With the increase to staff at various office locations from Santa Fe, OSO in Albuquerque and the Firefighters Training Academy in Socorro there is an increased need for IT support, this position will also assist the current IT staff to support (DHSEM/SFMO) at these locations. /( Pay Band IC) - \$120,072.47



### Code Enforcement Inspector-(2)

Currently our Code Enforcement Bureau is trending at 4000 annual fire and life safety inspections, and future Public Education Department collaborations would increase to an addition 800 PED locations. Possibly creating and additional 1500 reports.

Code Enforcement New Construction, trending at 7-9 million Square Feet a year, including 1 Plans Examiner, current work force is 3 dedicated persons to this mission.
