14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
15	SECTION 1. [<u>NEW MATERIAL</u>] SHORT TITLEThis act may be
16	cited as the "Uniform Collateral Consequences of Conviction
17	Act".
18	SECTION 2. [<u>NEW MATERIAL</u>] DEFINITIONSAs used in the
19	Uniform Collateral Consequences of Conviction Act:
20	A. "collateral consequence" means a collateral
21	sanction or a disqualification;
22	B. "collateral sanction" means a penalty,
23	disability or disadvantage, however denominated, imposed on an
24	individual as a result of the individual's conviction of an
25	offense that applies by operation of law, whether or not the

(3) shall update or cause to be updated the collection provided for in Paragraph (2) of this subsection within three months after the laws enacted during each session of the legislature are published in the New Mexico Statutes Annotated; and

(4) in complying with Paragraphs (1) and (2) of this subsection, may rely on the study of New Mexico's collateral sanctions, disqualifications and relief provisions prepared by the national institute of justice described in Section 510 of the federal Court Security Improvement Act of 2007, Pub. L. 110-177.

B. As required by Subsection A of this section, the identification agency shall include or cause to be included the following statements in a prominent manner at the beginning of the collection:

(1) "This collection has not been enacted into law and does not have the force of law.";

(2) "An error or omission in this collection, or in any reference work cited in this collection, is not a reason for invalidating a plea, conviction or sentence or for not imposing a collateral sanction or authorizing a disqualification.";

(3) "The laws of other jurisdictions and New Mexico counties and municipalities and the New MexicoAdministrative Code are not included in this collection and may.210861.2

(4) "This collection does not include any law or other provision regarding the imposition of or relief from a collateral sanction or a disqualification enacted or adopted after [insert date the collection was prepared or last updated].".

The identification agency shall publish or cause 9 to be published in the manner provided in Subsection D of this 10 section the collection prepared and updated as required by 11 Subsection A of this section. If available, the identification 12 agency shall publish or cause to be published, as part of the 13 collection, the title and internet address of:

(1) the most recent collection of collateral consequences imposed by federal law; and

(2) any provision of federal law that may afford relief from a collateral consequence.

D. The collection provided for in Subsection C of this section shall be published on the website of the identification agency and shall be available to the public on the internet without charge not later than three weeks after it is created or updated.

SECTION 5. [<u>NEW MATERIAL</u>] NOTICE OF COLLATERAL CONSEQUENCES IN PRETRIAL PROCEEDING AND AT GUILTY PLEA.--

1 section, counsel representing an individual charged with an 2 offense shall cause written notice substantially similar to the following to be communicated to the individual: 3 "NOTICE OF ADDITIONAL LEGAL CONSEQUENCES 4 5 If you plead guilty or no contest to an offense, or are convicted of an offense, you may 6 7 suffer additional legal consequences beyond jail or prison, probation, periods of parole and fines. 8 9 These consequences may include: 1. being unable to get or keep some licenses, 10 permits or jobs; 11 12 2. being unable to get or keep benefits such as public housing or education; 13 receiving a harsher sentence if you are 14 3. convicted of another offense in the future; 15 4. having the government take your property; and 16 being unable to vote or possess a firearm. 17 5. B. Before a court accepts a plea of guilty or no contest from an individual, the court shall confirm that the individual received and understands the notice required by Subsection A of this section and has had an opportunity to discuss the notice with counsel.

C. The notice required pursuant to Subsection A of this section need not be given until six months have elapsed after the collection of laws required pursuant to Section 4 of the Uniform Collateral Consequences of Conviction Act is first available on the internet pursuant to Subsections C and D of Section 4 of that act.

D. This section does not limit the duty that an individual's counsel otherwise owes to the individual.

SECTION 6. [<u>NEW MATERIAL</u>] NOTICE OF COLLATERAL CONSEQUENCES AT SENTENCING AND UPON RELEASE.--

A. An individual convicted of an offense shall be given notice as provided in Subsections B and C of this section:

(1) that collateral consequences may apply because of the conviction;

A. A collateral sanction may be imposed only by statute or ordinance or by a rule authorized by law and adopted in accordance with applicable law.

B. A law creating a collateral consequence that is ambiguous as to whether it imposes a collateral sanction or authorizes a disqualification shall be construed as authorizing a disqualification.

SECTION 8. [NEW MATERIAL] DECISION TO DISQUALIFY.--In deciding whether to impose a disqualification, a decision-maker shall undertake an individualized assessment to determine whether the benefit or opportunity at issue should be denied the individual. In making that decision, the decision-maker may consider, if substantially related to the benefit or opportunity at issue, the particular facts and circumstances involved in the offense and the essential elements of the offense. A conviction itself shall not be considered except as having established the elements of the offense. The decisionmaker shall also consider other relevant information, including the effect on third parties of granting the benefit or opportunity and whether the individual has been granted relief such as an order of limited relief.

SECTION 9. [<u>NEW MATERIAL</u>] EFFECT OF CONVICTION BY ANOTHER STATE OR THE UNITED STATES--RELIEVED OR PARDONED CONVICTION.--

A. For purposes of authorizing or imposing a .210861.2

1 collateral consequence in New Mexico, a conviction of an 2 offense in a court of another state or the United States is deemed a conviction of the offense in New Mexico with the same 3 elements. If there is no offense in New Mexico with the same 4 elements, the conviction is deemed a conviction of the most 5 serious offense in New Mexico that is established by the 6 7 elements of the offense. A misdemeanor in the jurisdiction of 8 conviction shall not be deemed a felony in New Mexico, and an 9 offense lesser than a misdemeanor in the jurisdiction of conviction shall not be deemed a conviction of a felony or 10 misdemeanor in New Mexico. 11

B. For purposes of authorizing or imposing a collateral consequence in New Mexico, a juvenile adjudication in another state or the United States shall not be deemed a conviction of a felony, misdemeanor or offense lesser than a misdemeanor in New Mexico.

C. A conviction that is reversed, overturned or otherwise vacated by a court of competent jurisdiction of New Mexico, another state or the United States on grounds other than rehabilitation or good behavior shall not serve as the basis for authorizing or imposing a collateral consequence in New Mexico.

D. A pardon issued by another state or the United States has the same effect for purposes of authorizing, imposing and relieving a collateral consequence in New Mexico

Ε. A conviction that has been relieved by expungement, sealing, annulment, set-aside or vacation by a 3 court of competent jurisdiction of another state or the United States on grounds of rehabilitation or good behavior, or for which civil rights are restored pursuant to statute, has the same effect for purposes of authorizing or imposing collateral consequences in New Mexico as it has in the jurisdiction of conviction; provided, however, that such relief or restoration of civil rights does not relieve collateral consequences applicable pursuant to the law of New Mexico for which relief could not be granted pursuant to Section 11 of the Uniform Collateral Consequences of Conviction Act or for which relief was expressly withheld by the court order or by the law of the jurisdiction that relieved the conviction. An individual convicted in another jurisdiction may seek relief pursuant to Section 10 of the Uniform Collateral Consequences of Conviction Act from any collateral consequence for which relief was not granted in the issuing jurisdiction except those consequences listed in Section 11 of that act.

A charge or prosecution in any jurisdiction that F. has been finally terminated without a conviction and imposition of sentence based on participation in a deferred adjudication or diversion program shall not serve as the basis for authorizing or imposing a collateral consequence in New Mexico. .210861.2

This subsection does not affect the validity of any restriction or condition imposed by law as part of participation in the deferred adjudication or diversion program before or after the termination of the charge or prosecution.

SECTION 10. [NEW MATERIAL] ORDER OF LIMITED RELIEF.--

A. An individual convicted of an offense may petition for an order of limited relief from one or more collateral sanctions related to employment, education, housing, public benefits or occupational licensing. The petition may be presented to the sentencing court at or before sentencing.

B. Except as otherwise provided in Section 12 of the Uniform Collateral Consequences of Conviction Act, the court may issue an order of limited relief relieving one or more of the collateral sanctions described in Subsection A of this section if, after reviewing the petition, the individual's criminal history, any filing by a victim pursuant to Section 14 of the Uniform Collateral Consequences of Conviction Act or a prosecutor and any other relevant evidence, it finds the individual has established by a preponderance of the evidence that:

 (1) granting the petition will materially assist the individual in obtaining or maintaining employment, education, housing, public benefits or occupational licensing;

(2) the individual has substantial need for the relief requested in order to live a law-abiding life; and .210861.2

C. ineligibility for certification as a law enforcement officer pursuant to the Law Enforcement Training Act or for employment as a correctional officer pursuant to the Corrections Act; or

D. prohibitions imposed pursuant to Section 30-7-16 NMSA 1978 making it unlawful for felons to receive, transport or possess a firearm or destructive device while in this state. SECTION 12. [NEW MATERIAL] ISSUANCE OF ORDER OF LIMITED RELIEF.--

A. The prosecutor shall be notified of a request for an order of limited relief. The court may issue an order of limited relief subject to restriction, condition or additional requirement.

B. The court shall order any test, report, investigation or disclosure by the individual it reasonably believes necessary to its decision to issue an order of limited relief. If there are disputed issues of material fact or law, the individual and any prosecutor notified pursuant to Subsection A of this section or another prosecutorial agency designated by a prosecutor notified pursuant to Subsection A of this section may submit evidence and be heard on those issues.

SECTION 13. [<u>NEW MATERIAL</u>] RELIANCE ON ORDER AS EVIDENCE OF DUE CARE.--In a judicial or administrative proceeding alleging negligence or other fault, an order of limited relief .210861.2

SECTION 14. [<u>NEW MATERIAL</u>] VICTIM'S RIGHTS.--A victim of an offense may participate in a proceeding for issuance of an order of limited relief in the same manner as at a sentencing proceeding pursuant to the Victims of Crime Act.

SECTION 15. [<u>NEW MATERIAL</u>] UNIFORMITY OF APPLICATION AND CONSTRUCTION.--In applying and construing the Uniform Collateral Consequences of Conviction Act, consideration shall be given to the need to promote uniformity of the law with respect to its subject matter among states that enact it.

SECTION 16. [<u>NEW MATERIAL</u>] SAVING AND TRANSITIONAL PROVISIONS.--

A. Except as provided in Subsection B of this section, the Uniform Collateral Consequences of Conviction Act applies to collateral consequences whenever enacted or imposed unless the law creating the collateral consequence expressly states that the Uniform Collateral Consequences of Conviction Act does not apply.

B. The Uniform Collateral Consequences of Conviction Act does not apply to the imposition of a collateral .210861.2
