



# 2026 Legislative Session Funding Request

\$500,000 to support a Statewide Nonprofit Organization to offer technical support for implementing the evidence based Community School strategy for school transformation in New Mexico.

## **Purpose**

- Provide direct on-site support to Community Schools to strengthen school systems and practices.
- Empower communities to implement the Community School Framework, ensuring local voices guide decision-making.
- Deepen understanding of the Six Key Practices among school staff, families, students, and community members to foster meaningful engagement and improved outcomes.

#### Goal

- Continue professional development for Community School Administrators and fund the Community School Coordinator Fellowship to strengthen leadership capacity and support coordinators as key drivers of school transformation.
- Provide more site-based technical assistance, emphasizing youth voice and family engagement to ensure schools implement the community school framework effectively.
- Develop enabling conditions for transformation that support schools in implementing the framework effectively and sustainably.

### **Results**

- Increased student and family engagement to strengthen connections between schools and communities.
- Reduced chronic absenteeism by addressing barriers to consistent school attendance.
- Improved student achievement through targeted supports and high-quality learning experiences.
- Culturally enriched learning opportunities that reflect and honor the diverse backgrounds of New Mexico students.
