## DACA RESCISSION FACTS:

September 5, 2017 U.S. Department of Homeland Security memorandum, Rescission of Deferred Action for Childhood Arrivals, rescinds the DACA program established June 15, 2012.

DACA status will be approved only for grantees whose benefits expire before March 5, 2018, provided they applied for renewal by October 5, 2018.

DHS immediately ceased accepting all new applications under DACA upon issuance of the memo.

# DACA FACTS INCLUDING NM STATISTICS

Approximately 800,000 young people who grew up in the United States have received DACA authorization.

Some 78% of DACA recipients are from Mexico.

NM statistics:

10,000 persons eligible to receive DACA status

6,838 have been approved

5,622 have been allowed to renew

6,250 DACA grantees are employed.

369 are business owners.

3,070 are students

2,195 currently are pursuing a bachelor's degree or higher.

DACA-eligible residents are estimated to contribute approximately \$18.8 million annually in state and local taxes in New Mexico—a contribution that may drop by \$7.5 million without DACA. Another estimate suggests that terminating DACA would, over a ten-year period, impact the New Mexico economy with \$258 million in budget costs and \$924.5 million in economic costs.

#### DACA APPROVALS ARE GRANTED ONLY TO PERSONS

\* Who came to the United States before the age of 16;

\* Who lived in the United States for at least 5 years prior to June 15, 2012;

\* Who were present and not older than 30 on June 15, 2012;

\* Who were not convicted of any felony offense, any significant misdemeanor offense, multiple misdemeanor offenses and were not otherwise a threat to national security or public safety ;

\* Who passed biometric and biographic background checks conducted by the Department of Homeland Security;

\* Who were enrolled in school on the date of applying or had graduated from high school or received a general education development certificate, or were honorably discharged or a veteran of the Coast Guard or Armed Forces of the United States

#### **PROGRAM PROMISES**

People were promised that information they used to apply for DACA status would not be "referred to ICE (Immigration and Customs Enforcement) for purposes of removal proceedings" even if the United States Citizenship and Immigration Services (USCIS) decided against approval except in limited circumstances.

Even in "exceptional circumstances" the families of people who applied for DACA status would not be referred to ICE for purposes of immigration enforcement against family members or guardians

Information provided by employers of DACA applicants would not be "shared with ICE for civil immigration enforcement purposes" when the information was submitted to support a request for consideration for DACA status.

## THREATS AGAINST PRES. TRUMP RE: DACA

On June 29, 2017, attorneys general of 10 states including Texas threatened to sue U.S. Attorney General Jeff Sessions and President Trump if they failed to end the DACA program by September 5, 2017.

Attorneys General signing the letter: Alabama, Arkansas, Idaho, Kansas, Louisiana, Nebraska, South Carolina, Tennessee, Texas, West Virginia and Governor of Idaho

## CONCLUSIONS OF THE SEPT. 5, 2017 MEMO:

Homeland Security promised to "reject all DACA initial requests and associated applications for Employment Authorization Documents" filed after Sept. 5, 2017 and to "reject all renewal applications it receives after October 5, 2017, and all renewal applications for authorizations that expire after March 5, 2018."

## **CONSEQUENCES OF RESCISSION**

DACA grantees whose deferred action expires after March 5, 2018 will immediately lose their employment authorization, as well as other vital benefits, such as social security cards, driver's licenses and financial aid among other benefits. They may also lose their homes if the program is allowed to expire.

Because of the rescission, information provided to the federal government by DACA grantees may be used against them at any time, without notice, for purposes of immigration enforcement, including detention or removal.
