
#### FEDERAL FUNDING TIMELINES


## **Recent Progress on OBAE Staffing**

- Contracted engineering firm for expertise
- Posted Four Positions:
  - Assistant Director, Grants Manager, Compliance Manager, Operations Manager
  - Consistent with current Operating Budget of \$680K
- Contracted with Subject Matter Experts (SMEs):
  - Digital Equity, Community Outreach, Tribal Liaison, NTIA, and Middle Mile, Project Management firm
- Identified OBAE growth positions and cost

- Three Types of Projects:
  - Fiber to the Premise (FFTP),
  - Fixed Wireless (where FFTP is not feasible)
  - Alternative Technologies (where Fixed Wireless is not feasible)
- Technical Assistance will be available
- Grant reviewers being identified and trained
- Round 1: August November; \*October awards for "shovel ready projects"
- Round 2: February 2023 launch (anticipated)





  - Award first pilot program grants (ARPA Capital Projects Fund)
  - RFI for additional stakeholder feedback ahead of NTIA MM submission
  - Submit NTIA MM application September 30
  - Tribal Summit and "Digital Inclusion Week" event October 3-7
  - Complete rulemaking for Connect NM Broadband Grant Program


## **Broadband 101**

#### Middle Mile

- Can be wired or wireless
  - Wired: Fiber-Optics the Best and most expensive (~\$24-\$40/ft buried, varies on soil conditions, use of power poles)
  - Wireless: Microwave, etc., Cheaper but less capacity and suffers in extreme weather
  - Opportunity for emerging technologies

#### Last Mile

- Anchor Institutions Include: Tribal Programs, health, libraries, education, public safety
- Connecting homes
- Direct fiber connections, ideally for high bandwidth needs
- Can be wired (Fiber-to-the-Home) or Wireless
  - FTTH is the best but very expensive
  - Wireless can use licensed or unlicensed spectrum
  - Note on spectrum: Tribes do not control their airwaves


