### Premium Tax Transfer

- > HB 0223 passed in 2018 with a transfer date set for January 1, 2020
- ➤ 6 OSI Financial Audit Bureau positions will be transferred to TRD. Two staff members transferred to TRD for testing in Gentax on November 1, 2019. The other 3 staff, plus 1 vacant position will be transferred by January 1, 2020
- > OSI will prepare Operating Transfer to TRD to cover payroll for the 6 positions for the remainder of FY20
- OSI & TRD have been working together diligently to get all aspects of the transfer complete by January 1, 2020
- OSI & TRD have completed all requests and are on track for the transition.

# Budget Request Overview – Expansion Detail

## OSI is requesting to replace the 6 positions transferred to TRD and fill them with FTE to be utilized in other areas within the Agency

- ➤ Life & Health Program Perform technical review of electronic form filings with an emphasis on drug formularies and ensure compliance with state & federal laws
- ➤ Health Policy & Consumer Education Perform technical reviews of Managed Health Care Plans
- ➤ Managed Health Care Compliance Handle consumer complaints & inquiries from consumers and conduct outreach presentation throughout NM
- ➤ Consumer Investigation Perform Case Management of investigation cases & clerical support
- ➤ Property & Casualty (2 Positions) Perform review of Property & Casualty Rate, Rule and Form Producer Filings

# Budget Request Overview – Expansion Detail

#### Additional Positions Requested

- 1. Human Resources Position will assist HR Manager with administrative HR Duties
- 2. Examination Bureau Position will identify insurance entities with market conduct practices that do not comply with NM Statutes by performing desk audits and market conduct examination
- ➤ No General Fund Impact Positions -Funded by Increase in Fraud Assessment Auto Theft Program – 4 Positions
  - 1. Attorney III
  - 2. Staff Member (paralegal)
  - 3. Special Agent
  - 4. Grants Manager

# Budget Request Overview – Base Increase

#### **Base Increase:**

- > Retention of 4 Positions and operating costs previously funded by Federal Grants
  - > All Federal Grant Funding will be expended by December 31, 2019
  - 4 Positions include:
    - 1. Business Operations Specialist
    - 2. IT Application Developer III
    - 3. Attorney IV
    - 4. Administrative Ops II
- > Salary for Superintendent of Insurance
- > Increase of Liability Insurance from GSD

### Closing Remarks

- OSI's consumer assistance team and the managed healthcare compliance team have helped consumers and service providers in NM save, resolve, and recover nearly \$19.7 million.
- OSI has implemented the State Based System, our web-based, paperless application process for companies and agents. The updated system also enhances the ability of policyholders to communicate more efficiently with OSI, resulting in improved response time.
- The Alto Theft Prevention Authority team was awarded the International Association of Alto Theft Prevention Investigators, Presidents Avard for 2019. The award is to honor members who have distinguished themselves though extraordinary service.
- OSI has numerous other initiatives on the horizon, all intended to enhance productivity and make New Mexico an easier state in which to write business and obtain affordable policies. The groundwork is laid for continued progress.
