The Eighth Judicial District FY21 base, special, and capital requests will "Advance Judicial Excellence" Priority #2 by improving, streamlining, and simplifying court processes to meet the needs of the citizens we serve. The base request includes: 1) \$120K for the transfer 2.5 FTE positions funded by the Warrant Enforcement Fund in FY20, 2) \$100K for 1.5 FTE for Magistrate Security Officers to improve public safety in our smaller Magistrate courts in Sprinter and Clayton, 3) \$124.6K for 1.5 FTE positions to expand our ability to meet case flow demand in District Court Domestic Relations in the counties of Taos, Colfax, and Union currently covered by one Domestic Relations Hearing Officer. Other base requests of \$66.9K include insurance rate and benefit increases, recurring computer refresh, Magistrate equipment maintenance and support, and a CEO compa rate restoration associated with the consolidation of the District and Magistrate courts.
