#### **SUMMARY OF REVENUE FY19/FY20**

 OVERALL STATE ROAD FUND REVENUE WAS DOWN 9% FROM FY19 TO FY20 WHICH TRANSLATES TO \$9.0M.

OVERALL MOTOR VEHICLE EXCISE TAX REVENUE WAS DOWN FROM PROJECTIONS.
 EXPECTED REVENUE WAS \$59M IN FY20 (\$52.6 TO D2 & \$6.5M TO SRF. THE NMDOT RECEIVED \$53M IN FY20 (\$47.6M TO D2 & \$5.9M TO SRF).

OVERALL FEDERAL REVENUE HAS REMAINED THE SAME.

#### **SUMMARY OF REVENUE FY20/21**

- OVERALL STATE ROAD FUND REVENUE IS EXPECTED TO BE DOWN FROM FY20 TO FY21. CURRENT PROJECTED REVENUE FOR FY21 IS \$451.8M.
  - FY21 REVENUES ARE TRACKING HIGHER THAN INITIALLY PROJECTED.
- OVERALL MOTOR VEHICLE EXCISE TAX REVENUE IS EXPECTED TO BE DOWN FROM FY20 TO FY21. CURRENT PROJECTED REVENUE FOR FY21 IS \$50.0M.
  - NEW PROJECTIONS SHOW POSSIBLE REVENUE GAINS.
- OVERALL FEDERAL REVENUE FOR NMDOT FOR FY21 IS EXPECTED TO BE THE SAME.
- OPPORTUNITY FOR FEDERAL REVENUE TO GROW WITH STIMULUS/NEW AUTHORIZATION

- LAST CALL THERE WAS \$113M WORTH OF PROJECTS THAT WERE NOT FUNDED

- CURRENTLY \$102.3M IS ENCUMBERED

- CURRENTLY \$75M IS SCHEDULED TO BE BONDED IN 2022


