Issues Facing Native Communities -- Rooted in Social, Cultural, and Economic Disruptions

- Violence, including MMIW
- Addiction
- Language loss
- Education and health disparities
- Poverty
- Infrastructure and housing needs
- Risks to natural and cultural resources

Planning and Community Development

- Documents community intentions, in writing, as guidance for future leaders and a tool to promote informed decision-making
- Community engagement to develop values, goals, strategies, and actions
- Comprehensive plan topics: health & wellness, housing, natural resources & environment, transportation, economic development, land use & infrastructure, implementation strategies
- Other types of plans: capital improvement plans, site master planning, facility conceptual designs, strategic plans
- Support for funding applications and reinforcement of legal positions
- Project management and packaging of funds for new buildings, facilities, and infrastructure

Indigenous Planning

- Based on indigenous land tenure, sustained collective ownership
- Using culture and identity to inform community development
- Assertion of tribal sovereignty

New Mexico Tribal Planners' Roundtable

- Created in 2010 by planners from the Pueblos of Laguna and Santo Domingo
- Discussions about planning, community development, and project management
- Unique problems and issues within Native American communities
- Differences in planning on Native lands, compared to non-Native land, funding sources
- Best practices and solutions
- Information-sharing, in person and via email
- Policy discussions (forwarded to tribal officials)
- Networking, descriptions of current projects
- Cross-cultural communication Native/non-Native, multiple professions
- Student engagement and inspiration; collaboration with UNM Indigenous Design + Planning Institute

- Presentation on the roundtable at statewide forums, such as NM Infrastructure Finance Conference
- Interaction with American Planning Association, tribal interest group and NM chapter
