

- · To' Hajiilee Community School is a community oriented school, over an area of about 123 square miles, and is 32 miles west of Albuquerque.
- \cdot The school has a current enrollment of around 263 students, from grades Pre-K through 12th.

Please fund afterschool tutoring and summer school initiatives for all students in New Mexico.

The funding allows us to give students a safe, supportive space to keep learning, with teachers who care, and the extra help the students need. It will also enable students who are finding themselves challenged by their lessons and outside situations the time and attention they require to grasp the concepts, and methodologies from their classes so they don't fall behind.

The goal for the project is a comprehensive afterschool and summer program that will increase the student's test scores from their current standing, and into the next benchmark. All programs will be aligned to the common core curriculum and enrichment, such as technology, health & wellness, film, pop culture, mentoring, tutoring, community collaborations, and hands-on activities, aimed at increasing the students academic, social, physical, and emotional wellbeing.

Our overall, the primary intention has allowed us to create four major student and family objectives:

- **1.** 85% of students participating in the program full-time and for a minimum of 30 days or more will show improvement in reading and math determined by the NWEA MAP assessment.
- **2.** 85% of the students participating in the program will take part in at least 20 enrichment activities within the program by the end of the school year.
- **3.** 50% of families who are participating in the program will attend a minimum of 2 Family Nights.
- **4.** 85% of the students participating in the program will take part in 5 cultural activities by the end of the school year.
- **5.** 85% of the students participating in the program will take part in 5 wellness activities by the end of the school year.

Pre-K Program:

Please fund our state funded Pre-K building at the new school campus.

The community had a Daycare Center under the Navajo Nation years ago, and because of a lack of funding and building space, the service no longer exists for the community.

TCS entered into a contract for services with the state for a pre-k program in SY 2015-16 and have continued to offer those services since. Where the TCS Pre-School Program is housed, flooding has created anticipation that the facility will be condemned and demolished, leaving the Pre-School Program without a place to be housed. Pre-K enrollment is often up to 20 students yearly, all who will be adversely affected by the loss, without a building space.

In order to prevent the community from losing access to Pre-K services and day care, we are requesting funding for new facilities. The project is to plan and design a new Early Childhood Learning Center, to provide services to the community's children, from infant to five years of age. This facility will benefit the Navajo people who are members of the To'Hajiilee Chapter.

We will put funds into phases up to \$18,375,925 over the next few years (2026, 2027, 2028 and 2029). These funds will enable us to design, construct, and furnish our Early Childhood Center, allowing us to take better care of our community and their youngest.

Please allocate funding to support school based health centers that include hiring staff to support student well-being.

With these funds, we can be better equipped to diagnose and handle student health issues onsite, rather than solely relying on outside resources.

We plan to hire a full-time onsite registered nurse, ensuring that we have a certified medical practitioner during school hours.

We will implement the School-Based Health Center (SBHC) model, as recommended by the New Mexico Department of Health (NMDOH) and presented on the website "https://nmhealth.org".

Implementing this program will ensure the following:

- Rapid response to student health issues, like food allergies and schoolground injuries.
- Manage and maintain supplies for chronic diseases, like asthma, diabetes, and so forth, onsite.
- A central point of communication and information on the medical and general health issues and concerns, for students, parents and staff.
- Development and implementation of codified health and emergency response methods and practices onsite, which we can disseminate to staff and students, enabling everyone to respond to emergency situations in a faster, more focused and capable manner.

According to a study by Pennington, Nicole & Delaney, Beth (2008) called <u>The Number of Students Sent Home by School Nurses Compared to Unlicensed Personnel</u>, from <u>The Journal of School Nursing</u>, 18% of students seen by a non-licensed staff member were sent home, whereas only 5% students seen by a licensed nurse were sent home.

To'Hajiilee is about one-hundred and twenty three square miles. This is a great distance for a parent to pick up their child. The impact of sending a child home is far greater than them just missing school hours. Single parent/guardian families, often grandparents raising their grandchildren, or household with a single mode of transportation, often have to leave their jobsite to gather and tend to their child's needs, may lose hours of household income.



Please fund school safety grants or capital outlay funding for safety initiatives for all students in New Mexico.

Incidents of gun shootings both fatal, and nonfatal, have been steadi-



ly increasing in Albuquerque.
To'Hajiilee Community School is
only fifteen minutes from Albuquerque, and has seen an increase and escalation of lockdown events in the area.

For this reason, we are requesting resources to help us acquire tools, and implement stronger safety and security measures

and protocols to keep our students, parents, staff, and visitors safe in these increasingly challenging times.

Of the total \$680,451 amount we need, we have already been awarded \$500,000 through grants. We are asking for the remaining \$180,451.

The list of vulnerabilities we will be securing with these funds are:

- 1) Mass communication / Police Notification Cost: \$389,903
 - A) Messaging Display System / Spotlight, a district wide remote lock-down and interactive map and communication system.
 - B) The Informed Classroom and Beyond, / Classroom Phones and Mobile Alert a system to ensure staff and students receive timely and clear alerts, even in noisy hallways and spaces.
 - **C)** <u>Teacher Microphone</u>, a single platform for classroom communications and paging.
 - **D)** <u>Cybersecurity Advantage</u>, to prevent tampering with the alert system server.
- An electronic access control system integrated with police access Cost: \$227,244

Access security with Key FOB access for teachers, staff, and police.

 Visitor access controls, integrated with the above system #2 Cost: \$10,451

Door buzzers and door intercoms, integrated with cameras.

- 4) Integrated Panic Buttons and lanyards for all staff Cost: \$45,553 Includes mobile phone integrated panic button.

- Handheld metal detectors for detecting weapons Cost: \$1,000





The Vision of **CBNHC:**

is a health campus of quality and excellence, where individuals and families are empowered to be healthy through all stages of life.

The To'Hajiilee (Canoncito Band of Navajos) community is a rural, noncontiguous section of the Navajo Nation located approximately 35 miles west of Albuquerque, New Mexico. Spanning more than 121 square miles, it is home to Navajo (Diné) residents. To Hajiilee is geographically isolated, with limited infrastructure, transportation, and healthcare access—creating significant barriers to essential services. Despite these challenges, the community maintains a strong cultural identity where Navajo language, traditions, and values remain central to daily life.


From October 1, 2024, to September 30, 2025, the Canoncito Band of Navajos Health Center proudly served 27,840 patient visits, reaching not only To'Hajiilee residents, but also individuals across Cibola, McKinley, Sandoval, and Bernalillo counties. The population experiences high rates of poverty, limited economic opportunities, and health disparities—factors that make investments in healthcare infrastructure and culturally grounded wellness programs essential to improving quality of life and advancing health equity for future generations.

KEY ISSUES WITHOUT EXTERNAL SUPPORT

Limited Financial Resources: The community does not have sufficient funding to cover construction, infrastructure, or equipment costs on its own.

Workforce Shortages: Lack of specialized personnel to manage large-scale construction and healthcare operations.

Infrastructure Gaps: Limited access to utilities (power, water, broadband) makes large projects harder to implement independently.

Regulatory & Technical Barriers: Complex permitting, design, and environmental requirements require technical assistance and expertise.

Geographic Isolation: Rural location increases transportation and construction costs, reducing feasibility without funding support.

Health Disparities: High rates of chronic disease and behavioral health issues create an urgent need for investment that exceeds local capacity.





CBN HEALTH CENTER ACCOMPLISHMENTS

- Expanded access to primary care, behavioral health, and telehealth services close to home.
- Promoted cultural healing and trust through Navajocentered care.
- Addressed social determinants of health by connecting families to food, housing, transportation, and wellness resources.
- Expanded behavioral health services, including mental health, substance use support, supportive employment and culturally informed therapy.
- Provided education and prevention programs for chronic disease, youth wellness, and community health.
- Created local jobs and strengthened the community workforce.

HEALTH DISPARITIES

The To'Hajiilee (Canoncito) community faces high rates of chronic disease (diabetes, heart disease, cancer) and behavioral health challenges (depression, PTSD, anxiety, substance use) well above state and national averages.

Alcohol-related illnesses and deaths are significantly higher than the U.S. average. These disparities are worsened by limited infrastructure—unreliable utilities, no grocery or wellness facilities, transportation gaps, and provider shortages.

Social determinants of health such as poverty, food insecurity, and limited education access further increases risk.

IMPACT STATEMENT - IMPROVING WELLNESS, BEHAVIORAL HEALTH, PRIMARY CARE, AND TRADITIONAL HEALING ACCESS IN TO'HAJIILEE, NEW MEXICO

EXECUTIVE SUMMARY

The Canoncito Band of Navajos Health Center (CBNHC) is spearheading a coordinated effort to improve health outcomes and equity for the To'Hajiilee community in New Mexico. Through two major strategic investments—a \$500,000 Wellness Center and Traditional Healing Grounds Expansion and a \$41 million New Health Center Construction Project—CBNHC is addressing long-standing health disparities with a holistic, culturally grounded approach.

These investments will significantly expand access to high-quality, comprehensive care while honoring traditional Navajo healing practices. The Wellness Center and Traditional Healing Grounds will provide vital space for community wellness activities, traditional ceremonies, and preventive health programming. The new Health Center will increase healthcare delivery, increase service capacity, and integrate behavioral health, primary care, and cultural healing under one roof. Together, these projects represent a major step toward health sovereignty—building infrastructure that supports both modern medical excellence and Navajo values of balance, wellness, and community connection. By investing in culturally responsive care, CBNHC is setting a model for sustainable, community-led health systems that strengthen physical, mental, and spiritual well-being for generations to come.

BACKGROUND: CANONCITO BAND OF NAVAJOS HEALTH CENTER

The Health Center exercised P.L. 93-638 (Public Law 638) in July 2016, authorizing Cañoncito Band of Navajos Health Center (CBNHC), a Tribal Organization, to contract and self-govern the day to day operations of health services and programs offered through a Title 1 Contract with Health and Human Services. This means that the organization withdrew money from Indian Health Services (IHS), and the clinic is now governed by the Cañoncito Health Board and other local officials, with input from tribal members. The mission statement of the CBN Health Center is to provide quality outpatient Behavioral Health services, substance abuse treatment, intervention, rehabilitation support, referral for Dine Traditional services for those who require Behavioral Health support, Dine Services and those who wish to recover from substance use/or dependence along with providing quality Prevention and Outreach education to the To'Hajiilee community.

CBN Health Center has a total of 12 programs for the following services: Behavioral Health, Dental Clinic, Diabetes Management, Health Clinic, Community Health Representatives (CHR), Patient Benefits Advocate, Patient Referred Care (PRC), Speciality and Primary Care, and Medication Assistance Program and Pharmacy. The focus of CBNHC Inc. is rebuilding a culture of health with collaboration between tribal government, the health center and the younger generations, and finding ways to connect with the patients, using the patient-center model. CBNHC Inc. addresses and provides direct support to community residents social determinants of health needs' such as water distribution for households with no access to clean water, food distribution, and others like income and social protection, education, unemployment, housing and basic amenities, early childhood development, social inclusion, structural conflict, and access to affordable health services.

NEEDS STATEMENT: TO'HAJIILEE COMMUNITY

The To'Hajiilee community—also known as the Cañoncito Band of Navajos— is a non-contiguous section of the Navajo Nation lying in the rural parts and counties of Bernalillo, Cibola, and Sandoval. It covers 78,887 acres and is part of the Navajo Nation Easter Agency. To'Hajiilee is approximately 25 miles west of Albuquerque, NM. According to the Navajo Nation Population Profile, To'Hajiilee has a total of 1,649 including American Indian/ Alaskan Natives and non-Natives. To'Haajiliee services urban Native Americans in metropolitan areas, like Albuquerque.

The To'Hajiilee (Canoncito) Navajo community faces a critical and persistent health crisis rooted in both social and structural inequities. Rates of chronic disease—particularly diabetes, heart disease, and cancer—remain significantly higher than state and national averages. Many residents experience limited access to early detection, regular screenings, and consistent disease management, resulting in poorer health outcomes and preventable complications. In addition to physical health concerns, behavioral health conditions are widespread and often untreated. High prevalence of depression, anxiety, post-traumatic stress disorder (PTSD), and substance use disorders reflects the compounded effects of intergenerational trauma, isolation, and limited access to culturally competent care. These challenges are exacerbated by a shortage of local behavioral health providers and the absence of integrated treatment facilities within the community.



Contributing to this state of need are significant social determinants of health: limited transportation options, the absence of nearby grocery stores or wellness facilities, inadequate utilities, and aging or insufficient healthcare infrastructure. These barriers make it difficult for residents to maintain preventive care routines, access healthy foods, or participate in wellness activities that support long-term health

Traditional healing is not only complementary to Western medicine—it is a core component of Navajo well-being, emphasizing harmony, balance, and connection to the natural world. In To'Hajiilee, community members have consistently expressed the need for formalized spaces for ceremony, teaching, and cultural healing alongside modern clinical care. Expanding access to traditional healing services—through dedicated grounds, cultural programming, and collaboration between traditional healers and medical providers—is essential to restoring balance in the community's health system. Meeting this need will strengthen trust, improve care engagement, and ensure that wellness for the To'Hajiilee community reflects both modern health standards and the enduring wisdom of Navajo tradition.

FUNDING REQUEST #1 WELLNESS CENTER/ TRADITIONAL HEALING GROUNDS EXPANSION — \$500,000

The Canoncito Band of Navajos Health Center (CBNHC) seeks \$500,000 to expand its Wellness Center and Traditional Healing Grounds — a targeted initiative designed to strengthen prevention, wellness, and the integration of cultural healing within the community.

This project will enhance the existing wellness facility to provide:

- Culturally grounded spaces for Navajo traditional healing ceremonies, talking circles, and community gatherings.
- Integrated behavioral health services addressing mental health and substance use through culturally safe and traumainformed approaches.
- Fitness and wellness programs focused on diabetes prevention, cardiovascular health, and youth engagement.
- Telehealth and supportive infrastructure to increase access to care while keeping services close to home.
- · Safe, accessible wellness spaces where elders, youth, and families can participate in healthy, community-based activities.
- The expansion will enable CBNHC to meet urgent preventive and behavioral health needs while reinforcing the community's
 cultural and spiritual foundation. In addition, the new services will enhance long-term sustainability by generating revenue
 through Medicaid and other reimbursement sources.
- Investment in this project will directly support a healthier, more resilient To'Hajiilee community grounded in Navajo wellness and tradition.

FUNDING REQUEST #2 NEW HEALTH CENTER CONSTRUCTION PROJECT — \$41 MILLION

The Canoncito Band of Navajos Health Center (CBNHC) is requesting \$41 million to construct a new Health Center that will serve as a cornerstone for accessible, high-quality, and culturally responsive healthcare. This comprehensive infrastructure investment will establish a modern facility capable of meeting the growing medical, behavioral, and specialty care needs of To'Hajiilee residents and surrounding communities.

The new Health Center will include:

- Primary and specialty care clinics to expand access to essential medical services.
- Behavioral health and substance use treatment programs that provide integrated, trauma-informed care.
- Laboratory, pharmacy, urgent care, and telehealth services to ensure continuity and coordination of care.
- Traditional healing integration within clinical services to honor and strengthen Navajo wellness practices.
- Expanded space and infrastructure to support workforce growth, modern medical equipment, and essential utilities such as power, broadband, and water.

This \$41 million investment will transform healthcare access by addressing more than 27,000 clinic visits To'Hajiilee and nearby areas of Sandoval, Cibola, McKinley, and Bernalillo counties. By reducing travel burdens, improving early intervention, and addressing long-standing health disparities, this project will build a sustainable foundation for health equity and community resilience. Investment in this new Health Center is an investment in the future health, dignity, and self-determination of the To'Hajiilee Navajo community.



LONG-TERM COMMUNITY IMPACT

The combined investments of \$500,000 for the Wellness Center & Traditional Healing Grounds Expansion and \$41 million for the New Health Center Construction Project will create lasting change in the health and well-being of the To'Hajiilee Navajo community. Together, these projects will:

- Increase access to both culturally grounded and modern healthcare services.
- Reduce the burden of chronic disease and prevent avoidable hospitalizations through early intervention and wellness promotion.
- Strengthen behavioral health care by integrating traditional healing, talking circles, and trauma-informed approaches.
- Support workforce development and create meaningful employment opportunities for local residents.
- Improve community infrastructure, including reliable power, broadband, water, and transportation systems.
- Build trust and cultural safety within healthcare delivery, ensuring care that honors Navajo values, language, and healing traditions.
- These transformative investments will not only expand healthcare capacity but also restore balance, strengthen resilience, and sustain wellness for generations to come in To'Haiiilee.
