

### HIGHER EDUCATION

 PROVIDES SCHOLARSHIPS TO STUDENTS OF:

- Tesuque Pueblo
- Picuris Pueblo
- Pojoaque Pueblo



The ENIPC, Inc. Higher Education Scholarship Program is a federal initiative managed by ENIPC. To be eligible for this scholarship, applicants must be full-time undergraduate students who are enrolled as tribal members.

### **Employment & Training**

The Workforce Investment Opportunities Act (WIOA) allows for training to the tribal members of:

- Pojoaque
- Picuris
- · San Ildefonso
- Tesuque

This program designed to provide opportunity to tribal members to increase the participants occupational and educational skills for long term employment.

The Adult Vocational Training (AVT)

 Is a program that assists tribal members, from the pueblos listed, with a stipend to cover training costs. The intention is to give tribal members the skills and education necessary to gain full-time employment.



### **Head Start**

The Head Start Program runs a center in the Pueblo of San Ildefonso.

Head Start is open to both Native and Non- Native children who qualify under the Head Start income guidelines.

The Center has a Lead Teacher, Assistant Teacher and a Cook.

Meals are provided and are served family style to provide interaction between the children.









## **Environmental Technical Assistance**

The Office of Environmental and Technical Assistance (OETA) assists the 22 Pueblos and Tribes in New Mexico and Texas with promoting the enhancement of environmental resources, environmental health, and in the protection of tribal lands from environmental hazards.

# Peacekeepers Domestic Violence Program

- Peacekeepers Domestic Violence Program offers services to the Eight Pueblos in:
  - Domestic Violence Advocacy
  - Civil Legal Services
  - Probation
  - Transitional Housing/Crisis Intervention
  - Batterers Intervention Program
  - Peacekeepers is open to non-native spouses who are or

were married to native men  $\mathcal{E}$  women.

• The Peacekeepers Program continues to assist Victims of Domestic Violence and reeducate Batterers who are referred to our program by court orders. In addition to our services to Victims and batterers, we are open to Tribal requests for Presentations, groups, crises intervention, community awareness campaigns, neighborhood watches, collections of donations, culturally specific projects and disbursement of information about Peacekeepers and picking up reports from the courts and the Police on client referrals.

### **Senior Citizens Program**

The Senior Program aids the Pueblos of:

- Nambe
- Picuris
- San Ildefonso
- Pojoaque

The program is offered to both native and non-native communities.



#### Services include:

- Case Management
- Information and Assistance
- Outreach
- Transportation
- Shopping Assistance
- Health promotion and disease prevention
- Nutrition Services
- Homebound & Congregate Meals
- Caregiver/ Respite Care services



### **Childcare Assistance Program**

- Childcare Assistance Program provides services to Six of the Eight Pueblos. They include:
  - Nambe, Pojoaque, San Ildefonso, Picuris, Ohkay Owingeh and Santa Clara.
  - They provide funding assistance to low-income families in need of Childcare.
  - Parents must meet income guidelines and be either employed, attending job training or enrolled in school.
  - Children can be placed in a home-based or center-based facility.








## Food Distribution Program

- Also known as commodities, service all Eight Pueblos and non-native communities located in the boundaries of the Pueblos.
  - Eligible households are certified based upon income and resource standards set by the federal government. Participating households must be recertified or receive a follow-up at least once every 12 months.
  - Applicants <u>Must not</u> be receiving Food Stamps with the State.
  - The areas served by the ENIPC Food Distribution Program are Nambe, Pojoaque, Tesuque, San Ildefonso, Santa Clara, Ohkay Owingeh, Taos and Picuris Pueblos. In addition, we also service the Taos County and Peñasco areas.

## WIC Woman, Infants & Children

WIC is a Special Supplemental Nutrition Program for Women, Infants and Children. WIC provides supplemental foods, health care referrals, and nutrition education for low income pregnant, breastfeeding, and postpartum women, and to infants and children up to age five who are found to be at nutritional risk.



WIC is a short-term program. A participant will graduate at the end of one or more certification periods. A certification period is the length of time a WIC participant is eligible to receive benefits.

The WIC food packages are designed to meet the needs of our participants who are at nutritional risk.

To apply to be a WIC participant, you will need to contact our office and schedule an appointment. At that time, you will be told what items to bring with you to your appointment. In most cases we offer same day appointments.



- Woman, Infants & Children services all Eight Pueblos and non-native clients. Services Include:
  - Breastfeeding Counseling
  - Continued support to provide qualified foods for children up to age five.
- The ENIPC Program has been in existence for over 34 years. We provide services to both tribal and non- tribal clients that reside throughout the Eight Northern Pueblos and Northern New Mexico. The ENIPC WIC Program serves three geographic areas:

- Santa Fe
- Taos
