Proactive Budgeting to Prepare for Effects of HB6

- Eliminate 126 vacant positions from FY20 to FY26
- Deferred \$50M of budgeted capital expenditure projects
- Deferred purchase of vehicle/equipment
- Implemented Capital Infrastructure Plans
- Budget Message: "Rethinking the Budget"

COH Making a Positive Impact

- 7% decrease in total reported crime
- 18% decrease in traffic crashes

Direct Challenges of HB6 for Public Services

Service Category	Pre-HB6 Funding Role	HB6-Induced Strain
Public Safety (Police & Fire)	GRT covers salaries, equipment, and response capabilities for a city serving oilfield workers.	Potential cuts to staffing or overtime, delaying response times in a high-risk energy hub; losses threaten the revenue reliance.
Infrastructure (Roads & Maintenance)	Funds repairs for heavy oilfield traffic on primary routes.	Deferred maintenance risks safety and economic access.
Utilities (Water & Sewer)	Supports expansions for growing population and industry.	Reduced capacity for new developments, impacting housing and business growth.
Community Amenities (Parks, Library, Recreation)	Enables family-friendly facilities amid boomtown pressures.	Cuts could limit youth programs and quality-of-life investments, worsening retention in a transient workforce city.
