Amendment sponsored by Representative Jared Hembree

- 1. On page 1, line 13, before the period, insert "; PROVIDING FOR STATE AND FEDERAL FUEL TAX AND COST OF COMPLIANCE WITH THE CLEAN TRANSPORTATION FUEL STANDARD STICKERS TO BE DISPLAYED AT FUEL PUMPS".
- 2. On page 7, line 24, before the period, insert "--MOTOR FUEL PUMP STICKERS".
 - 3. On page 10, between lines 18 and 19, insert:
- "D. The board shall produce stickers for display on a motor fuel pump from which fuel is sold at retail that provide notice of:
- (1) the federal and state fuel tax rates in cents per gallon for each type of fuel as of the date the sticker was produced; and
- (2) the cost of compliance with the clean transportation fuel standard program in cents per gallon for each fuel type as of the date the sticker was produced.
- E. The board shall calculate the cost of compliance with the clean transportation fuel standard by calculating the average cost of a credit sold pursuant to the clean transportation fuel standard program during the year and converting that cost to represent the program's cost in cents per gallon for each fuel type.
- F. The board shall produce updated federal and state fuel tax rate stickers whenever fuel tax rates have changed and an

updated cost of compliance sticker at least once every three years.

- G. The board shall distribute state and federal fuel tax and cost of compliance stickers to New Mexico department of agriculture employees and other individuals responsible for the inspection of motor fuel pumps. The New Mexico department of agriculture employees and other individuals responsible for the inspection of motor fuel pumps shall display the federal and state fuel tax rate and cost of compliance stickers on motor fuel pumps from which fuel is sold at retail:
- (1) on the face of a motor fuel pump on which the price of the fuel sold from the pump is displayed; and
 - (2) in a clear, conspicuous and prominent manner.
- H. The board shall provide state and federal fuel tax and cost of compliance stickers by mail free of charge at the request of motor fuel pump owners.
- I. At the time of inspection of a motor fuel pump, New Mexico department of agriculture employees or other individuals responsible for the inspection of motor fuel pumps shall replace state and federal fuel tax and cost of compliance stickers with updated versions if the cost of compliance rates as determined by the board or the tax rates have changed and new stickers have been produced.".
 - 4. Reletter the succeeding subsection accordingly.
