Child Welfare Performance Challenges

Workforce

Reducing Maltreatment and Repeat Maltreatment



Repeat maltreatment was 14% in the third quarter of FY25



Turnover worsened in FY25 to 39% in the third quarter of FY25 and was >50% in April 2025.

CYFD reported 1,062 licensed resource homes in April 2025.



Senate Bill 42 (2025)

- Aims to improve child welfare in New Mexico through three main objectives:
 - 1. Updating and improving data privacy and record retention requirements related to child welfare.
 - 2. Improving the way the state responds to alleged child abuse or neglect:
 - 1. Fixing the "CARA" program.
 - 2. Statewide multilevel response system
 - 3. Improving prevention and early intervention services.

Data Privacy and Record Retention in SB 42

- Section 2:
 - Requires CYFD employees to use department-issued electronic devices for all communications related to the performance of their duties.
 - Electronic records on the devices are required to be retained.
- Sections 10 and 11:
 - Improves transparency in investigations and proceedings alleging abuse or neglect

CARA Program

- Sections 5 through 8 of SB 42:
 - Shifts responsibility for the program from CYFD to the HCA.
 - Requires plans of safe care to be made for all substanceexposed newborns.
 - Requires the HCA to:
 - Ensure care coordinators are available to provide services in each birthing hospital in the state;
 - Follow up with families to help connect them with services.
 - Implement plans of safe care.
 - Notify CYFD within twenty-four hours of a family's failure to comply with a plan of safe care. Any family reported to CYFD will undergo a family assessment conducted by CYFD.

Families First Act

- Sections 14-17:
 - Requires CYFD to develop and implement a families first strategic plan that complies with the requirements and regulations set forth in the Family First Prevention Services Act.
 - Will enable the state to maximize federal resources for providing foster care prevention services.

SB 42 Key Dates

- August 1, 2025:
 - CYFD is required to finalize the families first strategic plan.
- September 1, 2025:
 - CYFD is required to submit the families first strategic plan to the federal administration for children and families.
- January 1, 2026:
 - CYFD is required to implement a system to back up all electronic records generated or received by employees on a daily basis.
- July 1, 2026:
 - Deadline for HCA to fully implement the new CARA program requirements.
- June 30, 2027:
 - Deadline for CYFD to implement a pilot program that provides foster care prevention services consistent with the families first act.
- July 1, 2027:
 - Deadline for CYFD to fully implement the statewide multilevel response system.
- June 30, 2032:
 - Deadline for statewide implementation of foster care prevention services consistent with the families first act.

Senate Bill 283 (2025)

- Federal Benefits for Children in State Custody Act:'
 - Requires CYFD to determine whether a child under the department's custody is currently receiving or is eligible to receive federal benefits.
 - If the child is eligible for benefits, CYFD is required to apply for the benefits on behalf of the child.
 - If the child does not have a guardian, custodian, etc. to manage the benefits, CYFD is required to manage the benefits for the child.
 - Requires CYFD to provide an annual accounting of the use of the benefits to the child, the child's attorney and the child's parents or guardians.
 - When a child is released from CYFD custody, the benefits are required to be released to the child or the child's parent or guardian.

House Bill 5 (2025)

- Office of the Child Advocate Act:
 - Creates the Office of the Child Advocate and administratively attaches the office to the office of the attorney general.
 - Office is run by the state child advocate who is appointed by the governor for a term of six years. The governor must select the state child advocate from a list of persons nominated by the newly created state child advocate selection committee.
 - The nominating committee is required to have its first meeting no later than September 1, 2025.
 - The office provides oversight over CYFD and investigates complaints against the department.
 - The office is annually required to:
 - report to the legislature on the status of the state's child welfare system and CYFD's performance; and
 - Provide recommendations for improving the child welfare system.

CYFD Budget History



In 2024, the GAA also included **\$24 million in nonrecurring, special appropriations** to CYFD, **including \$18.6 million in the Government Results and Opportunity Fund** (GRO) to pilot and evaluate targeted programs to address system challenges.

2024 GAA Multi-Year Appropriations Available to CYFD in FY26

- \$562.5 thousand to pilot incentives for master's-level social work attainment
- \$1.4 million to implement multilevel/alternative response
- \$1.25 million for recruitment and retention of foster families
- \$3 million for evidence-based prevention and early intervention programs

2025 GAA Special Appropriations (Sections 5,6,9,10) GRO funding included:

- \$30 million over three years to hire 101 caseworkers annually;
- \$9.6 million over two years to hire case aides;
- \$5.6 million to create a regional on-call response team;
- \$5.4 million over three years to pilot and evaluate a child welfare workforce training academy;
- \$5.2 million over to years for operating costs related to Senate Bill 42;
- \$1.8 million over two years for personnel to meet *Kevin S.* data obligations; and
- \$600 thousand over two years to respond to inquiries from the Office of the Child Advocate

The Legislature maintained a relatively flat operating budget for CYFD in the 2025 GAA while **investing more than \$72 million in non-recurring, special appropriations** from the general fund and the GRO fund. All together, the Legislature made more than **\$111 million in additional funding available to CYFD** in this year's GAA.
