

About Los Alamos County

- Population ~19K
- Commuting Workforce ~10K
- Type H combined city/county
- Budget
 - FY26 \$368M
 - \$122M General Fund revenues, 72% from GRT
 - \$50M Fire Services contract serving LANL
 - ~100M Utility revenues




Explanation


The adopted Fiscal Year 2026 budget totals \$367.9 million, representing a \$9.6 million reduction from the Fiscal Year 2025 budget of \$377.5 million. This decrease is largely attributable to a \$37 million decline in capital project funding. However, several areas experienced funding increases,

including \$6.6 million in the General Fund, \$6.5 million in Special Revenue Funds, \$5.2 million in Debt Service, \$8.0 million in the Joint Utility System Fund, and \$2.8 million in Internal Services Funds. The Other Enterprise Fund decreased by \$1.7 million.

General Fund Revenue Sources




Federal Budget Impacts Projected



Federal Impacts Actual


GRT Overview

- Ø General Fund GRT Revenue for FY25 \$80.7M or 86% of Adopted Budget of \$93.6M
- Ø GRT Revenue was projected to be \$10M lower during FY26 budget adoption
- June 30, 2025, GRT is now realized to be ~ 14% or \$13M lower than the adopted budget.
- \$4M lower than projected with the FY2026 Budget Hearings

Fiscal Reality

- GRT is 72% of the General Fund revenue; property taxes only 8%
- FY25 GRT revenue is \$13M below the adopted budget; further declines expected in FY26
- Without action, unsustainable deficits of (\$16M) – (\$20M) begin in FY27

Regional Competitiveness and Support

Even with the proposed increase, Los Alamos County's GRT rate remains below neighboring counties:

Taos: 9.175%

Santa Fe: 8.1875%

• Espanola: 8.6875%

- Los Alamos (July 1, 2026): 7.6875%
- Maintains competitive advantage for residents and businesses
- 0.625% GRT increase ensures the ability to provide regional partnership support, without it, these programs would be in jeopardy

Recent projects

- 2020 Trinity Dr repaving and allowed for a road diet from Oppenheimer to Diamond Dr
- 2021 Main Hill Rd repaving
- 2024 NM 4/East Jemez Intersection Improvement collaboration
- Canyon-Rim Train and Urban Trail grant support

Transit

- Bandelier shuttle, NCRTD, Park & Ride partnerships
- All in one app to facilitate customer connections between services (add-on to MyRide app)
- Saturday service ride share on-demand pilot for 13 weeks
- Great relationship with NM Department of Transportation

Needed Infrastructure Projects

- NM 4 reconstruction White Rock to West Jemez Rd (501)
 - Paving is scheduled, however a widened shoulder or separate bike/ped path is needed for safety
- Additional safety improvements
 - Trinity Dr, Oppenheimer to Knecht St
 - NM 502/Camino Entrada Intersection (LANL safety audit)
 - NM 4/Sherwood Blvd Intersection Signal
- Support robust funding for road improvements regionally
