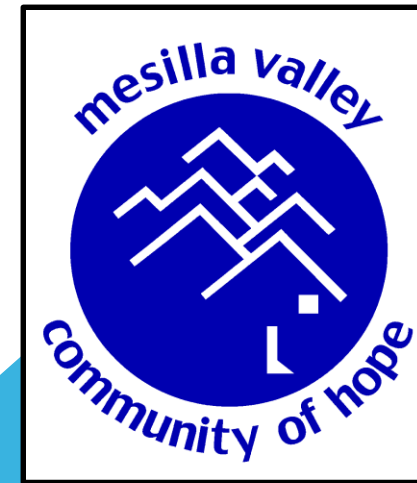

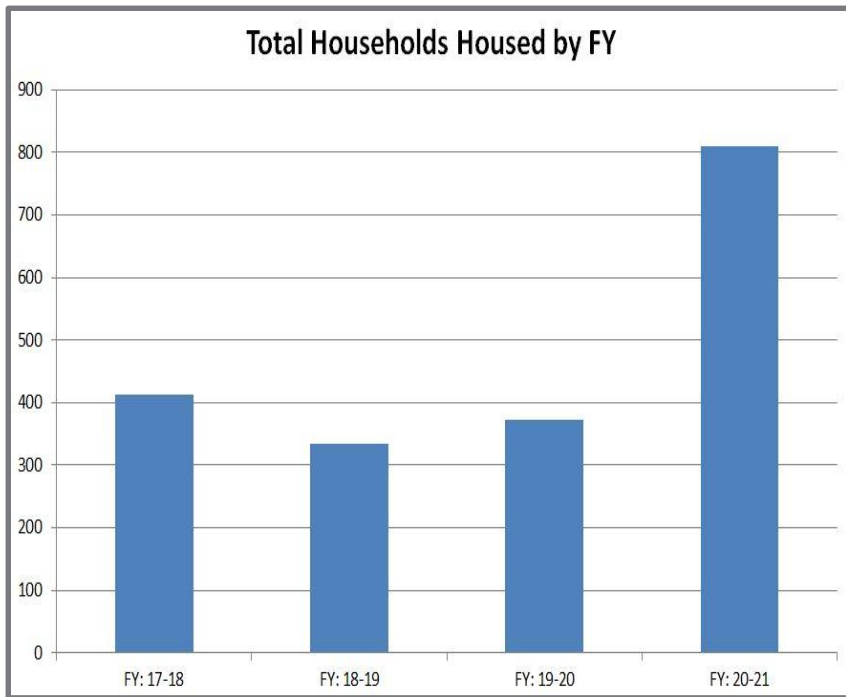

INCOME SUPPORT

- MVCH assists clients with applying for disability benefits; last year MVCH assisted 568 clients with this service
- Mano y Mano Day Labor Program; partnership with the City of Las Cruces:

Unique People Worked-

Men- 438

Women- 130

- Assistance with job search and applications
- Resume writing assistance



CAMP HOPE

- Camp Hope began in November 2011
- Not a funded project; relies on community donations
- Hosts up to 50 people, but typically holds at 40
- Encouraged to contribute 6 hours of service per week and
- Create housing plan
- Keeps people in a safe place while they transition into housing
- Last year, Camp Hope residents contributed 12,328 hours of volunteer service,
- **Total Served in 2020-21: 254**
Male- 167
Female- 87

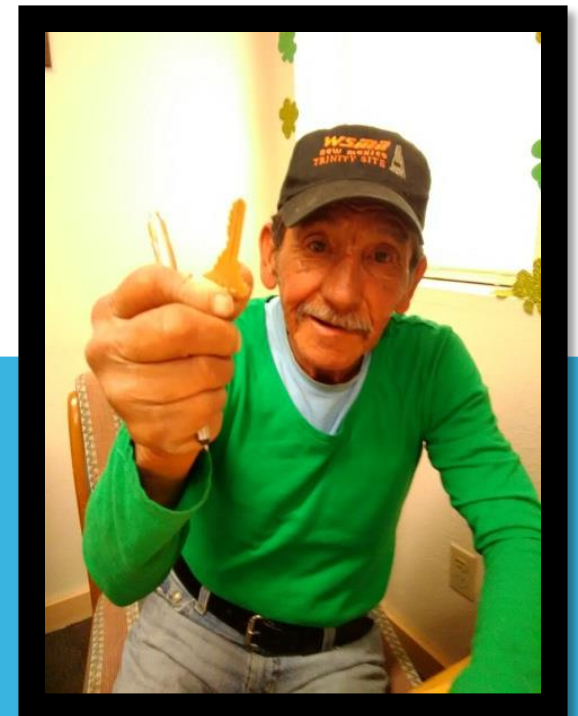

HOUSING ENDS HOMELESSNESS

- Last year, MVCH housed 1,290 people, including 258 children
- MVCH has several different types of housing programs; owns 3 homes; partners with over 100 landlords annually
- Case workers perform home visits once per month
- Clients contribute 30% of their income toward the rent



DESERT HOPE APARTMENTS

City of Las Cruces has a shortage of affordable housing units (over 7,000 units);

MVCH partnered with the City of Las Cruces and the MV Public Housing Authority to bring in Low-Income Housing Tax Credits

Acquisition/Rehab of 40 units

MVCH has staff person onsite; opened August 9, 2021!

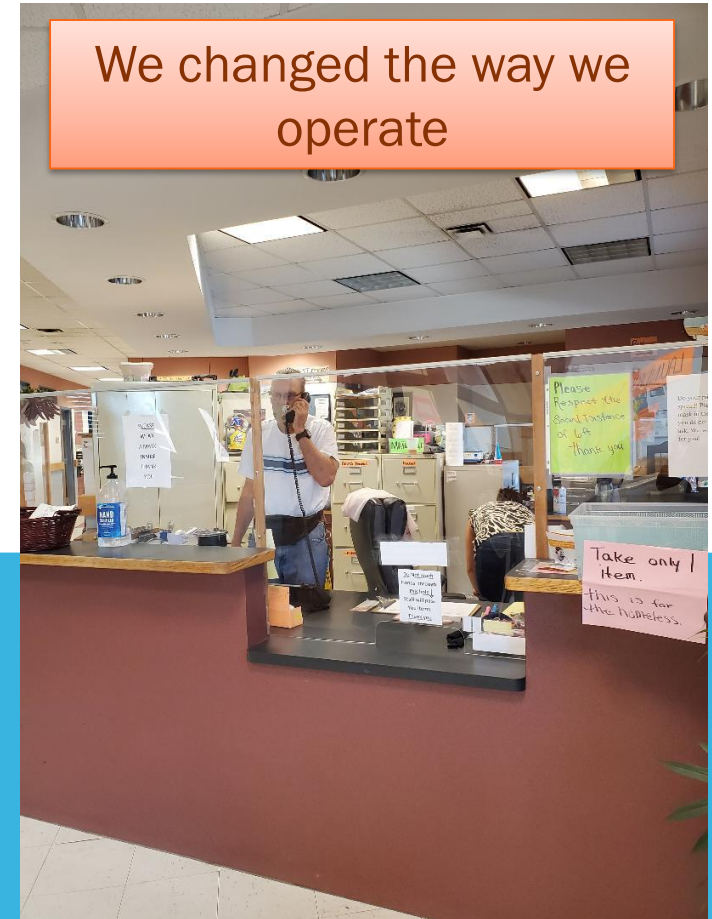


COVID-19 RESPONSE

- Additional funding from City of Las Cruces , VA, NM MFA for rent/mortgage/utilities
- Just last year alone, we helped 1,010 people with mortgages, rent, and motel stays during the pandemic
- Concerns about evictions/ nonpayment of rent
