**Quarterly Report, November 2024** 

### **Capital Balances Push \$6 Billion**

At the end of the first quarter of FY25, outstanding capital outlay balances totaled an estimated **\$5.8 billion across roughly 5,300 projects**. The unspent funds include projects authorized by the Legislature (\$3.3 billion), projects funded through severance tax bond earmark programs (\$651.2 million), supplemental severance tax bonds for public school construction (\$1.6 billion), and special appropriations to capital projects (\$225.3 million). The last figure represents uncommitted and unspent funds from \$977.4 million in special appropriations from 2021 and 2022. Attachment A

**REPORTS** provide analysis on the progress of capital appropriations.

Data is derived from the Department of Finance and Administration, state and local entities, and the Capital Projects Management System. Outstanding balances reported in this memo reflect reported expenditures as of September 2024 and do not include encumbered but unspent funds, with the exception of balances reported for special appropriations.

### **Key Points**

- Balances do not yet include 2024 projects authorized for funding with general obligation bonds, which were approved by voters in the November election. The Board of Finance will sell the bonds—totaling approximately \$288 million—this spring.
- An estimated \$141 million was spent in the last quarter on legislatively authorized capital projects, or 7 percent of the previous quarter's balance.
- More than half—56 percent—of legislative project balances are from the general fund (\$1.9 billion) and a third are from severance tax bonds (\$1.1 billion). Projects funded with general obligations bonds make up 6 percent of legislative project balances (\$219.7 million).
- Construction demand remains high in New Mexico, with recent public sector growth outpacing a still notable increase in private activity.

### **Construction Landscape**

### State and Local Spending Grew by Almost a Third in 2023

Since 2019, private nonresidential and state and local construction spending in New Mexico has grown at a far higher rate than in the nation as a whole—with an 83 percent increase in these two categories in New Mexico versus just 37 percent nationally. That growth was driven by dramatic increases in public and private spending starting in 2022 and continuing into 2023, the most recent year for which data is available.



In 2022, private nonresidential construction spending increased by 87 percent over the previous year while state and local spending increased by 31 percent. In 2023, private nonresidential construction spending grew again, though at a much slower pace, with a 16 percent increase over the previous year, while public sector growth continued at its previous pace, with a 31 percent increase. Absolute private sector spending continues to exceed state and local spending.

### **Stalled Projects**

The growth in state dollars available for capital projects is undoubtedly a driver of the increase in state and local construction spending. And while the uptick in construction activity is an economic boon for the state, it has also presented challenges in the form of cost increases and labor shortages. A 2023 LFC *Policy Spotlight* on public construction costs found New Mexico needs at least 2,000 more construction workers to meet current demand.

These challenges are likely contributing to growing balances across the state's capital programs, which reflect a basic reality: new funding is flowing into the pipeline at a rate that outpaces spending capacity. Large balances have piqued legislative interest in identifying stalled projects.

Balances are an imperfect but accessible proxy for measuring projects' progress, and the state's system for monitoring and tracking capital projects is not currently well equipped to identify stalled projects with precision. High balances could appear on projects that are progressing. Local entities may

request reimbursement only at the end of a project, for instance, and if appropriations are made to projects before design is complete, higher levels of spending associated with construction may be delayed multiple years.

Nevertheless, LFC analysis of expenditure data for the first quarter of FY25 identified 561 projects set to expire in June 2025 that had spent 10 percent or less of their original appropriations. Unspent balances on these projects totaled \$189 million. Such low levels of spending multiple years after appropriations are a strong indication of delayed progress and 85 percent of the 561 projects— with balances totaling nearly \$123 million—had not recorded any expenditures. Nearly 400 of the projects were local, with \$94 million in balances. Projects that had been reauthorized were the next largest category, with 145 appropriations totaling \$72 million.



### **Opportunities to Improve Local Project Success**

Local capital appropriations provide direct support for local priorities at no cost to municipalities, county governments, and other public entities, and because capital outlay is one of the few funding programs for public infrastructure that does not require a local match or debt, it is in high demand. The largest overall amounts are regularly appropriated to three categories of projects: roads, water and wastewater, and parks and recreation facilities.

This pattern indicates a desire among legislators to improve critical infrastructure around the state. However, due to the high demand for capital outlay dollars, legislators are often only able to contribute a fraction of project costs. About 45 percent of projects in the 2024 capital bill received 50 percent or less of the funding requested for those projects. Such piecemeal funding, along with obstacles like insufficient planning and local capacity limitations, often prevent completion of projects in a timely manner—or at all. For years, the state has not lacked clarity on the sources of these challenges nor potential solutions. What it has lacked is action to implement solutions.

Recently, however, the Legislature has taken several important steps to support local project success and it can continue to build on these efforts in the 2025 session.

Special Grant Programs. Legislative appropriations and statutory earmarks on certain revenues support a number of state-funded grant and loan programs that fund projects similar to capital outlay. The Legislature has expanded and bolstered these programs with recent revenue surpluses. In 2022 and 2023, the Legislature appropriated \$85 million to the Department of Finance and Administration for a grant program for local recreation and quality of life projects, for example, and it created a related but more specialized grant

program for trail development through the Outdoor Recreation Division of the Economic Development Department. In 2024, the Legislature appropriated an additional \$50 million to the water project fund to address a gap between qualified applications and available funding for water projects funded through the Water Trust Board. The Legislature created the transportation project fund in 2019, which now receives a portion of the motor vehicle excise tax to provide 95 percent grant support for local road projects.



These programs have proven popular with communities and LFC program evaluations have found they support project completion more effectively than capital outlay—partly because they have application-based processes that vet projects for need and readiness and partly because they are able to provide higher levels of funding. For example, water and wastewater projects are among the most common capital outlay appropriations but are typically expensive projects that are difficult to fully fund with the allocations each legislator receives. The average capital outlay appropriation to water and wastewater system projects was roughly \$455 thousand in 2024. The average award from the Water Trust Board, in contrast, was \$3.1 million. A similar gap exists for road projects funded through the transportation project fund versus capital outlay. The average transportation project fund award in 2024 was \$1.1 million versus \$514 thousand for capital outlay.

### Recommended Vetting Criteria for 2025 Requests.

- Appropriation would complete funding for a project or a functional phase.
- Design will be complete or near completion when appropriation becomes available, if requesting construction funding.
- Support only planning and design, if that work has not been initiated at time of request.
- Project is a top-three priority on a public entity's infrastructure capital improvement plan.
- Project reduces health and safety hazards or provides key infrastructure for economic development.
- ✓ Total project cost is based on estimates provided by a qualified professional.
- ✓ Land, property, rights-of-way, or easements required to begin construction have been acquired.
- ✓ Funding requested could not be secured through other sources.
- ✓ Entity has committed some local revenues to the project.

### \$1 Million and Greater Report – Attachment A

LFC's \$1 million and greater report for the first quarter of FY25 provides updates on 712 active or recently closed projects with appropriations totaling \$4.3 billion.

The 66 blue-rated appropriations reported as complete or fully expended this quarter include:

- Three appropriations dating to 2020 and totaling \$7.7 million for Western New Mexico University's Deming Learning Center;
- \$1 million for Popejoy Hall lobby improvements at the University of New Mexico;
- \$5.3 million for dining hall renovations at the New Mexico School for the Deaf;
- \$4 million for a Silver City senior, veteran, and youth facility;
- \$1.5 million for a Gallup public safety building;

- \$3.5 million for Las Vegas sports complex improvements;
- \$3.9 million for North Domingo Baca pool in Albuquerque;
- \$2.2 million for Laguna Pueblo fire station 1;
- \$1.2 million for the Sandia Pueblo child development center;
- \$7 million for new vehicles for the State Police; and
- \$2 million for dam rehab statewide.

## The 277 red-rated appropriations (see Table 3), indicating no activity, no or minimal reporting, recent reauthorization, significant challenges or delays, or significant unspent funds, include:

- A 2016 appropriation for \$2 million for library and building renovations at Southwest Indian Polytechnic Institute;
- \$2.5 million in two appropriations dating to 2020 for HVAC improvements to Luna Community College;
- \$1.1 million for an Albuquerque performing and visual arts education center;
- \$5 million to Roswell Air Center improvements;
- \$5.9 million for Rehoboth McKinley hospital improvements;
- \$4.9 million for Midtown campus improvements in Santa Fe;
- \$29 million in two appropriations for the Santa Fe magistrate court;
- \$4.5 million for an elevated water tank in Santa Teresa;
- \$20 million for the Next Generation Media Academy; and
- \$20 million for a metro area administrative complex for the Department of Public Safety.

#### **Earmark Funds**

The status of projects funded through the Water Trust Board (Attachment B), the Colonias Infrastructure Board (Attachment C), and the Tribal Infrastructure Fund (Attachment D) are summarized in the respective attachments.

#### Authorized but Unissued Projects (Attachments E)

Attachment E provides a list of projects authorized by the Legislature for which general funds have not been budgeted. Projects may be stalled due to lack of audit compliance or readiness to proceed. Currently, \$89.4 million in general funds are considered authorized but unissued; \$70 million of the total is related to 261 appropriations from 2024 to entities that are not audit compliant, indicated they were not ready to proceed, or did not complete questionnaires that are required before funds can be released.
