OUTCOMES/IMPACT

- Expanded staffing in areas with offices (ABQ and Las Cruces), and
 - appropriate levels of HR, Fiscal, and IT personnel to ensure operational excellence
 - better distribution of system-improvement work across the agency and more opportunities for professional development, career advancement, and job satisfaction (improving employee retention)
- Reduced reliance on contractors *while* achieving best practice caseloads for attorneys & higher quality representation
- Expanded interdisciplinary services to additional clients, leading to better outcomes for children
- Greater compliance with OFRA's enabling statute

OUTCOMES/IMPACT

- Higher quality representation from reasonable attorney caseloads and better geographic distribution of cases, while still
 - protecting existing lawyer-client relationships, and
 - preventing conflicts of interest
- Essential litigation supports lead to higher quality representation and better outcomes
- Critical staff supports for dealing with emotionally challenging cases (个 staff satisfaction & retention)
- Better data collection and evaluation (↑ continuous quality improvement)

- Staff Recruitment
- IT and telecom services
- Mileage and travel
- Subscriptions
- Office Supplies



On-site staffing and robust training will enhance accountability, improve advocacy and outcomes, and help attract and retain employees by:

- building more effective interdisciplinary teams
- enhancing mentoring, coaching, on-the-job training, and participation in educational opportunities
- increasing staff access to support
- facilitating easier management of personnel, IT services, and tracking of supplies/ equipment

What?

3 FTEs (lawyer, social worker, and navigator) to consult with families being investigated by CYFD

When?

During investigation but before filing of an abuse/neglect petition

How?

By identifying issues that may impact child safety and providing referrals with supported handoffs to legal and social service providers that can help families resolve identified issues.

Where?

Bernalillo, Chaves, Doña Ana, and San Juan Counties

Keeping children safe and with their family reduces trauma, increases positive outcomes, and saves taxpayer dollars.

Why?
