

# 1765 +/-

Generations of families have been living and working together to survive and thrive as best they can in the foothills of the Sandia Mountains now known as the Placitas area. In 1765 Juan Gutierrez first approached Governor Tomás Vélez Cachupín and requested, on behalf of himself and eight other families, a tract of vacant land which was known as San Jose y San Antonio de las Huertas.

On September 28<sup>th</sup>, 1765, Cachupín had Bartolomé Fernandez, the Alcalde (overseer of an area) of Santo Domingo, checked to make sure that there was "no impediment" to the surrounding Pueblo communities.

In 1767 the now twenty-one families residing in the "said place in good faith," asked that they, the twenty-one families, be granted the San Antonio de las Huertas grant. Governor Pedro Fermín de Mendinueta made the grant in the name of "His Majesty to the twenty-one families named in the petition of the place San Antonio de las Huertas."

Finally, in January of 1768 Governor Mendinueta stated that the grant boundaries were to be as follows so as "not to infringe" on the pueblos of San Felipe and Santa Ana and the settlers of Bernalillo: "on the north the brow of a hill adjoining the town which stretches to a sharp-crested hill adjoining the watering-place commonly called Una de Gato, on the south some red hills forming a ridge at the point of the Sandia mountain, on the east the place commonly called...(torn), and on the west some high hills adjoining the place commonly called the "plazitas"/las Placitas." It was further assessed that the eastern boundary "was at least as far east as the brow of the mountain on the San Pedro Road."





- Work to have the right to exercise and maintain our Traditional use rights.
- Continue to work to get back lost lands that are within our original Land Grant boundaries.
