
### **New Mexico Arts Division**

### **FY25 Program Statistics**

### **Regular Grants Program**

- \$1,170,958 in grants (57% state GF and 43% NEA)
  - 200 nonprofits and local gov't orgs & 3 folk art apprenticeships
- 33% of the funds went to 73 organizations in rural New Mexico
- 76% serve Native, Hispanic, and other historically underserved communities
- NMA grants supported 436 full-time arts jobs and 928 part-time arts jobs in the state
- Programs supported by NMA grants served more than 4,000,000 people including 780,000 children
- Over 15,000 artists participated, and more than 6,000 volunteers donated nearly 150,000 hours of their time
- In FY25, NMA investments in arts and culture leveraged more than \$40,000,000 in total cash expenditures by grant recipients







### **FY25 Program Statistics**

### **Art in Public Places Program (AIPP)**

Created in 1986 by state statute (Ch. 13, art. 4A NMSA 1978); 1% of state capital outlay over \$100,000 for eligible new construction or major renovation of public buildings is set aside for public art.

- Facilitated the acquisition of 335 public artworks a total of just under \$2.8 million
- Placed public artworks in 22 New Mexico counties 19 of which are considered rural.
- Worked with **Navajo Nation and 7 NM Pueblos** to secure public artworks for tribal government buildings.
- Through AIPP, 71 public art contracts with artists from tribal cultural backgrounds totaling \$900,050.



### NMA Program FY25 Additional Highlights

- New Mexico Epic Poem project workshops -Poet Laureate & NMA Director traveled to 13 rural communities in 13 different counties across the state. (29 of 33 counties visited over the 3-year program.)
- 8-week free artist professional development workshop in partnership with the National Hispanic Cultural Center.
- Arts & the Military mini grants 10 projects across the state including Otero Arts' monthlong Veteran's Arts Showcase.
- Rural Artist Residence program at Los Luceros Historic Site.
- 2025 Poetry Out Loud program; state winner from Montezuma placed 3<sup>rd</sup> at the national competition in Washington DC.

# ECONOMIC IMPACT OF NON-PROFIT ARTS INDUSTRY ONLY & THEIR AUDIENCES

In 2022, the impact of this economic activity generated **\$106.1 million** in total tax revenue to federal, state, and local governments.

\$43.39 per person per event is spent by LOCAL attendees, not including the cost of admission.

\$121.74 per person per event is spent by NON-LOCAL attendees, not including the cost of admission.



The New Mexico arts and culture sector was a **\$3.4 billion** industry in **2022** (**2.69%** of the state's GDP), representing **26,215 jobs** (**2.98%** of New Mexico's workforce), and total compensation of **\$1.9 billion**.

### **Key Social Impact Statistics - NM**

- 89.5% of arts and culture attendees agree that the activity or venue where they were surveyed "is inspiring a sense of pride in this neighborhood or community."
- 87.0% agree that "I would feel a great sense of loss if this activity or venue were no longer available."
- 82.0% agree that the venue or facility where they were surveyed is "an important pillar for me within my community."
