

Projected Growth toward Universal Access by Program and Fiscal Year






The Early Childhood Education and Care Department officially began July 1, 2020. The Department's aim is to create a more cohesive, equitable, and effective prenatal to age five early childhood system in New Mexico, ensuring that families in every corner of the state can access the services they need.

These dashboards share insights about the department's progress towards that goal.



Child Care Assistance

The Child Care Assistance Program subsidizes the cost of child care for families at or below 400% of the federal poverty level.



New Mexico PreK

New Mexico PreK (NM PreK) is a free voluntary program during the school year that delivers high-quality education in community-based and school-based settings.



Home Visiting

New Mexico's free, voluntary home visiting program is for any family expecting a baby or with children under the age of five.



Family Infant Toddler

ECECD's Family Infant Toddler program connects families with local experts to provide free screenings and evaluations to determine if their child is experiencing, or may be at risk for, a developmental delay or disability.


Child Care Assistance

Results by Developmental Domain




