

#### What does the DDPC Office of Guardianship do?

- Contracts with petitioning attorneys, court visitors, and guardians ad litem to provide <u>legal services</u> to request the court to appoint a guardian for <u>income</u> <u>eligible adults</u>
- Provides <u>professional guardians</u> appointed by state district courts
- Provides treatment guardians appointed by mental health courts
- Monitors contract compliance to ensure clients receive quality services
- Conducts comprehensive service reviews and protected person welfare visits
- Educates professionals and the public on <u>alternatives to guardianship</u>, guardianship court proceeding, and guardianship <u>best practices</u>
- Responds to and investigates <u>complaints</u> against professional guardians contracted with DDPC Office of Guardianship







#### DDPC Office of Guardianship Budget Projections

- Inaccurate historical budget projections resulted in drastically growing waitlists, large general fund reversions, and ballooning OOG fund
- Significantly more accurate projections, increased monitoring of contracts, and reduction/elimination of waitlist resulted in very small FY19 general fund reversion, projected FY20 budget shortfall, and a large BAR from OOG fund (if approved)
- OOG has already halted new case assignments for FY20 and expects the waitlist to grow drastically in the next few months
- OOG anticipates the OOG fund will be depleted by early FY21
- Without a significant budget increase, OOG anticipates very few new case assignments in the foreseeable future

#### Person-Centered Strategies to Maximize Resources

- Collaborate with state agencies to build comprehensive, sustainable community-based supports to adequately serve New Mexicans living with disabilities
- Educate the public, guardianship professionals, and the courts on least restrictive options and alternatives to guardianship
- Connect New Mexicans seeking guardianship with least restrictive options, including alternatives to guardianship
- Evaluate guardianship needs of clients to ensure quality contractor service and appropriate level of guardianship
- Empower clients to graduate from guardianship when appropriate
- Partner with the courts on a pilot program to monitor guardians and other substitute decision makers
