18	SECTION 1. Section 30-49-2 NMSA 1978 (being Laws 1993,

20	"30-49-2. DEFINITIONSAs used in the Tobacco Products,
21	E-Cigarette and Nicotine Liquid Container Act:
22	A. "child-resistant" means a package or container
23	that is designed or constructed to be significantly difficult
24	for children under five years of age to open or obtain a toxic
25	or harmful amount of the substance contained therein within a

Β. "e-cigarette":

means any electronic oral device, whether (1)composed of a heating element and battery or an electronic circuit, that provides a vapor of nicotine or any other substances the use or inhalation of which simulates smoking; and

includes any such device, or any part (2) 12 thereof, whether manufactured, distributed, marketed or sold as an e-cigarette, e-cigar, e-pipe or any other product, name or descriptor; but

does not include any product regulated as (3) a drug or device by the United States food and drug administration under the Federal Food, Drug, and Cosmetic Act [21 U.S.C. Section 301 et seq.];

"minor" means an individual who is less than C. [eighteen] twenty-one years of age [and]. "Minor" does not include active duty military personnel who are eighteen years of age or older who present an identification card issued by the United States armed forces as proof of age for this purpose or individuals who were eighteen to twenty-one years of age on July 1, 2018;

"nicotine liquid container" means a bottle or 2 other container of any substance containing nicotine where the substance is sold, marketed or intended for use in an e-3 4 cigarette; and E. <u>"tobacco product" means:</u> 5 (1) any product made of or derived from 6 7 tobacco or nicotine that is intended for human consumption, whether smoked, heated, chewed, absorbed, dissolved, inhaled, 8 9 snorted, sniffed or ingested by any other means, including cigars, cigarettes, chewing tobacco, e-cigarettes, pipe tobacco 10 or snuff; and 11 12 (2) any component, part or accessory used to consume tobacco but does not include any product that has been 13 14 approved by the United States food and drug administration for sale as a tobacco cessation product or for other therapeutic 15 purposes where such product is marketed and sold solely for 16 such an approved use." 17 SECTION 2. Section 30-49-5 NMSA 1978 (being Laws 1993, 18 19 Chapter 244, Section 5, as amended) is amended to read: 20 "30-49-5. REFUSAL TO SELL TOBACCO PRODUCTS, E-CIGARETTES OR NICOTINE LIQUID CONTAINERS TO PERSON UNABLE TO PRODUCE 21 IDENTITY CARD.--A person selling goods at retail or wholesale 22 may refuse to sell tobacco products, e-cigarettes or nicotine 23 liquid containers to a person who is unable to produce an 24 25 identity card as evidence that the person is [<del>eighteen years of</del> .208819.1

age or over] not prohibited from purchasing tobacco products,
e-cigarettes or nicotine liquid containers."

SECTION 3. Section 30-49-9 NMSA 1978 (being Laws 1993, Chapter 244, Section 9, as amended) is amended to read:

"30-49-9. SIGNS--POINT OF SALE.--A person, firm, corporation, partnership or other entity engaged in the sale at retail of tobacco products, e-cigarettes or nicotine liquid containers shall prominently display in the place where tobacco products, e-cigarettes or nicotine liquid containers are sold and where a tobacco product, e-cigarette or nicotine liquid container vending machine is located a printed sign or decal that reads as follows:

"A PERSON LESS THAN [<del>18</del>] <u>21</u> YEARS OF AGE WHO PURCHASES A TOBACCO PRODUCT, AN E-CIGARETTE OR A NICOTINE LIQUID CONTAINER [<del>1S</del>] <u>MAY BE</u> SUBJECT TO A FINE OF UP TO \$100 <u>OR UP TO 48 HOURS</u> OF COMMUNITY SERVICE.

A PERSON WHO SELLS A TOBACCO PRODUCT, AN E-CIGARETTE OR A NICOTINE LIQUID CONTAINER TO A PERSON LESS THAN [<del>18</del>] <u>21</u> YEARS OF AGE [<del>1S</del>] <u>MAY BE</u> SUBJECT TO A FINE OF UP TO \$1,000 <u>AND IS</u> <u>GUILTY OF A CRIMINAL MISDEMEANOR</u>."."
