On behalf of the New Mexico Counselors for Advocacy and Social Justice (NM CASJ), I am writing to express our support for the Counseling Compact. Our organization focuses on advocacy and social justice around mental health equity in NM. The compact has the potential to remove barriers to accessing mental health care. The rural areas of NM have limited access to well trained and qualified professionals, and the Counseling Compact serves to meet this need. It would provide greater access to services from providers that can better meet each client's specific needs. Additionally, the compact can allow both clients and counselors the ability to travel or relocate without interrupting therapeutic services. Also, this would allow counselors to move to NM and be able to see clients quickly if they come from another compact state.

Having stated these benefits, there are some areas that are specific to NM that must be considered when approaching the Counseling Compact. It is vital that NM residents remain protected from large tech companies who have put profits over client welfare. These large companies have the potential to bring counselors who are not from NM into treating NM residents. Counselors from other states must have cultural competency for working with the unique population in NM or risk hurting residents seeking treatment. The population and culture in NM are nuanced. When joining the compact, the legislature must ensure that the need for cultural competency in counselors outside of NM is addressed. Additionally, an exploration of the financial impact and accessibility for NM counselors must be explored. Joining the compact must support NM counselors, not further harm or alienate them. Finally, NM is still recovering from the consequences of the dismantling of the mental healthcare system which begin in the summer of 2013. There is a critical need to proceed with caution to mitigate the unintended consequences of the Counseling Compact. The NM behavioral health system requires further strengthening and increased consistency now more than ever. Thank you for your consideration.

Our two largest and premier counseling organizations in the United States (the American Counseling Association and the National Board for Certified Counselors) are in full support of this legislation. In short, the Compact addresses several issues that the American public have been struggling with for many years.

Additionally, the **Department of Defense (DOD)** fully supports this legislation (https://compactconnect.org/). We need to make it easier for military personnel and spouses to maintain their ability to practice when they or their clients relocate or travel to other states.

There is a shortage of independent Licensed Professional Clinical Counselors (LPCC) in New Mexico. Our citizens continue to go without vital mental health services and specializations due to lack of access.

There is a lack of sharing licensure and disciplinary action information across states because no central database currently exists. However, the vast majority of other states who have enacted legislation are already collaborating with The Council of State Governments to create this system.

The Counseling Compact is akin to a Driver's License. It would allow independently licensed clinical counselors to use their home state license to practice in another state, while each state holds the individual accountable to the law specific to the state in which they are practicing. Thus, the New Mexico Counseling and Therapy Practice Board (NM Regulation and Licensing Department) would continue to be responsible for protecting the health, safety, and public trust in the profession, as well as conducting disciplinary proceedings and taking action against those who violate NM laws.

While there will be details to consider, such as Medicaid reimbursement and ensuring the cultural competency of those practicing with our population, I believe that the collective wisdom of our legislators can ensure the Counseling Compact **is passed** with the necessary details to protect the public.

I am writing in support of the above Senate Bill previously introduced by Senator Maestas and respectfully ask for your urgent consideration of placing this Bill on the upcoming call for the July 18th Special Session.

New Mexico is one of only a few States in the Union that are not part of the Clinical Mental Health Counseling Consortium. There is a critical shortage of qualified behavioral health counselors in New Mexico and joining the Consortium would provide immediate relief from this critical mental health concern. As the Executive Director of Wilderwood, a 501(c)(3) autistic-led nonprofit that specializes in research and programs for autistic people with a focus on autism in women and girls, my team is among a handful of researchers worldwide who are leading research and therapy support for autistic females, including Wilderwood's development of a new assessment instrument and protocol for autistic women.

Because research into female adult autism is in its infancy, there is a lack of knowledgeable counselors who can recognize autism in women and provide appropriate clinical mental health support. There are only two such practitioners currently in New Mexico of whom we are aware, with a third due to be credentialed in 2025. If New Mexico joined the Counseling Consortium, this would open up access to counselors in all the other consortium states. Access to counseling across State lines has the potential to change the lives of New Mexico's autistic and neurodivergent women – as well as those with other behavioral health counseling needs – to gain support they so very greatly need.

As a licensed counselor in private practice these last 23 years, I am writing to express my strong support for the Counseling Compact in New Mexico. I am currently licensed as an LPCC in New Mexico; an LMHC in Washington State, and an LPC in Colorado. These are all comparable licensures, and each of them has a different renewal period, different CEU requirements, and an application process that ranges from simple to maddening (although North Carolina, where I resided briefly, is in a category all of its own in terms of making newly-arrived counselors jump through hoops to become licensed at a comparable level).

Most of my clients are from New Mexico, the state in which I received my first licensure and established my first private practice. My New Mexico clients travel extensively, and relocate for periods of time (or permanently) in other states – Texas, Colorado, Washington, Missouri, Utah, California, Washington D.C., Arizona, Illinois – and will forgo getting counseling if they have to switch to a new counselor. Obviously, this situation affects continuity of care and can be devastating to clients with whom I have established a strong and effective therapeutic relationship.

In a world where people are forced to relocate for education, employment, and jobs, how can a motivated, respected, and skilled counselor keep up with temporary licensure requirements, or worse, be forced to hold separate licensures in each client's location? Several years ago, when a client moved to California, there simply was no way for me to continue to be his therapist. Perhaps that has changed — I have not updated the spreadsheet I created to keep track.





Our state is in dire need of Mental Health resources, more Providers (therapists) who can provide those services, while at the same time finding ways to retain existing Providers in the state. Between the high need for mental health services and low level of providers available (we have less than 1 provider per 1000 residents), those providers are experiencing high levels of burnout, driving them to change fields, retire earlier than planned and/or leave the state all together. All these factors negatively impact the overall mental health crisis in the state, while also resulting in less revenue being generated. Couple all those challenges with the fact that private providers and small business owners also face the cost of paying GRTs on these services (which is uncommon across majority of the others states in the US) on top of high self-employment tax rates, they experience even greater strain and challenges in their ability to survive as a small business or private provider.

While I am personally just a resident in this state (not a Provider), I myself have experienced long wait times for mental health services and very limited options, as far as specific specialties being offered by those Providers. In my profession and through my work, I have also experienced many employees who are in need of mental health services but are unable to get those or have to wait for months to be seen, which negatively impacts them both personally but also professionally as effective workforce in their jobs.

We know that a community or a society is only as healthy and successful as those who struggle the most in that same community. We need more Providers and keep active the ones we currently have so that we can provide the services needed for all residents of state of New Mexico and elevate the quality of their lives, improve the standard and wellbeing of our entire state.

Counseling Compact will deliver on that premise by enabling access to more Providers, while also allowing existing Providers to increase their opportunity to grow and expand their business, stabilize viability of their own private practices or small businesses, all the while improving the quality of mental health services for our Residents. Dear Governor Lujan Grisham,

I am a Clinical Mental Health Counselor currently working in Private Practice. I moved to New Mexico in 2015 to create a life here as a Mental Health Therapist after working for twenty years as a teacher in Wisconsin. I worked in two non-profit agencies before deciding to create my own practice to allow for more flexibility for both my clients and myself. I believe that independent private practice owners are the backbone of our community. So, first of all, I want to thank you for all that you have done for my clients and myself (as a provider) by supporting us through COVID, allowing for phone and video sessions during COVID and raising Medicaid rates. However, we need your support once again before you leave office.

I am writing this letter to express strong support for creating and passing legislation for the Counseling. Compact in New Mexico. This legislation will greatly improve access to mental health services for residents of New Mexico. COVID changed the world as we know it. I started my Private Practice in July, 2019 and there was very little to no interest in telehealth before COVID. Since then, people realized that they can access those services anywhere they are and now the majority of my clients want telehealth and more importantly don't want to lose their weekly therapy appointment that they look forward to and need, because they have to leave town for work, vacation, a death in the family, to caretake for an ill family member, because their military spouse is being relocated or because they are in an abusive relationship and their closest supportive ally is in a different state. The Counseling Compact would allow for this crucial continuity of care.

Mental health therapy is unlike any other services and should be taken with special consideration because of this. I often say to clients that the therapeutic relationship is unlike many others in their life, because we have no personal bias and no positive/negative consequences as a result of the personal changes and choices in their life. Because of this, a therapist can become a confidante, an advisor or a guide as they encounter the trials, tribulations and hurdles throughout their life. One of the most difficult parts of my job is when a client feels forced to relocate outside of New Mexico because of choices they would otherwise not choose. The statement I hear most often is something similar to "I need to go. I really wish I could take you with me. I really don't want to start over with someone who doesn't know me like you do."

Because mental health counseling is state regulated, any client that has to move whether it is their choice, not their choice or required for mere survival, like in abuse, chronic poverty or possible job loss is expected to start over and lose sometimes the one supportive person that they have in their life. This Counseling Compact legislation would allow providers to work with neighboring states to enter into an agreement which allows them to virtually go with their clients. Currently, many people who are forced to change therapists, usually don't end up resuming mental health services at all, specifically because they don't want to "tell [their] story to someone all over again". Moving is stressful, as someone who has changed cities and changed states, I know. Being able to retain the same therapist would be wonderful! It would be one less obstacle that we are expecting struggling families to overcome.

Please consider creating and supporting the Counseling Compact legislation in New Mexico during this legislative session. This has been passed in 30+ states in our country. It would provide assistance and continuity of care for clients with an established therapeutic relationship, military families who get relocated for their job, while preserving state licensing requirements and regulations like laws that have already been passed for nurses, physical therapists, physicians, psychologists and EMS personnel.

We are in a time of urgent need and these services have never been more important.

The recent pandemic exposed unacceptable health care disparities throughout our country, highlighting the crisis of care we are facing. The Department of Health and Human Services estimates that 169 million Americans are living in an area with a mental health provider shortage. Even urban areas are struggling to find enough providers to meet the demand for our services. The question we now face is how to promote accessibility of mental health services safely across the country. The Counseling Compact is the most viable way of achieving this goal.

The purpose of the Counseling Compact is to provide a system of certifying that counselors have met acceptable standards of practice between member states, and to promote cooperation among Compact states in the areas of licensure and regulation. Much like existing licensure compacts for nurses, physical therapists, physicians, psychologists, and EMS personnel, the Counseling Compact will provide a mechanism for a member state to recognize licensing for practitioners in a different member state, and for professional counselors who meet uniform licensure requirements to quickly obtain a privilege to practice, without need for multiple licenses. It will also allow member state regulatory boards to better protect consumers through enhanced sharing of licensure information. Existing interstate occupational licensure compacts have been successful in reducing barriers for practitioners who wish to provide services in other states.

The Counseling Compact will benefit clients and the counseling profession by:

- Enhancing mobility for counselors who meet uniform licensure requirements;
- Increasing access to care for clients, ensuring continuity of care when clients or counselors relocate or travel to other
- Allowing military personnel and spouses to maintain their certifications more easily when relocating; and
- Preserving and strengthening the current system of state licensure.

Unlike national licensure initiatives that supersede state regulatory authority, an interstate compact allows a member state to continue to determine the requirements for licensure in that state, as well as maintain the state's unique scope of practice for all professional counselors practicing in that state, whether it be through a state-issued license or through a privilege to practice. Counselors utilizing the Compact must abide by the laws and rules of the state in which they are practicing, including adhering to that state's scope of practice. Additionally, by ensuring the sharing of investigative and disciplinary information among member states, the Counseling Compact will allow member state regulatory boards to better serve community needs while protecting the public.

Personal Experience. My own experience highlights some of the very issues the Counseling Compact is currently trying to address. I am a Licensed Mental Health Counselor residing in the state of Washington. I am also a property owner in New Mexico. where I will be permanently relocating in the next few years. My family has wished to relocate for several years, but in large part due to the inability for me to easily continue my counseling practice in another state, that move has been repeatedly delayed. After years of education, effort, and expense to build a thriving practice, it is very hard to consider potentially giving that up, or starting all over again, due to lack of licensure portability. I have no doubt many other mental health providers across the country have found themselves in similar situations. I have personally known several providers who have closed their practices permanently when moving to a new state, due to the complexities that often exist when trying to secure licensing across state lines, and the aforementioned practical and financial stressors involved in attempting to regrow an established practice.

As a whole, today's world is highly mobile. And it is estimated that our military families are relocated on the average of every three years. This lack of portability presents issues for professional counselors on a number of levels, the most obvious being the strain these difficult situations and decisions can put on families. It is also important to note the time and dedication it takes to become a mental health clinician, and the burden of debt from an advanced education that often results. The inability to be guaranteed that your education can translate and be similarly used across state lines can be a prohibitive factor to remaining in, or even entering into, the profession. It includes an element of potential future risk that some individuals may not be willing to take on. In a climate where our nation is facing such disparities in care, prioritizing support and minimizing obstacles for our providers is of paramount importance.

The converse is also true; clients are part of our mobile society as well. It takes time and energy to not only locate a provider, but to build the rapport necessary for effective treatment to occur. As things currently stand, if a client moves to another state, they have to find a new provider. This is inconvenient at best, and potentially life-endangering at worst, as in cases of individuals who need continuity of care to maintain stability. And given that therapy is based on the foundation of relationship, having to start over with a new provider is rarely ideal for anyone, under any circumstances. In most cases, existing regulations dictate that a client can't even be seen by their current provider if they are temporarily located in another state for work or travel. Many of my clients travel for work, and I can speak directly to the fact that these limitations have at times caused them great difficulty due to the disruptions this has imposed on their treatment.

I was fortunate enough that I was able to ultimately secure a license to practice in New Mexico. However, it came at additional time and expense, and I must now incur the financial and other impacts of meeting differing requirements for continuing education for each state, and paying fees for multiple licenses, adding to both my overall workload and the costs of running a practice. I am in a position where this is something that I can manage, but not all providers are able to meet such challenges. But even this solution did not solve the larger problems discussed—the mobility of our society, impacting both practitioners and clients, and the great need we have in this county to provide consistent care for our clients, while also taking care of our providers, many of whom are experiencing stress and burnout (45% of clinicians, according to 2022 American Psychological Association reports), from heavy caseloads and other challenges being faced in the profession.

The Counseling Compact could begin to address some of the inequities, and redundancies, that exist in our behavioral health care system. It is with all of these benefits in mind that I look forward to supporting the Counseling Compact in the state of New Mexico. Thank you for your time and consideration of these relevant and important issues facing our profession, as we work to address the mental health care shortage that our nation is currently facing.
