

### Economy & Finance

Bernalillo County's taxable gross receipts in mining and oil and gas extraction increased by \$2.2 million, or 367 percent, from this time last year. Retail trade is still the largest industry of the county's taxable gross receipts, making 24 percent of total taxable gross receipts, followed by professional. scientific. and technical services at 20 percent. The county's FY24 audit had 4 findings. including two significant deficiencies

(in thousands)




# Bernalillo County General Fund Balance (in thousands)

### Residential Property Tax by Use, 2024



- Bernalillo County's general fund is primarily made up of assigned funds. Assigned fund balance represents money
  that has been restricted, committed, or assigned to specific purposes within the general fund. In FY24, the county's
  unassigned general fund balance increased by \$147.8 million, or 84 percent, over FY23. This is because the
  Department of Finance and Administration required the county to reserve 25 percent of budgeted expenditures, or
  \$146 million.
- The county's behavioral health fund has an \$89 million balance.
- Bernalillo County residents are paying more in property tax in relation to their property value than the New Mexico average. The main driver of this is special levies, which constituents vote on. Voted special levies include levied property tax towards hospitals, public schools, local colleges, etc.

### Economy & Finance

Following the Office of the State Auditor's FY24 audit. the city of Albuquerque had 24 audit findings, including 2 material weaknesses, 12 significant deficiencies. 5 other noncompliance findings, and 5 other matter findings. Of these findings, 8 are repeat or repeated and modified findings. Audit findings include a miscategorization of \$2.3 million worth of invoices that were included in accounts payable at yearend, which is a repeat audit finding. One of the significant deficiency findings was noncompliance with the city's policy of evidence of employee approval of timesheets.



### City of Albuquerque General Fund Balance (in thousands)



The city of Albuquerque's general fund is primarily unassigned, or committed, fund balance. Albuquerque's general fund balance decreased by \$71.7 million in FY24, though the city saw an increase in revenue of \$21.7 million from FY23. The city's expenditures increased by \$82.6 million, which includes an increase of \$65 million towards public safety from FY23. In total, the city spent \$448.4 million on public safety in FY24.

### City of Albuquerque Revenue vs. Expenditures (in thousands)







APD recently reported a year-overyear decrease in quarterly violent crime and property crime. Outpacing similar decreases in national crime rates.
