Higher Education Governance Subcommittee Goals

Set Direction

Create clear expectations for how New Mexico's Higher Education Institutions (HEIs) will contribute to state education and economic development goals and develop a higher education governance structure that will meet those needs.

Assess

Structure Comprehensively assess New Mexico's current higher education governance structure, with the aim of enhancing systems and improving collaboration to create a more flexible system that can quickly support the

current statewide goal,

as well as adapt to

shifting needs and goals in the future.

Define what needs to be accomplished, including: constitutional and statute changes required for recommendations and establishment of operational and process goals to ensure that recommendations lead to a positive return on the state's invested capital






Studied Governance Structures Nationwide

Criteria for Selection

OUTCOME CRITERIA

Does the proposed model include:

- Authority and capacity to lead HEIs to achieve state goals
- Authority and capacity to drive operational efficiency
- Recognition of differences among HEIs (mission, size, location, etc.)
- Consistency of leadership


IMPLEMENTATION CRITERIA

Would the proposed model:

- Require constitutional or statutory change
- Incur significant costs to implement (monetary, time, staffing)
- Generate stakeholder pushback (legal, from existing HEI leadership, general public, etc.)




Other State Models Considered – North Carolina



*Each university has its own Board with powers delegated by state-level Board.




Other State Models Considered – Kentucky/Virginia






Other State Models Considered – Arizona






Other State Models Considered – Colorado






Other State Models Considered – Montana






Other State Models Considered – Tennessee






Other Model Studied – 2 Sector System





Other Model Studied – North/South System






NM HED Reactions/Conclusions

- 1. Things that are probably not the answer for NM:
 - a) A single "superboard"
 - b) A system with one university board and one CC board
 - c) A "north/south" board structure
- 2. There are concerns with combining a community college with a 4 year institution; importance of the community college mission
- 3. In NM, universities with community college branches are not working optimally as systems
- 4. Many states have had success with all community colleges in a single system
- 5. In certain cases, the state should consider taking action on institutions before accreditation is lost and students are negatively impacted.
