- Broad-based finance agency created in 1992 as a government instrumentality; staffed with 75 finance professionals (budgeted for 80 FTEs in FY2026 budget)
- Governed by an 11-member independent Board
  - Approves rules, policies, and projects
  - Oversees operations and approves budget
  - Active Committee process provides high level of oversight of NMFA's diverse and complex operations
- Expansive programming and service to New Mexico
  - Authorized to operate 27 programs through 13 Acts
  - New Mexico Finance Authority Act (§6-21-2):
    - Purpose: "...to coordinate the planning and financing of state and local public projects ... and to improve cooperation among the executive and legislative branches of state government and local governments in financing public projects."
  - Statewide Economic Development Finance Act (§6-25-6):
    - Purpose: financing projects and to achieve economic development goals of the state
- Administrator of four other Boards and their respective committees and one Executive Task Force
- Overseen by 24-Member NMFA Oversight Committee

- Created in 2001. NMFA serves as staff to the 16-member board and administers the Water Project Fund
- Board's duties are to authorize NMFA to make loans and grants to six types of water projects: 1) Storage, conveyance or delivery of water to end users; 2) Federal Endangered Species Act implementation projects; 3) Restoration and management of watersheds; 4) Flood prevention; 5) Water conservation or recycling, treatment or reuse of water; and 6) Wastewater Projects
- The Act created two funds:
  - Water Trust Fund, an SIC-managed permanent fund, that makes annual distributions to the Water Project Fund
  - Water Project Fund, created in the NMFA, which is used to make grants and loans recommended by the Water Trust Board and authorized by the Legislature.
    - The Water Project Fund receives annual distributions from the Water Trust Fund and a net 8.1% earmark of senior severance tax bonds
- In 2024, HB 211 authorized NFMA to use Water Project Funds to hire contractors to provide technical assistance and capacity development. The WTB and NMFA have approved two uses of these fund: 1) facilitation of regionalization and 2) small-system planning



- Primary responsibility of the Water Trust Board is to recommend projects for funding to the Legislature and the NMFA
- Since the 2017 application cycle, the WTB has relied upon comprehensive policies and evaluation criteria to prioritize project applications and set conditions for funding
- A six-agency Project Management Team evaluates applications and recommends prioritization to the WTB
  - Watershed projects reviewed by ENMRD, NMED, and Dept. of Agriculture scores averaged
  - All others evaluated by NMED or NMFA
  - **Evidence of appropriate planning required for all design and/or construction projects**
- Funding recommendations made in priority order by project type within WTB Policy Targets

- The annual Water Trust Board application cycle has been operated in the same manner and by the same personnel since the 2018 application cycle with policy and application procedures reviewed and refined annually.
- **The annual application cycle has multiple phases that typically occurs over 18-24:** 
  - Notice of Intent which allows NMFA to gauge volume of applications (key for estimating the number of days needed for applicant presentations) and provides access to the on-line application.
  - Project Application used by evaluation team to vet and prioritize applications
  - Legislative Authorization typically begins 2-3 months after the Water Trust Board makes its recommendation and lasts 30 or 60 days
  - Readiness Application begins approximately one month after the Water Trust Board makes its recommendation to the Legislature and lasts an average of 6 weeks
  - Regulatory Compliance provides applicants an opportunity to update project information that may have changed since application was submitted and allows agencies to determine regulatory/policy compliance
  - Water Trust Board Award made in order applications were prioritized in the fall, bypassing projects only for regulatory/policy non-compliance and lack of funding
  - NMFA Approval final terms of grants and loans recommended by the WTB and authorized by the Legislature
  - Readiness to Proceed clients have up to 4 months to submit all conditions of closing
  - Closing typically occurs in 3 to 4 months
  - First draw typically occurs within 120 days of closing



Prior to the 2018 application cycle, applications were either not fully vetted and/or prioritized before legislative authorization. In many years, all complete applications from qualified entities for qualified projects were presented for legislative authorization without complete vetting.

Full vetting of applications prior to the NMFA Oversight Committee Meeting endorsement consideration requires that the application start date occur approximately 3 ½ months before the last NMFA Oversight Committee Meeting.

- **\$157,845,329** was available for awards from Severance Tax Bond earmarks and Water Trust Fund Distribution.
- **The Legislature also appropriated \$200 million in general funds for projects authorized in 2025 and 2026**
- In April, the WTB recommended to NMFA that it make awards to 60 applicants from the 2025 Application Cycle totaling \$146,603,384
  - 42 Water Storage, Conveyance, and Delivery Projects totaling \$97,917,033
  - □ 12 Flood Control Projects totaling \$29,801,138
  - **3 Water Conservation, Treatment & Reuse Projects totaling \$16,985,213**
  - **3 Watershed Restoration and Management Projects totaling \$1,900,000**
- 42 of the recommended projects include construction in the project scope
- 2 projects were recommended for smaller scopes because of project readiness
  - Bosque Gardens requested \$3.225 million for Design and Construction: \$553,924 recommended for design only
  - Storrie Water Users Association requested \$18 million for Design and Construction: \$2.35 million recommended for Design only
- The WTB will make a 2nd set of recommendations to NMFA in August -- 10-15 projects are expected to receive awards totaling \$35 - \$45 million. These projects were not eligible for awards in May because they did not meet regulatory compliance – primarily due to late audits.

- MFA Operates the Water Trust Board primarily from a team of two highly experienced professionals that also oversee the activities of the Colonias Infrastructure Board and funding of the Colonias Infrastructure Project Fund
  - Legislative authorization of Water Trust Board projects constrains the capacity of the team
- In addition to collecting readiness to proceed and coordinating the closing, NMFA staff oversee the completion of the construction project with assistance from a technical contractor, historically NMED's Construction Program and more recently from ERG Engineering. Project oversight includes:
  - Determination of adequacy of plans and specs
  - Budget review and management
  - Change Order review and approval
  - Construction Oversight
  - Review of Quarterly Reports
  - Site visits from newly recreated NMFA Project Oversight Team (headed by Donnie Quintana) for projects not meeting identified milestones

### Changes from HB 211 Inclusion of Wastewater Projects

- The Water Trust Board revised its rules to accommodate the HB 211 revisions to the Water Project Finance Act:
  - Removed requirement that the Board give priority to projects considered urgent to meet the needs of a regional water plan
  - Removed submission of a water conservation plan
  - Removed fiscal agent fees as eligible project costs
  - □ Added Wastewater projects as an eligible Water project
- At its June 25, 2025 meeting, the Water Trust Board also revised its comprehensive Project Management Policies to incorporate those changes and to provide for the inclusion of Wastewater. NMFA consulted with NMED on the recommended changes:
  - Defined "appropriate planning documents" for wastewater
  - Definition of scope of eligible wastewater projects
  - Reallocated spending targets
    - Reduced Watershed Management minimum from "10% -15%" to "Up to 5%"
    - Reallocated prioritization weighting to accommodate the elimination of the completed regional water plans

- The policies also provided an expansion to the loan forgiveness policy:
  - The NMFA may forgive loan repayments in their entirety upon the completion of regionalization projects that result in a physical connection between systems and the provision of water to a regionalized community or communities"
  - Change may be needed to facilitate regionalization projects
  - Current policy provides that 100% grant is made when the project includes regionalization:
    - Consolidation
    - Expansion to unserved areas
    - Physical interconnections
  - Goals is to reduce the number of very small systems that are not able to operate sustainably
  - Supports the WTB's Technical Assistance priority of regionalization



- Technical Assistance Program ("TAP"): On August 7, 2024, the WTB approved a set-aside of \$3.5 million to hire contractor(s) to provide technical assistance to water systems. The technical assistance will focus on:
  - facilitating regionalization
  - individual small system planning
- ♦ On December 17, 2024, the WTB approved the policies governing the TAP.
- MMFA issued an RFP and selected a broad team of comprised of 11 contractors to provide the services
  - Engineers
  - Hydrologists
  - Accountants / Financial Advisors
  - Attorneys
  - Community Facilitators
  - Project Managers
- In June, NMFA began accepting letters of interest from systems requestion technical assistance
  At least one regionalization project has requested assistance
- Technical assistance could be broadened to manage individual projects within a region seeking to jointly procure for a contractor
  - Would assist small communities and systems in rural areas attract contractors



- The WTB began reserving portions of annual funding to cover cost overruns
  - 2021: 29 projects totaling \$51,035,518. 2 projects still in construction
  - 2021: \$2,280,398 set aside for cost overruns. Current Balance \$184,212. 4 projects received cost overrun awards
    - La Cueva MDWCA \$105,500
    - Rodarte MDWCA \$540,000
    - Rio Lucio DWCA \$250,686
    - Union del Llano MDWCA \$1,20,000
  - 2022: 31 projects totaling \$66,938,000. 13 open awards 12 of which are construction projects; 8 have not started construction
  - 2022: \$5,100,000 set aside for cost overruns. Current Balance \$5,100,000
  - 2023: 50 projects totaling \$122,442,762 were awarded. 44 open awards 33 of which are construction projects; 19 have not started construction
  - 2023: \$6,066,277 set aside for cost overruns. Current Balance \$6,066,277
  - 2024: 53 projects totaling \$163,835,366. 38 of the awards included construction. Most have not yet started construction.
  - 2024: \$6,739,082 set aside for cost overruns. Current Balance \$ 6,739,082
- In 2024, the Legislature appropriated \$18 million for Cost Overruns in projects awarded before 2024 (SB275). One cost overrun award made to date (Cerro Regional MDA from the 2020 Application cycle for \$1.2 million) Remaining balance: \$16.8 million.
