FY17 BHIZ HIGHLIGHTS



PACKAGE LIQUOR SALES

The city was able to work with the governor and state legislators to pass a law that would prohibit package liquor sales from 7:00 a.m. to 10:00 a.m.

- 2 SAMHSA GRANT

 The BHIZ Core group was able to work together to submit a SAMHSA Grant.
- NCI STAFF

 NCI added 3 counselors and 1 case manager.
- NCI GROUP THERAPY

 NCI offers' relatives 2 various groups a day (stress reduction, substance abuse education, group therapy).
- RMCHCS EXPANDED SERVICES

 RMCHCS added the Next Step Program. GED, and expanded to 40 beds and soon 50.
- STRATEGIC PLANNING

 Funded and supported a strategic plan for the McKinley County-Gallup Behavioral Health Collaborative
- Program evaluator will track client progress.
- RMCHCS AFTERCARE

 Case management, aftercare and work rehab will be offered to individuals up to one year after completion of the inpatient residential services.
- 9 NCI AND GIMC COLLABORATION
 NCI has begun meetings with IHS to potentially bring services to detox relatives.
- WORK REHAB

 RMCHCS has partnered with the Chamber of Commerce to create a job pool and work with local employers to hire clients out of the RTC. The City of Gallup has placed 7 individuals from the 20/20 work rehab in job internships and community enhancement positions throughout the City.



Behavioral Health Collaborative Strategic Plan

McKinley County Strategic Plan

In April the BHIZ hosted a strategic planning session for the 5 groups that form the Behavioral Health Collaborative. The five groups that form the Behavioral Health Collaborative are: Treatment, Prevention, Supportive Care, Education Resources, and Transition to Wellness. The planning session improved collaboration at a County level with multiple agencies that serve our population. In addition, the session provided a community developed plan with short, midterm and long term outcomes for addressing the substance abuse problems, collaboration and coordination of service issues faced by community members and providers.

The planning session identified needs in the community for the groups as follows: Treatment group- collaboration, building local capacity and provide cultural and respectful treatment; Prevention Solutions, Transition to Wellness and Aftercare group- housing, education, and prevention (combined 3 groups). The supportive care group- homelessness, resource list, housing. The Educational Resource group: no one showed but the majority of the participants that would have attended had already attended the Prevention, Transition to wellness and aftercare group.



Transportation

The City of Gallup Community Service Aides will provide secure safe transportation of intoxicated individuals from emergency departments, once medically cleared to the social detox NCI.





Currently, there is an average of 10 daily residents in the shelter. The expansion will allow for use of larger shelter space, thus allowing for up to 65 male beds and up to 25 female beds. The shelter will be made available to any community member after their 72 -hour hold or a 12 hold at NCl's social detox and/or sober walk-ins in need of shelter. Shelter residents will have access to individual counseling, group therapy, employment assistance, hot meals, transportation to medical appointments, and Case Management for a variety of social needs.

Case Management







This layout is great for a detailed explanation of one topic. NCI will implement a comprehensive case management led employment assistance program. Three Case Workers will be hired to help with job seeking skills and help them find employment. Case Workers will assist with obtaining identification cards, social security cards, calling employers, provide transportation to job interviews, assist with resume writing, videotape mock job interviews and assist with the completion of employment applications. The high-risk NCI Unit will be assigned to work closely with IHS and GIMC with regards to medical appointments to ensure that all clients have medical follow through.





NCI will implement the First Step Program, a 90-day residential treatment program with three phases leading towards employment and a sober lifestyle. The program will have two Traditional counselors and one Certified Substance abuse Counselor with experience in Motivational Interviewing. The added counselors will allow for individual and culturally appropriate sessions, increased number of interventions with families; when client consent is obtained. In broad terms, the program translates into the availability of secure, uninterrupted behavioral health care, and social service delivery while in the transitional phase of living. This program is designed to continue the recovery phase post detox, by promoting sobriety through a 90-day 12 step program with attendance to AA/NA meetings within Gallup and surrounding areas. This program will complement the goal: "To reduce public intoxication"

Outpatient Therapy

A full-time Certified Substance Abuse Counselor will be hired to provide counseling to social detox clients who request the service. Motivational Interviewing (MI) will be used to assist clients to move through the stages of change when it comes to their substance use. Motivational Interviewing is culturally appropriate, well accepted, and based on a self-determined need for change. Based on the 12 core functions a treatment plan will be co-constructed with the client.





A full-time Registered Nurse and 3 certified Nurse Assistants will be hired due to the need for medical support, assistance with triaging medically complex patients, screenings, and coordination with GIMC to ensure clients are keeping scheduled appointments. The Nurse and Nurse Assistants from NCI's High Risk unit will ensure that high risk patients discharged from the hospital to detox will receive access to their medications, monitor pills taken, remind relatives of their medication schedule, label and safely store all medications. Nurses and certified nurse assistants will provide counseling about the importance of taking their medication. Appointments will be arranged for patients through the partnership with GIMC and transportation will be provided to scheduled appointments.






UNDUPLICATED TOP 200 RELATIVES AT NCI FOR A 72 HR HOLD GENDER BREAKDOWN




