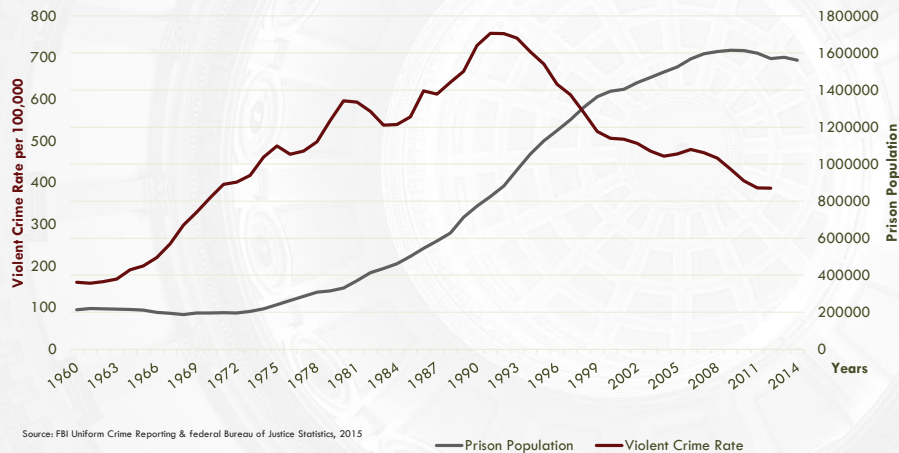

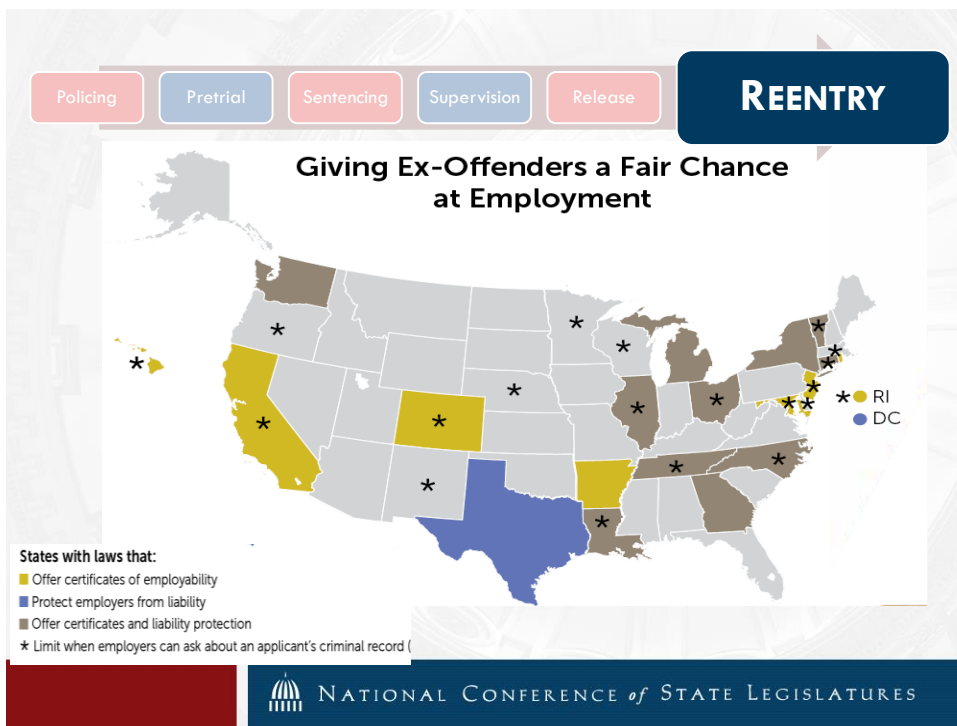
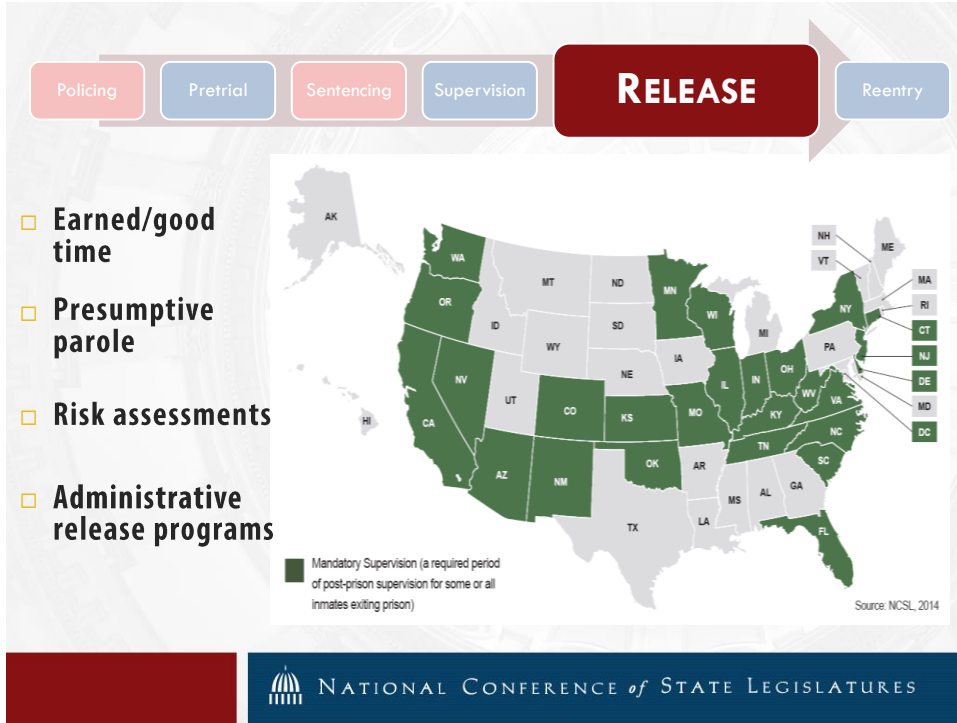
Level of surveillance (high to low)
