

NEW MEXICO JUDICIARY INITIATIVES ON FINANCIAL SENTENCES:

January 1, 2018: Payment of Fines, Fees, and Costs (NMRA 6-207.1):

- The court shall assess the defendant's ability to pay fines, fees, and costs at the type of sentencing
 - O Defendants who can pay, shall be required to pay in accordance with the financial sentence imposed by the court.
 - o Defendants who cannot pay, the court shall permit community service.
- Before the issuance of a warrant for failure to pay, the court shall issue a summons to appear or pay.
 - O At hearing, the court may modify the payment agreement or convert the payment to community service.
 - o The court must afford adequate procedural due process before jail is imposed.

Ongoing:

- Community engagement and contact through social media, letters, postcards, telephone calls, and text messages.
- Safe Surrender events to assist court customers with compliance before law enforcement contact.

Moving forward:

- Development of customer call center to assist defendants with routine questions about criminal case processing, and to issue phone calls / text messages to remind court customers about upcoming deadlines including hearings, payments, and other compliance matters.
- Reduction of fee funded positions
