# 2023 Paid Summer LESC Internship Program

The Legislative Education Study Committee (LESC) examines a wide range of education issues, both fiscal and programmatic, that affect the achievement and well-being of prekindergarten, elementary, and secondary students, and also postsecondary students enrolled in teacher preparation programs in New Mexico. The LESC internship will provide students with professional work experience and a unique opportunity to interact with elected officials. Interns will learn more about the legislative process and current education issues, and will have the chance to work on research projects alongside LESC policy analysts.

#### Who is eligible?

All undergraduate and graduate students interested in the legislative process are welcome to apply, regardless of major or year in school. Consideration will also be given to students who graduated college within the last year. High school students in their junior or senior year are also welcome to apply.

#### When does the internship begin and end?

Internships will take place in-person for 6-8 weeks between June 1, 2023 and August 18, 2023. There is some flexibility to accommodate other obligations and time commitments interns may have, and the application will allow candidates to share their availability. If the suggested dates or length of internship are a concern, please reach out to discuss your specific situation.

#### Is this a paid internship?

The LESC is committed to both providing a meaningful work experience as well as compensating interns for their important contributions. Earnings will be determined based on hours worked, and finalists will receive additional information about the offered rate.
