Public Engagement Plan

Special Education Stakeholder Public Engagement Plan

Purpose and Overview

Low educational outcomes for special education students, achievement gaps between special education student subgroups, and feedback from families and advocates have raised a series of concerns related to the services available to students with disabilities in New Mexico.

The Legislative Education Study Committee (LESC) will convene special education stakeholders to provide an opportunity for all to take part in a conversation regarding the provision of special education services in New Mexico, to learn, work with others, and provide input. To this end, the LESC will be organizing both listening sessions and convening a special education stakeholder working group:

- The purpose of the listening sessions is to provide the opportunity for stakeholders to express opinions, share ideas, and tell their stories.
- The purpose of the special education working group is to provide specific feedback on policy proposals from the LESC.

Intended Outcome

LESC staff will use feedback and recommendations to inform a draft bill proposal for potential LESC endorsement in December 2023 for consideration during the 2024 regular legislative session (if put on the governor's call).

Format

Listening Sessions

LESC staff will hold nine listening sessions for special education stakeholders—five in person sessions around the state and four virtual only sessions—from June through August 2023. Each listening session is scheduled for 90 minutes, but LESC staff will keep listening sessions open for as long as stakeholders would like to participate. LESC staff will record all listening sessions and will conduct a qualitative analysis of all listening sessions to synthesize what we are hearing to better facilitate deep understanding and learning for working group members.



Special Education Stakeholder Engagement Working Group

The special education stakeholder engagement working group will meet virtually from August through October 2023. The special education stakeholder engagement working group has already been seated at the recommendation of LESC members so that working group members have the opportunity to attend the listening sessions in June through August 2023.

Outreach

LESC staff will conduct outreach to special education stakeholders utilizing existing listservs from LESC, PED, the Developmental Disabilities Council/Office of the Special Education Ombud, the Early Childhood Education and Care Department, the Higher Education Department, and the Division of Vocational Rehabilitation, and other partners.

LESC staff will also use a press release to advertise special education stakeholder engagement sessions more broadly and to share these opportunities with stakeholders that may not be reached via existing listservs.

LESC staff will advertise special education stakeholder engagement sessions on their website.

Audience

The intended audience is all special education stakeholders in New Mexico.

Records

LESC staff will keep detailed, private records on all special education stakeholder engagement sessions, including names and contact information for all participants. All virtual stakeholder engagement sessions will be recorded. In addition, a dedicated note taker will take minutes for each session, and will capture all feedback submitted via Jamboard, chat, or email.

LESC staff will complete qualitative analysis to summarize trends and details from the listening sessions and working group. LESC staff will transcribe recorded sessions and complete analysis to summarize key findings, which would be anonymized. This summary will be shared with participants to ensure accuracy and to help inform any next steps.

Follow Up

LESC staff will share October 2023 and December 2023 presentations and work products with all participants.



Plan Público de Educación Especial con los grupos y las personas interesadas.

Propósito y descripción general

Los bajos resultados educativos entre los estudiantes de educación especial, así como el poco rendimiento entre los subgrupos de estudiantes de educación especial, y las observaciones de las familias y partes interesadas, han proyectado una serie de preocupaciones relacionadas con los servicios disponibles para los estudiantes con necesidades especiales en Nuevo México.

El Comité de Estudio de Educación Legislativa (LESC, por sus siglas en inglés) esta convocando a las partes involucradas a que sean parte de la conversación para aprender, colaborar, y contribuir con ideas y experiencias sobre el suministro de servicios de educación especial en Nuevo México. Con este fin, LESC organizará foros públicos y sesiones de escucha, además de crear un grupo de trabajo con las partes involucradas en educación especial:

- El propósito de las sesiones es brindar la oportunidad para que las partes interesadas expresen sus opiniones, compartan sus ideas y cuenten sus historias.
- El propósito del grupo de trabajo de educación especial es brindar comentarios específicos sobre las propuestas de políticas del LESC.

Resultado previsto

Para diciembre del 2023 el personal del LESC creara un proyecto de ley usando los comentarios, observaciones y recomendaciones que arrojen estas reuniones. Se presentará con el respaldo del LESC para su posible consideración durante la sesión legislativa regular del 2024 (si se somete a la convocatoria del gobernador).

Formato

Foros públicos

El personal del LESC organizará nueve foros públicos o sesiones de escucha para todas las partes interesadas en educación especial (cinco sesiones en persona a través del estado y cuatro sesiones virtuales). Las reuniones se llevarán a cabo desde junio hasta agosto del 2023. Cada sesión está programada con una duración de 90 minutos, pero si las partes interesadas lo requieren se extenderá todo el tiempo que sea necesario. El personal del LESC grabará todas las reuniones y realizará un análisis cualitativo de todos los foros

públicos para sintetizar lo que se diga en las reuniones y que los miembros del grupo de trabajo tengan un mejor entendimiento y un aprendizaje mas profundo.

Grupo de trabajo con todas las partes involucradas en educación especial.

El grupo de trabajo con todos los involucrados en educación especial se estará reuniendo virtualmente desde agosto hasta octubre del 2023. Este grupo de trabajo ya ha sido establecido bajo la recomendación de los miembros del LESC, buscando así que tengan la oportunidad de asistir a los foros públicos de junio a agosto del 2023.

Consultas Públicas

El personal del LESC invitará a las partes involucradas en la educación especial a través los servidores de listas existentes (listservs) del LESC, del PED, y del Consejo de Discapacidades del Desarrollo/Oficina del Ombudsman de Educación Especial, el Departamento de Atención y Educación de la Primera Infancia, el Departamento de Educación Superior y la División de Rehabilitación Vocacional, y otras agencias.

El personal del LESC también utilizará un comunicado de prensa para dar a conocer e invitar a las sesiones de trabajo a todos los involucrados en educación especial y promocionar de una manera mas extensa estas oportunidades de participación con las partes interesadas que no tienen acceso o que no están incluidas en los servidores de las listas existentes.

El personal del LESC también promocionará en su sitio web estas sesiones de los grupos de trabajo con las partes involucradas en educación especial.

Audiencia

La audiencia prevista son todas las partes interesadas y todos los involucrados en la educación especial en Nuevo México.

Información Confidencial

El personal de LESC mantendrá los registros privados y detallados de todos los participantes de los grupos de trabajo, incluidos los nombres y su información personal. Además de grabar todas las sesiones virtuales, una persona estará dedicada especialmente a tomar notas de cada sesión y capturará todos los comentarios enviados a través del Jamboard, chat o correo electrónico.

El personal del LESC completará un análisis cualitativo para identificar las tendencias y sintetizar los puntos importantes de las sesiones de escucha y del grupo de trabajo. El personal del LESC transcribirá las sesiones grabadas y completará el análisis para sintetizar hallazgos clave, manteniendo la confidencialidad. Este resumen se compartirá con los participantes para garantizar la precisión y ayudar a comunicar cuales serán los próximos pasos.



Seguimiento

El personal del LESC compartirá con todos los participantes los materiales y las presentaciones de las sesiones que se lleven acabo en octubre y en diciembre del 2023.
