- H 98a SCHOOL BUS FUEL GROSS RECEIPTS (**Passed H**), *Rep. Gonzales* creates a new section in the Gross Receipts and Compensating Tax Act to provide for a deduction from the Gross Receipts Tax for receipts for the sale of fuel for school buses for to-and-from school or school-related transportation; and provides a deduction from the Compensating Tax for fuel used in a school bus. - H 166 ALBUQUERQUE SCHOOL BLACK STUDENT UNION, *Rep. Stapleton* appropriates \$150,000 from the General Fund to the Public Education Department for expenditure in FY 15 to fund the Black Student Union Program in the Albuquerque Public Schools.
- H 167 BERNALILLO COLLEGE PREP TEST PROGRAM, *Rep. Stapleton* appropriates \$60,000 from the General Fund to the Local Government Division of the Department of Finance and Administration for expenditure in FY 15 to provide for an ACT and SAT preparation program and program evaluation in Bernalillo County.
- H 169 SCHOOL TRANSPORTATION BOUNDARY AGREEMENTS, *Rep. Lundstrom* creates a new section in the Public School Code to provide for transportation boundary agreements, including setting procedures and criteria for boundary agreements; also addresses the transportation of students residing on Native American reservations. (For the Indian Affairs Committee) [Related to H 308 and S 258, S 278, S 320, CS/S 330, SJM 12a]
- H 170 HIGH SCHOOL STUDENT INDUSTRY CERTIFICATION, *Rep. Stapleton* appropriates \$1.5 million from the General Fund to the Workforce Solutions Department for expenditure in FY 15 to assist high school students throughout New Mexico in paying fees associated with achieving the appropriate required industry certification in their chosen careers and technical education fields.
- H 172 MESALANDS CC ATHLETIC PROGRAMS, *Rep. Roch* appropriates \$75,000 from the General Fund to the Higher Education Department for expenditure in FY 15 for Mesalands Community College athletic programs.
- H 173 ABQ WEST MESA HIGH SCHOOL HEALTH CLINIC, *Rep. Maestas/Sen. Candelaria* — appropriates \$150,000 from the General Fund to the Department of Health for

expenditure in FY 15 to operate a school-based health clinic at West Mesa High School in Albuquerque.

- H 174 CHILD ENTICEMENT CRIMINAL PENALTIES (**Passed H**), *Rep. Perea* increases the criminal penalty for the enticement of a child to a third degree felony if the child is under 13 and to a fourth degree felony if the child is over 13 but younger than 16 years of age. (Message 18)
- H 182 MOVE APPRENTICESHIP ASSISTANCE PROGRAM (Passed H/Passed S), *Rep. Miera* — transfers the functions, appropriations, money, contractual obligations and other property, powers and duties related to the administration and oversight of the Apprenticeship Assistance Act from the Instructional Support and Vocational Education Division of the Public Education Department to the Workforce Solutions Department; also changes the membership of the Apprenticeship and Training Advisory Committee. (Message 28)
- \*H 184 ATRISCO LAND GRANT CULTURAL SITE PLAN, *Rep. Roybal Caballero* appropriates \$75,000 from the General Fund to the Board of Regents of the University of New Mexico for expenditure in FY 14 and FY 15 to fund a study by the Indigenous Design and Planning Institute to develop a plan for the preservation of cultural and historical sites and the development of a multipurpose center within the Atrisco Land Grant-Merced.
- H 187 CS/H 187 CS/CS/H 187 CS/CS/CS/H 187 CS/CS/H 187 CS/CS/H 187 CS/CS/H 187 CS/CS/H 187
  - H 194 PUBLIC SAFETY EMPLOYEE RETIREMENT, *Rep. Rehm* amends the Public Employees Retirement Act and Public Employer Group Provisions and defines "public safety employee"; provides that retired public safety employees may return to public safety employment without suspending their pensions during employment; provides that certain reemployed public safety employees are not required to pay the contributions under the applicable member coverage plan; and requires that the state or any other affiliated public employer pay public safety employees' member contributions and all group insurance contributions if such an employee sustains a non-administrative work-related injury rendering the employee absent from work on approved workers' compensation leave. (May affect public schools)
  - H 197a SOCIAL WOKERS AT CERTAIN ELEMENTARY SCHOOLS, *Rep. - H 220 NEW MEXICO GROWN PRODUCE IN SCHOOL LUNCHES, *Rep. MH García* appropriates \$100,000 from the General Fund to the Board of Regents of New Mexico State University for expenditure in FY 15 and subsequent years for the New Mexico Department of Agriculture to purchase locally grown New Mexico fresh fruits and vegetables and to administer a program to provide such fresh fruits and vegetables for public school lunch programs in the Gadsden, Las Cruces, and Deming school districts. [Related to H 81, H 86, H 271aa, and S 23aa, S 143, S 272]
- H 221 PROPERTY TAX EXEMPTIONS FOR CERTAIN AGE, *Rep. Stapleton* provides an exemption from property tax for persons of a certain age. (May affect public schools)
- H 227 LIMIT CERTAIN STANDARDS-BASED ASSESSMENTS, *Rep. McCamley* amends the Assessment and Accountability Act to limit to seven days a year the administration of all standards-based assessments to students in grades 3, 8, and 10; also eliminates standards-based assessments for students in other grades.
- H 235 CHILD CRIMES VICTIMS ADVOCACY FUND, *Rep. DY Gallegos* creates the Child Crime Victims Advocacy Fund in the State Treasury, with all fees collected to be transmitted monthly to the Department of Finance and Administration; also prescribes eligibility requirements for a child crime victims advocacy program to receive funding, requirements that include the use of a safe house to provide a secure environment for a child and the use of child forensic interviews by forensic interviewers who have completed 40 hours of nationally accredited training. (May affect public schools)

- H 245 AFRICAN AMERICAN SCIENCE & MATH BRIDGE PGM, *Rep. Powdrell-Culbert* appropriates \$350,000 from the General Fund to the Board of Regents of the University of New Mexico for expenditure in FY 15 to support the African American Student Services Science, Technology, Engineering, and Mathematics Summer Bridge Program.
- H 252a PRE-K PROVIDER GROSS RECEIPTS (**Passed H**), *Rep. Irwin* exempts from the Gross Receipts Tax those for-profit pre-kindergarten providers who provide pre-kindergarten services pursuant to the Pre-Kindergarten Act. [Identical to H 302]
- \*H 254a LOTTERY SCHOLARSHIP SOLVENCY (**Passed H**), *Rep. Smith/Sen. Candelaria* adds new material to current law to create the Legislative Lottery Tuition Fund Act; amends provisions relating to the Lottery Tuition Fund and the Community College Act; and repeals three sections of current law in Chapter 21, State and Private Education Institutions; provides a definition of terms such as "legacy student"; changes the amounts of the awards; and beginning in FY 15 requires the boards of regents or governing bodies of public postsecondary institutions to award lottery tuition scholarships to qualified students and legacy students. [Related to H 145, \*H 263a, \*CS/H 348a, HM 37 and S 141, S 146, \*S 150, S 302, S 303, \*S 327, \*S 379, SM 23]
- H 256 TRIBAL LAND CHARTER SCHOOL, *Rep. Lundstrom* appropriates \$75,000 from the General Fund to the Public Education Department for expenditure in FY 15 for the Indian Education Division to conduct a planning and feasibility study for a charter school on tribal land to serve isolated rural communities.
- H 258 SCIENCE & MATH TEACHER DEVELOPMENT, *Rep. Stewart* provides for CS/H 258 professional development for science and mathematics teachers within the Mathematics and Science Education Act; requires an annual report no later than November 1 of each year; and appropriates \$500,000 from the General Fund for expenditure in FY 15 and subsequent years to make grants for professional development for mathematics and science teachers.
  - H 259 EARLY LITERACY ACT, *Rep. Stewart* creates the Early Literacy Act within the Public School Code to provide support and funding for early literacy intervention, instruction, and remediation to students in grades K-3; includes definitions of intervention and deficient in reading; also prescribes program requirements that include a report by the participating school board or governing body and secretary by August 1, 2015 and each subsequent year to review early literacy programs; and establishes eligibility requirements for state funding. Stewart* amends the Public School Capital Outlay Act to define "educational technology infrastructure"; provides for allocations from the Public School Capital Outlay Fund for an education technology infrastructure; establishes an educational technology infrastructure deficiency corrections initiative; and allows for waivers for the local school share of the program cost. [Similar to\*S 159a, which passed]
  - \*H 263a LOTTERY SCHOLARSHIP CHANGES (**Passed H**), *Rep. Harper/Sen. Brandt* creates the Legislative Lottery Scholarship Act, requiring the Higher Education Department (HED) annually to determine a uniform percentage for calculating Legislative Lottery

Scholarships; defines the term "qualified student"; requires HED to promulgate rules and to report by November 1 each year to the Legislative Finance Committee and the Department of Finance and Administration; recompiles the section establishing the Lottery Tuition Fund into the Legislative Lottery Scholarship Act; amends the Community College Act; and repeals sections of Chapter 21 NMSA 1978. [Related to H 145, \*H 254a, \*CS/H 348a, HM 37 and S 141, S 146, \*S 150, S 302, S 303, \*S 327, \*S 379, SM 23]

- H 265 DUTY TO REPORT CHILD ABUSE & NEGLECT, *Rep. Chasey* amends the Child Abuse Code to clarify language describing the duty to report known or suspected child abuse or neglect. [Similar to \*H 334]
- H 266 EXPAND CRIMINAL SEXUAL CONTACT & EXPOSURE, *Rep. Clahchischilliage* expands the scope of criminal sexual penetration, criminal sexual contact, and aggravated indecent exposure according to the age of the child and the relationship between the child and the perpetrator. (May affect public schools) (Message 63)
- H 271a K-12 BREAKFAST AFTER THE BELL PROGRAMS [SGND (Mar. 5) Ch. 16 (Exec msg: 135)], *Rep. K. Martinez* amends the Public School Code to establish a "Breakfast After the Bell" program for students in grades K-12; establishes funding and reporting guidelines; also appropriates \$680,000 from the General Fund to PED for expenditure in FY 15. [Related to H 81, H 86, H 220, and S 23aa, S 143, S 272]
- H 274 ABQ SCHOOLS PARENT ADVOCACY PROJECT, *Rep. CH Trujillo* appropriates \$580,000 from the General Fund to the Public Education Department for expenditure in FY 15 and subsequent fiscal years to establish a Parent Advocacy Project to enhance parental support of failing students in Albuquerque Public Schools.
- H 275 RAISE STATE EMPLOYEE MINIMUM WAGE, *Rep. CH Trujillo* raises the minimum wage for state employees to no less than \$12.00 per hour.
- H 276 TEACHER LICENSURE ADVANCEMENT, *Rep. Roch* amends sections of the School Personnel Act to change the designations for teacher licensure levels to apprentice, professional, master, and administrator. [Related to FL/H 67a, H 148, H 289, and S 104, S 105] (Message 77)
- H 278a VETERAN VIRTUAL REALITY PTSD TREATMENT (**Passed H**), *Rep. Hamilton* continues the Veterans Virtual Reality Treatment Pilot Project to determine the efficacy of virtual reality treatments for veterans who suffer from post-traumatic stress disorder; provides for therapists training; provides for virtual reality therapy curriculum development for the Master's of Social Work Program at Western New Mexico University (WNMU); provides that the program be administered through WNMU with interim and final reports be given to the Governor and to the Health and Human Services Committee; and creates the Veterans Virtual Reality Treatment Fund. (Message 75)
- \*H 279 SCHOOL ADMINISTRATION OF EMERGENCY MEDICATION, *Rep. Egolf* creates the Emergency Medication in Schools Act, requiring the Department of Health (DOH) to promulgate rules regarding the use of Albuterol to treat respiratory distress and the use of Epinephrine to treat anaphylactic reactions in schools; provides for the stock supply of Albuterol and Epinephrine in schools; provides for school policies regarding the use of

Epinephrine in schools; requires DOH, by July 1, 2014, to promulgate rules and recommendations for each school district and governing body to administer Albuterol and Epinephrine. [Related to \*H 49, CS/H 52, H 53, and FL/CS/S 75a, S 165] (Message 72)

- H 280a RETURN TO STATUTORY SCHOOL CLASS LOADS (Passed H/Passed S), *Rep. Stewart* — creates a new section of the School Personnel Act to return to statutory individual class and teaching loads over a three-year period.
- H 281a ADULT BASIC EDUCATION PROGRAMS, *Rep. Miera/Sen. Padilla* appropriates
   \$4.0 million from the General Fund to the Adult Basic Education Fund for expenditure in
   FY 15 for additional funding for adult basic education.
- H 289 TEACHER COMPETENCY FOR ADVANCEMENT (**Passed H**), *Rep. Stapleton* amends the School Personnel Act to allow teachers to advance in the three-tier licensure system through multiple options. [Related to FL/H 67a, H 148, H 276, and S 104, S 105]
- H 294 COUNSELOR LEVEL 3-A SALARY ELIGIBILITY, *Rep. CH Trujillo* amends the School Personnel Act to clarify that counselors holding the highest-level counselors license are eligible for Level 3-A licensure salaries.
- H 295 EARLY LITERACY ACT, *Rep. Stewart* creates the Early Literacy Act within the Public School Code to provide support and funding to school districts and charter schools that deliver multiple opportunities to K-3 students who experience difficulties in learning language; and appropriates \$11.5 million from the General Fund to the Public School Reading Proficiency Fund for expenditure in FY 15 and subsequent years for early literacy intervention, instruction, and remediation for students in grades K-3. [Related to CS/H 93, H 259, and S 45, S 297]
- H 298 FAMILY IN NEED OF COURT ORDERED SERVICES, *Rep. Fajardo* expands the definition of "family in need of court-ordered services" within the Children's Code. (Message 86)
- H 302 PRE-K PROVIDER GROSS RECEIPTS, *Rep. Taylor* exempts from the Gross Receipts Tax those for-profit pre-kindergarten providers who provide pre-kindergarten services pursuant to the Pre-Kindergarten Act. [Identical to H 252a]
- H 303 NORTH CENTRAL ECONOMIC DEVELOPMENT PROGRAMS, *Rep. Garcia Richard* — appropriates \$200,000 from the General Fund to the Local Government Division of the Department of Finance and Administration for expenditure in FY 15 for the North Central New Mexico Economic Development District Council of Governments for economic development programs. (May affect public schools)
- H 308 SCHOOL TRANSPORTATION BOUNDARY AGREEMENTS, *Rep. Jeff* requires school districts with 75 percent or more Native American students residing within their boundaries to consult with tribal leaders regarding certain public school transportation issues; defines the term "school district" for transportation boundary agreements; and provides for a resolution process for transportation boundary disputes by requiring a written complaint to the Public Education Department. [Related to H 169 and S 258, S 278, S 320, CS/S 330, SJM 12a]

- H 312 HIGH SCHOOL WORK FORCE ASSESSMENT SYSTEM, *Rep. Miera* appropriates \$35,000 from the General Fund to the Workforce Solutions Department for expenditure in FY 15 to implement a national workforce assessment system that would replace for some public high school students the reading and mathematics exit examinations typically required for graduation.
- H 313 STATE BILINGUAL ADVISORY COUNCIL, *Rep. Miera* creates the State Bilingual Advisory Council to advise the Secretary of Public Education and the Public Education Department on the effective implementation of the Bilingual Multicultural Education Act; provides that the council consist of 15 members appointed by the Secretary; and provides duties of the council.
- H 321 REPEAL CAPITAL GAINS DEDUCTION, *Rep. CH Trujillo* repeals the Capital Gains Deduction from net income beginning on or after January 1, 2015.
- \*H 324 REPORTING CHILD ABUSE, *Rep. Gentry* clarifies that every person who knows or has a reasonable suspicion of child abuse or neglect shall report the matter; and makes violations of this provision a misdemeanor.
- \*H 325 SCHOOL SECURITY SYSTEMS, *Rep. Jeff* amends the Public School Capital Outlay Act to require by school year 2014-2015 that school districts and charter schools establish and implement a school security system; to establish a process for awarding funds for school security grants; and appropriates up to \$3.0 million to the Public School Capital Outlay Fund for expenditure in FY 15 through FY 17 for school districts and charter schools to establish and implement security systems.
- H 327a HIGHER EDUCATION FINANCE ACT, *Rep. Hall* creates the Higher Education Finance Act, for the purpose of outlining a funding formula methodology that will use a unit value concept to allocate for instructional and general funding for public postsecondary education. (Message 110)
- H 329 HOME SCHOOL TESTING & DIPLOMAS, *Rep. Baldonado* provides that a New Mexico diploma of excellence be awarded to resident home school students who demonstrate competence and meet certain graduation requirements through testing, including mathematics and language arts.
- **H 330 DIPLOMA SEAL OF BILINGUALISM (Passed H/Passed S)**, *Rep. Miera* creates a new section of the Public School Code providing for a state seal of bilingualism-biliteracy on a New Mexico Diploma of Excellence for graduates who are proficient in speaking and writing a language other than English.
- H 331 MILITARY SERVICE DEGREE PROGRAM CREDIT, *Rep. Anderson* provides for degree program credit for military coursework or military service.
- \*H 334 REPORTING OF CHILD ABUSE, *Rep. Gentry* clarifies that every person without limitation who knows or has a reasonable suspicion that child abuse or neglect has occurred shall report the matter, notwithstanding any other provision of law. [Similar to H 265] (Message 118)

- H 341 CONTRACTS IN SUNSHINE PORTAL, *Rep. Stewart* amends the Sunshine Portal Transparency Act to require the application of the inspection of Public Records Act and Open Meetings Act to certain contracts and provides requirements for outsourcing contracts. [Related to S 201]
- \*H 342a HEALTH ACT CHILD PLACEMENT DEFINITIONS (**Passed H**), *Rep. R. Martinez* revises definitions in the Public Health Act to include certain residential placements for children and persons up to 21 years of age. (May affect public schools) (Message 116)
- H 345 SCHOOL FINANCE "LOCAL REVENUE," *Rep. Stewart* changes the definition of "local revenue" within the Public School Finance Act to include 75 percent of any other receipts provided to the school district for noncapital purposes and derived from locally imposed gross receipts tax.
- H 348 LEGISLATIVE LOTTERY TUITION WAIVER ACT (**Failed H**), *Rep. Baldonado* \*CS/H 348a creates the Legislative Lottery Tuition Waiver Act; provides for a tuition waiver conditioned on the attainment of a degree or certificate; defines terms; and sets provisions for providing tuition waivers from the Lottery Tuition Fund. [Related to H 145, \*H 254a, \*H 263a, HM 37 and S 141, S 146, \*S 150, S 302, S 303, \*S 327, \*S 379, SM 23]
  - H 349 HOSPITAL GOVERNMENTAL GROSS RECEIPTS, *Rep. J. Trujillo* imposes a hospital gross receipts tax and a hospital governmental gross receipts tax on certain hospitals for one year; and suspends certain exemptions pursuant to the Gross Receipts and Compensating Tax Act, for certain hospitals, for one year. (May affect public schools)
  - H 351 BILINGUAL CHARTER SCHOOL ACT, *Rep. Maestas* creates the Bilingual Charter School Act; provides definitions of terms; provides for charter schools that specialize in bilingual education; and provides enrollment procedures that support the establishment of a bilingual student body.
  - H 352 TEACHER SCHOOL ADMINISTRATOR LICENSURE, *Rep. Stewart* amends the Public School Code to adjust requirements for teachers who qualify for school administrator licensure.
  - H 353 SOLICITATION OF CHILDREN INTO STREET GANGS, *Rep. Fajardo* makes soliciting or recruiting a child into a criminal gang a criminal offense and provides penalties, including a fourth degree felony. (Message 114)
  - \*H 357 DIPLOMA FOR STUDENTS MEETING REQUIREMENTS, *Rep. Stewart* provides for a New Mexico General Diploma for high school students who meet the requirements of 24 units in certain state academic and performance standards. [Related to \*H 66]
  - H 363 RETIREE HEALTHCARE CONTRIBUTIONS (**Passed H**), *Rep. Miera* amends the CS/H 363 Retiree Health Care Act by increasing the employer and employee contribution rates paid to the Retiree Health Care Fund. (May affect public school employees)
  - H 391 PHASED MINIMUM TEACHER SALARY INCREASES, *Rep. Stewart* phases in a minimum salary increase for teachers and principals beginning in school year 2014-2015.

HJM 6 DONATION OF EXCESS SCHOOL MEALS, *Rep. DM Gallegos* — requests that public school food directors donate excess school meals to public or nonprofit organizations that feed the hungry and the homeless; and requests that state agencies and nonprofit organizations convene a work group to address food redistribution to hungry and homeless people in New Mexico.

### HJM 11 BID & RFP TRAINING FOR STATE CONTRACTS (Passed H/Passed S),

CS/HJM 11 *Rep. Garcia Richard* — requests that the secretary of General Services develop guidance and secure qualified training for chief procurement officers on bids and requests for proposals for government contracts that will promote fair competition and transparency for New Mexico resident businesses and contractors. (May affect public schools)

### HJM 16 HIGHER ED FACULTY UNDERREPRESENTATION (Passed H),

*Rep. Clahchischilliage* — requests that the Higher Education Department appoint a task force to study the underrepresentation of minority faculty in schools of social work, sociology, and psychology at state colleges and universities; and requests a report of the results of the study to the appropriate interim legislative committee by August 1, 2014.

- HJM 17 SENIOR CITIZENS FOR EARLY CHILDHOOD TEACHING, *Rep. Thomson* requests that the LESC, in cooperation with the Public Education Department, the Children, Youth and Families Department, and the Legislative Finance Committee, study the feasibility of using senior citizens to assist with providing early childhood education for preschoolers.
- HJM 21 INDIAN EDUCATION SUBCOMMITTEE, *Rep. Jeff* requests that the New Mexico Legislative Council create an Indian Education Subcommittee during the 2014 interim composed of members of the LESC and the appropriate legislative committee that studies Indian Affairs.

Cisneros FL/S 6 — amends the Education Technology Equipment Act to include eligibility of locally and state-chartered charter schools for a prorated share of education technology equipment purchased through issuance of educational technology notes.
  - S 8a RESIDENT TUITION FOR SOME UNDERGRAD STUDENTS, *Sen. Papen/Rep. Roch* — provides for resident tuition and fee rates for international and nonresident undergraduate students studying science, computer science, health, information technology, engineering, mathematics, or business at certain universities.
  - S 13 STATE INSPECTORS GENERAL ACT, *Sen. Candelaria* enacts the State Inspectors General Act for the purpose of conducting and supervising internal and compliance audits and investigations relating to the programs and operations of departments and state-funded entities, including the Higher Education Department and the Public Education Department.
  - S 15 DENTAL STUDENTS IN WICHE PROGRAM, *Sen. - S 18 CAMPAIGN FINANCE REPORTING, *Sen. (May affect the Public Education Commission)
- S 20 CAPITAL OUTLAY CHANGES & COMMITTEE, *Sen. Campos* appropriates \$1.1 million from the General Fund to the Capital Project Administration Fund for expenditure in FY 15 and subsequent fiscal years to establish the Capital Outlay Planning and Monitoring Division to carry out the purposes of the Capital Outlay Planning and Monitoring Act; increases the fiscal and programmatic scrutiny of Capital Outlay expenditures; requires a comprehensive five-year plan with annual updates; creates the Capital Outlay Planning and Monitoring Division in the Department of Finance and Administration; creates the Executive Capital Planning Committee; creates a joint Legislative Capital Outlay Review Committee; and requires funding recipients to be current on audits and reports.
- S 23a K-12 BREAKFAST AFTER THE BELL PROGRAM (**Passed S**), *Sen. Campos* amends the Public School Code to establish a "Breakfast After the Bell" program for students in grades K-12, provided that the program shall begin the first school year after the Legislature provides funding for that portion of the program; establishes guidelines for reporting to the Public Education Department (PED); and appropriates \$680,000 from the General Fund to PED for expenditure in FY 15 to combine with the appropriation for breakfast for elementary students in the General Appropriation Act of 2014 to provide breakfast for all students. - S 34 NO STANDARDS-BASED TESTS FACTORED INTO GPA (**Failed S**), *Sen. Keller/ Rep. Stewart* — adds new material to the Public School Code to provide for a waiver of any standards-based assessment that is not factored into the student's grade point average.
- S 35 NMSU MENTAL HEALTH NURSE PRACTITIONER PROGRAM, *Sen. Papen* appropriates \$171,200 from the General Fund to New Mexico State University's Board of Regents to support the mental health nurse practitioner program for FY 15 and subsequent years.

Kernan* repeals the current remediation and promotion provisions in the Assessment and Accountability Act in the Public School Code and adds a new section to create the Academic Success Through Remediation Act; requires that a student who is not proficient in reading at the end of grades K-2 be provided with intensive remediation; requires that a student who is not proficient in reading at the end of grades 4.8 not be retained but be provided with intensive remediation; and requires assessment, intervention, and remediation programs to address deficiencies identified between grades K-8. [Related to S 297, and CS/H 93, H 259, H 295] (Message 3)

Cisneros \*CS/S 53 authorizes the issuance and sale of capital projects general obligation bonds to make capital expenditures for senior citizen facility improvements and acquisitions, for library acquisitions and for capital improvements and acquisitions at institutions of higher education, state special schools, and tribal schools; provides for a tax levy for payment of principal of, interest on, and certain costs related to the bonds; and requires approval of the registered voters at the 2014 general election of the state.

- CS/S 75
- *Rep. Herrell* requires the Department of Health to promulgate rules regarding the use of **FL/CS/S 75** Albuterol to treat respiratory distress and the use of Epinephrine to treat anaphylactic reactions in schools; provides for the stock supply of Albuterol and Epinephrine in schools; and provides for school policies and related laws to comport with federal grant requirements regarding emergency medication in schools. (FL/CS/S 75 & S 165) [Related to S 165, and \*H 49, CS/H 52, H 53, \*H 279]
  - S 82 COUNTY EDUCATION GROSS RECEIPTS FOR BONDS (Passed S), Sen. Martinez/ *Rep. Gonzales* — gives qualifying counties the authority to impose a special county education gross receipts tax dedicated to payment for bonds for public school capital outlay improvements.
  - S 96 ELECTED OFFICIAL & CABINET SECRETARY LOBBYING, Sen. O'Neill/ *Rep. Stewart* — prohibits former statewide elected officials, former public regulation commissioners, former legislators, and former cabinet secretaries from accepting compensation as lobbyists for a period of two years after their service; prohibits employers of lobbyists from compensating former statewide elected officials, former public regulation commissioners, former legislators, and former cabinet secretaries as lobbyists for a period of two years after service; and imposes a misdemeanor penalty for violation. [Related to H 82]
  - S 97a SCHOOL CHILD SEXUAL ABUSE DETECTION TRAINING, Sen. O'Neill — amends CS/S 97 the School Personnel Act to require all licensed school employees to be trained in detecting and reporting child sexual abuse; to require health education instruction to include age-appropriate sexual abuse and assault awareness, including assault awareness and prevention training; to require the Public Education Department (PED) to consult with the federal Centers for Disease Control and Prevention (CDC) in developing the section on child sexual abuse and assault; and to require PED to coordinate with the Children, Youth and Families Department to develop training programs that meet CDC standards.   - S 102 STATEWIDE ROBOT WORKSHOPS & COMPETITION, Sen. Kernan — appropriates 24 \* Emergency Clause LESC - 3/7/2014 (3:45 PM)

\$300,000 from the General Fund to the Board of Regents at Eastern New Mexico University for expenditure in FY 15 to manage and conduct statewide workshops for students in grades 3-12, together with their teachers, to learn to design, build, program, and test payload-delivering, firefighting, or other autonomous robots, culminating in an international robot competition. [Related to H 138]

- S 103 WICHE VETERINARY DOCTORATE PROGRAMS, *Sen. Kernan* appropriates \$300,000 from the General Fund to the Higher Education Department for expenditure in FY 15 through FY 18 to fund at least two additional slots for New Mexico students to obtain their doctorates in veterinary medicine through the Western Interstate Commission for Higher Education Program.
- S 104 STREAMLINE TEACHER ADMINISTRATIVE LICENSURE, *Sen. Moores* amends and creates sections of the School Personnel Act to grant an administrator's license to those who have completed or participated in an approved administration preparation program and hold a Level 2 license. [Related to S 105, and FL/H 67a, H 148, H 276, H 289]
- S 105 TEACHER LICENSURE & ADVANCEMENT, *Sen. Moores* amends sections of the School Personnel Act to change the designations for teacher licensure levels from Level 1 to "apprentice"; Level 2 to "professional"; Level 3-A to "master" or "master teacher"; and Level 3-B to "administrator." [Related to S 104, and FL/H 67a, H 148, H 276, H 289]
- S 115 SOCIAL WORKER IN HIGH POVERTY SCHOOLS, *Sen. Padilla* creates a new section of the Public School Code to require a social worker in every high-poverty public school and appropriates \$3.0 million from the General Fund to the Public Education Department for expenditure in FY 15 for the purpose of implementation.
- \*S 122a SCHOOL DISTRICT P.E. REQUIREMENTS (Passed S/Passed H), Sen. Brandt/ Rep. Harper — amends the Public School Graduation Requirements for students to meet a physical education requirement. [Related to S 178, S 307aa, SJM 10]
- S 123 NMSU DOÑA ANA CC DENTAL HYGIENE CLINIC, *Sen. Soules* appropriates \$225,000 from the General Fund to the Board of Regents of New Mexico State University for expenditure in FY 15 and subsequent years to support the Doña Ana Community College Dental Hygiene Clinic. [Identical to H 95]

# S 130a SERVICE MEMBER CHILD CUSTODY ACT [SGND (Mar. 1) Ch. 4

- CS/S 130 (Exec msg: 98)], Sen. Ivey-Soto/Rep. Cote creates the Deployed Parents Custody and Visitation Act and establishes procedures for modifying existing custody, time-sharing, or visitation orders for children of service members; prohibits entry of final orders modifying existing child-custody, time-sharing or visitation orders while a service member is unavailable pursuant to military orders; and prohibits the modification of existing child custody, time-sharing, or visitation orders solely because a service member is absent or might be absent pursuant to military orders. (For the Military and Veterans' Affairs Committee) (May affect public schools)
  - \*S 132 SCHOOL TURNAROUND PILOT PROGRAM, *Sen. Soules* appropriates \$3.0 million from the General Fund to the Board of Regents of New Mexico State University for

expenditure in FY 15 through FY 16 to develop and implement, through the Arrowhead Business and Research Park in collaboration with the Anderson School of Management at the University of New Mexico, a school turnaround pilot program for the adoption of applicable proven business management practices in participating school districts.

- S 135 RETIREE HEALTH CARE CONTRIBUTION RATES, *Sen. Muñoz* amends the Retiree Health Care Act by increasing the employer and employee contribution rates paid to the Retiree Health Care Fund.
- S 139 TRIBAL COLLEGE DUAL CREDIT PROGRAM, *Sen. Pinto* appropriates \$1.5 million from the General Fund to the Tribal College Dual Credit Program Fund for expenditure in FY 15 and subsequent years to compensate tribal colleges for forgone revenue due to the waiver of tuition and fees by the tribal colleges for high school students participating in the dual credit program during the preceding school year. Candelaria* amends the general provisions relating to state educational institutions to limit tuition increases for lottery tuition scholarship recipients, requiring that the tuition rate in effect when a student qualifies for the scholarship remain in effect for the remaining semesters for which the student qualifies; limited to the rate to eight consecutive semesters. [Related to S 146, \*S 150, S 302, S 303, \*S 327, \*S 379, SM 23 and H 145, \*H 254a, \*H 263a, \*CS/H 348a, HM 37]
- S 143 NM GROWN PRODUCE IN SCHOOL MEALS, Sen. Campos appropriates
   \$1.44 million from the General Fund to the Public Education Department for expenditure in FY 15 and subsequent fiscal years for the department to distribute to school districts and charter schools for the purchase of New Mexico-grown fresh fruits and vegetables for school meal programs. [Related to S 23aa, S 272, and H 81, H 86, H 220, H 271aa]
- S 146 LOTTERY TUITION RATES & DEFINITIONS, *Sen. Ingle* amends the general provisions relating to state educational institutions to limit increases for lottery tuition scholarship recipients and changes the definition of "full-time student" to require 15 credit hours; also requires that the tuition rate in effect when a student first qualifies for the scholarship remain in effect for the remaining semesters for which the student qualifies; and excludes summer sessions. [Related to S 141, \*S 150, S 302, S 303, \*S 327, \*S 379, SM 23 and H 145, \*H 254a, \*H 263a, \*CS/H 348a, HM 37]
- S 148 COMPUTER PROGRAMMING AS SCHOOL LANGUAGE, *Sen. Candelaria* amends the Public School Code to allow a course in a modern, widely used computer programming language to count as a language other than English.
- \*S 150 LOTTERY SCHOLARSHIP SOLVENCY, *Sen. Smith/Rep. Varela* makes two appropriations; adds new material to create the Legislative Lottery Tuition Scholarship Act; amends provisions relating to the Lottery Tuition Fund; and repeals three sections of current law in Chapter 21, State and Private Education Institutions; defines the term "legacy student"; changes the amounts of the awards and awards distributed; requires a minimum balance of \$2.0 million in the Lottery Tuition Fund; appropriates from the General Fund for expenditure in FY 15 and subsequent years: \$2.9 million to provide tuition scholarships for the full amount of tuition for legacy students and \$8.0 million to

provide tuition scholarships for qualified students as defined in the Legislative Lottery Tuition Scholarship Act. (For the Legislative Finance Committee) [Related to S 141, S 146, S 302, S 303, \*S 327, \*S 379, SM 23 and H 145, \*H 254a, \*H 263a, \*CS/H 348a, HM 37]

- S 153 HOME SCHOOL PROGRAM UNIT CALCULATIONS (Passed S/Passed H), Sen. Brandt — amends the Public School Finance Act to incorporate in the program cost calculation the home school student program unit provisions included in legislation enacted during the 2013 legislative session (technical change). (For the LESC)
- S 155 EARLY CHILDHOOD TEACHER RETENTION, *Sen. Rodriguez* appropriates \$300,000 from the General Fund to the Children, Youth and Families Department (CYFD) for expenditure in FY 15 to fund a demonstration project to increase the quality of early childhood education for children from birth to five years of age by providing incentives to increase retention of teachers in early childhood education programs; and requires CYFD to contract for operation of the demonstration through a nonprofit entity with at least two years demonstrated experience in achieving zero attrition among early childhood education teachers. [Related to H 123a]
- S 158a DUAL CREDIT PROGRAM PARITY [SGND (Mar. 5) Ch. 12 (Exec msg: 101)], Sen. Ivey-Soto/Rep. Roch — amends the general provisions relating to state educational institutions to provide dual credit parity for all school-age person as defined within the Public School Code; clarifies terms including "dual credit course," "dual credit program," and "high school"; and updates home school registration requirements. (For the LESC)
- \*S 159a EDUCATION TECHNOLOGY INFRASTRUCTURE FUNDING [SGND (Mar. 6) Ch. 28 (Exec msg: 103)], Sen. Candelaria/Rep. Stewart — amends the Public School Capital Outlay Act to define "educational technology infrastructure"; provides for allocations from the Public School Capital Outlay Fund for education technology infrastructure; establishes an educational technology infrastructure deficiency corrections initiative by the Public Education Department; allows for waivers for the local school share of the program cost; and appropriates up to \$15.0 million of the fund to council for expenditure in FY 15 through FY 19 for building systems repair, renovation, or replacement. (For the LESC) [Similar to \*H 260]
- S 160 MAGISTRATE RETIREMENT CHANGES (Passed S/Passed H), Sen. Beffort CS/S 160 amends the Magistrate Retirement Act provisions applicable to certain members by changing the age and service requirements for normal retirement, decreasing the pension multiplier for service earned after June 30, 2014, and increasing the number of years used to calculate the final average salary; provides a temporary suspension of and decrease and delay of the cost-of-living adjustment; increases the maximum pension benefit; increases contribution rates; requires membership and changes the pension form of payment and survivor beneficiary provisions for new magistrates and magistrates whose terms of office begin on or after July 1, 2014; and provides for the suspension of the cost-of-living adjustment for return-to-work judges, justices, and magistrates. (For the Legislative Finance Committee)
  - \*S 161a SCIENCE EARLY EDUCATION PROGRAM, *Sen. Papen/Rep. K. Martinez* amends the Public School Code to create the Science Early Education Program as a five-year pilot

project based on three-year student cohorts that incorporates hands-on, age-appropriate physics education into grades 6-8; establishes reporting and evaluation requirements for participating schools, including student and program assessments with a final report given annually to the Governor and the Legislature; creates the Science Early Education Fund in the State Treasury; and appropriates \$110,000 from the General Fund to the Science Early Education Fund for expenditure in FY 14 though FY 19 to carry out the provisions of the program.

- S 165 SCHOOL USE OF EMERGENCY MEDICATIONS, Sen. McSorley adds new sections to the Public School Code to create the Emergency Medication in Schools Act to allow for emergency administration of medication for asthma and anaphylaxis in schools. (For the Legislative Health and Human Services Committee) (Succeeding entries: S 75) [Related to FL/CS/S 75a, and \*H 49, CS/H 52, H 53, \*H 279]
- **S 169 SUMMER CIVICS SCHOOL COURSES AS ELECTIVES (Passed S/Passed H)**, *Sen. Muñoz* amends the courses of instruction and school programs section of the Public School Code to allow summer civic courses to be offered as electives.
- S 172 SPACEPORT GROSS RECEIPTS TAX USES, *Sen. Cotter* limits the use of certain proceeds of the county regional spaceport gross receipts tax.
- \*S 174a RESIDENTIAL PLACEMENTS FOR CHILDREN, *Sen. Beffort* revises definitions in the Public Health Act to include certain residential placements for children. (May affect public schools)
- S 175a SOFTWARE DEVELOPMENT GROSS RECEIPTS (**Passed S**), *Sen. Beffort* expands the definition of "software development services" for purposes of a deduction from gross receipts; and requires an annual report compiled on the deduction that includes the numbers of taxpayers approved to receive the deduction to be presented every three years to the Revenue Stabilization and Tax Policy Committee and the Legislative Finance Committee. (May affect public schools)
- S 178 SCHOOL EQUALIZATION GUARANTEE FOR P.E., *Sen. Lopez* appropriates \$14.0 million from the General Fund to the State Equalization Guarantee of the Public School Fund for expenditure in FY 15 to fund physical education in public schools pursuant to the Public School Finance Act and the Public School Code. [Related to \*S122aa, S 307aa, SJM 10]
- S 180 SANTA FE CC SMART & MICRO GRID PROGRAM, *Sen. Wirth* appropriates \$250,000 from the General Fund to the Higher Education Department for expenditure in FY 15 for the Santa Fe Community College Training Center Corporation to design and develop a smart grid workforce training program and a micro grid innovation laboratory, research park, and training center.
- S 188 FAMILY, INFANT, TODDLER PROGRAM RATE STUDY, *Sen. Morales* appropriates \$4.0 million from the General Fund to the Department of Health (DOH) for expenditure in FY 15 to implement the recommendation of DOH's 2003 study of reimbursement rates for providers of services to the Family, Infant, Toddler program that the DOH operates.

- S 192 BRAIN EDUCATION ADVANCED LEARNING PROGRAM, *Sen. Lopez* appropriates \$500,000 from the General Fund to the Board of Regents of New Mexico State University for expenditure in FY 15 to conduct a professional development pilot project to train public school teachers on a statewide basis in "brain education."
- \*S 197 SCHOOL TEACHER EVALUATION MORATORIUM, *Sen. Sapien* provides a oneyear moratorium on the teacher and school leader evaluation system created by the Public Education Department.
- S 199 VOCATIONAL DIFFERENTIAL IN FUNDING FORMULA, *Sen. Lopez* amends the Public School Finance Act to restore the vocational education-funding differential to the public school funding formula.
- S 201 SUNSHINE PORTAL CONTRACTS, *Sen. McSorley* amends the Sunshine Portal Transparency Act to require the application of the Inspection of Public Records Act and Open Meetings Act to certain contracts; and provides requirements for outsourcing contracts. [Related to H 341]
- S 204 NMSU MANUFACTURING DEVELOPMENT PROGRAM, *Sen. Cervantes* appropriates \$100,000 from the General Fund to the Board of Regents of New Mexico State University for expenditure in FY 15 to expand the Manufacturing Sector Development Program.

### S 206 FOSTER CARE SYSTEM STUDENT TUITION WAIVER (Passed S/Passed H),

- **CS/S 206** *Sen. Muñoz* adds a new section in state law regarding state and private educational institutions to provide for the waiver of tuition and fees at public postsecondary educational institutions for students who have been in the foster care system or in the legal custody of a New Mexico Indian nation, tribe or pueblo, or the Bureau of Indian Affairs.
  - S 207 STATE INSPECTORS GENERAL ACT, *Sen. Sapien* creates the State Inspectors General Act to require certain departments, including the Public Education Department and the Higher Education Department, to have offices of Inspectors General; creates the Government Accountability Coordinating Council; transfers functions, money, records, personnel, property, and contracts pertaining to audit and compliance; and makes appropriations from several sources to the respective departments to establish the offices of inspectors general.
  - S 210 NMSU ARROWHEAD CENTER, *Sen. Cervantes* appropriates \$145,600 from the General Fund to the Board of Regents of New Mexico State University for expenditure in FY 15 to increase and expand the Economic Development Mission of the Arrowhead Center for Business Development.
  - S 213 DOÑA ANA AT-RISK YOUTH INTERVENTION PROGRAM, *Sen. Soules* appropriates \$75,000 from the General Fund to the Board of Regents of New Mexico State University for expenditure in FY 15 and FY 16 for the School of Social Work to research, design, and implement a pilot project to reduce early court intervention for at-risk youth in Doña Ana County.

- S 214 TEACHER EVALUATION SYSTEM & COUNCIL, *Sen. Sapien* amends the School Personnel Act in the Public School Code to establish a Teacher and Administrator Evaluation System to include differential performance levels; establishes an Educator Preparation and Effectiveness Council to advise and oversee promulgation of rules for the new system and to establish an effective teaching portfolio within the three-tier licensure system; and appropriates \$4.5 million from the General Fund to the Public Education Department for distribution through the State Equalization Guarantee for expenditure in FY 15 to increase the Level 1 teacher salary.
- S 215 SOCIAL WORKER LOAN FOR SERVICE ACT, *Sen. Padilla* creates the Social Worker Loan for Service Act to authorize loans to certain students majoring in social work in return for a service obligation to the Children, Youth and Families Department (CYFD); provides repayment penalties if service is not completed; requires the CYFD to interview and select candidates for the program; provides for program administration by the Higher Education Department and provides certain contract requirements; and appropriates \$2.0 million from the General Fund to the Social Worker Loan for Service Fund for expenditure in FY 15 and subsequent years to carry out the provisions of the act.
- S 218 CAREER TECHNICAL STUDENT ORGANIZATIONS, *Sen. Campos* appropriates \$400,000 from the General Fund to the Board of Regents of Eastern New Mexico University for expenditure in FY 15 to support six career technical student organizations to accelerate career technical education programs for students statewide.
- S 222a PRE-K PROVIDER GROSS RECEIPTS, *Sen. Smith* provides a deduction from gross receipts for certain pre-kindergarten providers.
- S 225 MESA VISTA & PEÑASCO SCHOOL EARLY COLLEGE PGM, *Sen. Martinez* appropriates \$150,000 from the General Fund to the Public Education Department for expenditure in FY 15 for the Early College High School Program at Mesa Vista Consolidated Schools and Peñasco Independent Schools.
- S 230 ENERGY AUDITS FOR CERTAIN SCHOOL DISTRICTS, *Sen. Campos* appropriates \$10.5 million from the General Fund to the Energy, Minerals and Natural Resources Department for expenditure in FY 15 through FY 17 to conduct energy audits and to purchase and install appropriate alternative energy systems in school districts with fewer than 300 students.
- S 232a USE & SALE OF TOBACCO PRODUCTS TO MINORS, *Sen. Ryan* defines terms such as "tobacco product" and "vapor device" within the Tobacco Products, Alternative Nicotine Product and Vapor Act; prohibits the sale of tobacco products, alternative nicotine products, and vapor devices to minors; and requires that no later than August 1, 2014, the Public Education Department revise its tobacco, alcohol, and drug-free school district policy to include alternative nicotine products and vapor devices.
- S 250a INCORPORATE ARTS INTO CLASSROOM INSTRUCTION, *Sen. McSorley* appropriates \$350,000 from the General Fund to the Public Education Department for expenditure in FY 15 and subsequent years to create regional centers throughout New Mexico to assist licensed school employees to incorporate arts into classroom instruction in common core subjects and standards-based assessment.

- S 255 EARLY CHILDHOOD READING LITERACY PROGRAM, *Sen. Morales* appropriates \$200,000 from the General Fund to the State Equalization Guarantee distribution of the Public School Fund for expenditure in FY 15 to fund an early childhood reading literacy program.
- S 257 LOW-INCOME, AT-RISK CHILDREN DANCE PROGRAM, *Sen. Morales* appropriates \$140,000 from the General Fund to the Children, Youth and Families Department for expenditure in FY 15 to provide low-income, at-risk children access to a best-practice, character-building youth dance program in partnership with local school districts statewide.
- S 258 SCHOOL TRANSPORTATION & TRIBAL LEADERS, *Sen. Muñoz* requires school districts with 75 percent or more of Native American students residing within their boundaries to consult with tribal leaders regarding certain public school transportation issues. [Related to S 278, S 320, CS/S 330, SJM 12a and H 169, H 308]
- S 259 EARLY CHILDHOOD CARE & EDUCATION, *Sen. Beffort* makes appropriations and amends the Early Childhood Education and Care Act in the Children's Code to add a definition for an "early childhood care and education system"; modifies the powers and duties of the State Early Learning Advisory Council to require the council to develop a legislative proposal for the system by November 1, 2014; appropriates a total of \$2.8 million through six separate appropriations from the General Fund to the Children, Youth and Families Department or the Higher Education Department for expenditure in FY 15 and, in some cases, FY 16. (For the Legislative Finance Committee)
- S 261 NORTHERN NM STATE SCHOOL VETERANS CENTER, *Sen. Martinez* appropriates \$105,000 from the General Fund to the Board of Regents of Northern New Mexico State School for expenditure in FY 15 to create a Veterans Center on the Española campus to assist veterans in the transition from military to civilian and student life.
- S 262 NORTHERN NM STATE SCHOOL SUPPLIES, *Sen. Martinez* appropriates \$85,000 from the General Fund to the Board of Regents of Northern New Mexico State School for expenditure in FY 15 to purchase instructional and classroom supplies and equipment.
- S 264 SCHOOL DISTRICT POLICE FORCES, *Sen. Neville* creates a new section in law enforcement statutes authorizing a school district to establish a police force with jurisdiction within the boundaries of the school district; requires specialized training; and requires a school district to report to the Public Education Department and the appropriate legislative interim committee on the operations of the police force within one year of establishment.
- \*S 265 LEGISLATIVE INTERIM CHILDREN'S COUNCIL, *Sen. Papen* creates the Children's Council as an interim legislative council from the date of appointment until December 1 prior to the 2015 legislative session; prescribes a membership of 16 members with staff provided by the Legislative Council Service (LCS); and appropriates \$75,000 from the General Fund to the LCS for expenditure in FY 14 and FY 15 to reimburse the per diem and mileage expenses of the Children's Council members and to pay other expenses.

- S 267 ENMU STUDENT SUPPORT, *Sen. Ingle* appropriates \$200,000 from the General Fund to the Board of Regents of Eastern New Mexico University for expenditure in FY 15 to design and implement a student support program that identifies and provides outreach to high-risk students.
- S 272 INCREASE MINIMUM SCHOOL INSTRUCTIONAL HOURS, *Sen. Cervantes* amends the Public School Code to increase the minimum instructional hours in a school year according to grade level and appropriates \$261.1 million from the General Fund to the State Equalization Guarantee for expenditure in FY 15 to provide for 20 additional instructional days. [Related to S 23aa, S 143, and H 81, H 86, H 220, H 271aa]
- S 273 ARTS EDUCATION, *Sen. Sapien* appropriates \$13,400 from the General Fund to the Cultural Affairs Department for expenditure in FY 15 for an arts education program that integrates literacy and theater for middle and high school students who attend public schools in Bernalillo, Sandoval, and Valencia counties.
- S 278 SCHOOL TRANSPORTATION BOUNDARY AGREEMENTS, *Sen. Muñoz* amends provisions in the Public School Code relating to school bus routes to require school districts with 75 percent or more of Native American students residing within their boundaries to consult with tribal leaders on issues related to public school transportation services; including transportation boundary disputes. [Related to S 258, S 320, CS/S 330, SJM 12a, and H 169, H 308]
- S 280 INTELLECTUAL DISABILITY STUDENT FRIENDSHIPS, *Sen. Morales* appropriates \$100,000 from the General Fund to the Public Education Department for expenditure in FY 15 to enhance programs in middle schools and high schools directed at fostering one-to-one friendships between students with and without intellectual and development disabilities and promoting inclusion in school climates.
- S 285 RAISE MINIMUM WAGE, *Sen. C. Sanchez* raises the minimum wage to \$8.00 per hour, effective January 1, 2015; and provides certain exceptions.
- S 293 CARLOS VIGIL MEMORAL ACT & PREVENT BULLYING, *Sen. Candelaria/ Rep. Smith* — creates the Carlos Vigil Memorial Act to help cultivate a school culture where bullying is unacceptable; creates the Carlos Vigil Memorial Board; creates the Eradicate Bullying Fund in the State Treasury to be administered by the Board of Regents at the University of New Mexico; and appropriates \$200,000 from the General Fund to the Eradicate Bullying Fund for expenditure in FY 15 and subsequent years to carry out the provisions of the act.
- S 294 NM ROBOTICS CAMP, *Sen. Pinto* appropriates \$60,000 from the General Fund to the Indian Education Division of the Public Education Department for expenditure in FY 15 to fund a New Mexico robotics camp.
- S 296 IMPLEMENTATION OF COMMON CORE STANDARDS, *Sen. Lopez* prohibits the Public Education Department (PED) from continuing to implement the Common Core Standards until certain requirements have been met; provides requirements for the adoption or revision of curricular standards; requires the state to withdraw from the

Partnership for Assessment of Readiness for College and Careers; prohibits the state from implementing assessments aligned to common core standards by the partnership; requires the state to use assessments in place before the adoption of the common core standards; prohibits the department from entering into certain agreements; requires public hearings and a fiscal analysis of implementation of common core standards; and appropriates \$50,000 from the General Fund to PED for expenditure in FY 15 to hold public meetings on implementation of common core standards.

- S 297 K-8 INTERVENTION & REMEDIATION, *Sen. Lopez* provides for improved intervention and remediation practices for grades K-8 and top to bottom accountability; includes definitions; and appropriates \$75.2 million from the General Fund to the State Equalization Guarantee distribution of the Public School Fund for expenditure in FY 15 to fund reading and mathematics intervention teachers for students in grades K-8 who are in need of intervention. [Related to S 45, and CS/H 93, H 259, H 295]
- S 298 GUADALUPE COUNTY EARLY CHILDHOOD PROGRAMS, *Sen. Campos* appropriates \$50,000 from the General Fund to the Local Government Division of the Department of Finance and Administration for expenditure in FY 15 to improve and expand early childhood education programs in Guadalupe County and in Anton Chico.
- S 302 REPEAL CAPITAL GAINS DEDUCTION, *Sen. M. Sanchez* repeals the capital gains deduction from net income effective January 1, 2015; and transfers \$3.0 million from the repeal of the capital gains savings to the Lottery Tuition Fund for five years until June 30, 2019. [Related to S 141, S 146, \*S 150, S 303, \*S 327, \*S 379, SM 23 and H 145, \*H 254a, \*H 263a, \*CS/H 348a, HM 37, HM 44]
- S 303 MOTOR VEHICLE TAX TO LOTTERY TUITION, *Sen. M. Sanchez* increases the motor vehicle excise tax to 3.75 percent; and provides for a 20 percent distribution of tax receipts to the Lottery Tuition Fund. [Related to S 141, S 146, \*S 150, S 302, \*S 327, \*S 379, SM 23 and H 145, \*H 254a, \*H 263a, \*CS/H 348a, HM 37, HM 44]
- S 307a SCHOOL DISTRICT P.E. & GRADUATION REQUIREMENT (Passed S/ Passed H), Sen. Cervantes — amends the graduation requirements in the Public School Code: to prohibit changes to the graduation requirements for a student from those specified in law at the time the student entered the ninth grade; and, with approval of each school district, to allow participation in marching band, an athletic team, or an athletic sport during the school day to count toward fulfillment of physical education graduation unit requirements. [Related to \*S 122aa, S 178, SJM 10]
- S 309 HIGHER ED. FACULTY PARITY ACT, *Sen. Morales* creates the Faculty Parity Act; provides certain benefits, including the state's educational retirement system, to adjunct and non-tenure track faculty at public postsecondary educational institutions; and creates the Faculty Restoration and Equity Fund in each public postsecondary educational institution, with a sufficient amount of the appropriations from the Legislature for instruction and general purposes to be transferred to the fund for FY 15 through FY 21.
- S 310a SCHOOL DISTRICT "LOCAL REVENUE," *Sen. Candelaria* amends the Public School Finance Act to expand the definition of "local revenue" for calculation of a school district's State Equalization Guarantee distribution.

S 313 GENERAL APPROPRIATIONS ACT OF 2014 (Passed S/Passed H), Sen. Smith —

CS/S 313a

appropriates approximately \$2.73 billion from the General Fund for public school support and related recurring appropriations, as well as \$15.1 million in nonrecurring appropriations; among its recurring provisions, provides \$2.5 billion to the state equalization guarantee (SEG) distribution (commonly referred to as above the line funding) to provide \$30.5 million for enrollment growth, fixed costs, and insurance costs (commonly referred to as opening the doors costs); an average 3.0 percent compensation increase for all school personnel; an additional average 3.0 percent compensation increase for education assistants; an increase in minimum teacher salaries by \$2,000 each for Level 1, Level 2, and Level 3; and funding to reestablish class size minimums, support at-risk students, provide adjustments to school districts with less than 200 students, and support teacher mentorship programs; also includes \$127 million in categorical public school support appropriations, including school transportation and an average 3.0 percent compensation increase for all transportation employees; also provides \$107 million recurring appropriations to PED, including \$11.8 million for the PED departmental budget and \$95.2 million for other PED education initiatives, including prekindergarten, K-3 Plus, and the early reading initiative; and allocates \$15.1 in nonrecurring funding for: the implementation of common core state standards, emergency support for school districts experiencing shortfalls, instructional materials, administration and supervision of interscholastic activities in New Mexico, and to ensure the state meets maintenance of effort requirements for special education in FY 14 and FY 15. [Related to CS/H 2 et al. and H 7]

- S 315a CHILD SEXUAL EXPLOITATION BY PROSTITUTION, *Sen. Candelaria* revises penalties for sexual exploitation of children 16 years of age or younger by prostitution to include a first-degree felony.
- S 319 STATE MINIMUM WAGE & ANNUAL INCREASES, Sen. Campos provides for a
- CS/S 319 minimum hourly wage rate of \$10.10 for state employees and for employees of state contractors of contracts valued at greater than \$60,000; and provides for the state minimum wage to increase annually at the rate of inflation. [Related to S 322]
  - **S 320 SCHOOL TRANSPORTATION BOUNDARY AGREEMENTS (Passed S/Passed H)**, *Sen. Muñoz* — amends provisions in the Public School Code related to school bus routes to school districts with 75 percent or more of Native American students residing within their boundaries to consult with tribal leaders on issues related to public school transportation services, including transportation boundary disputes. [Related to S 258, S 278, CS/S 330, SJM 12a and H 169, H 308]
  - S 322 STATE & STATE EDUCATION MINIMUM WAGE, *Sen. Campos* raises the minimum wage for employees of the state and state educational institutions to no less than \$10.10 per hour. [Related to CS/S 319]
  - S 325 NATIONAL MERIT SCHOLAR SCHOLARSHIPS, *Sen. Candelaria* establishes a scholarship program for National Merit Scholars, renewable each semester for four consecutive years; and provides award provisions.
  - S 326 READING SUCCESS ACT, *Sen. Sapien* creates the Reading Success Act within the

Public School Code and defines terms such as "intervention" and "reading proficiency"; requires baseline assessment data on reading proficiency for students; provides interventions and differentiated remediation measures for students who do not demonstrate reading proficiency; establishes reporting deadlines to the Public Education Department, with the department presenting to the LESC during the legislative interim; requires schools districts to maintain intervention files; and appropriates \$25.0 million from the General Fund to the State Equalization Guarantee for distribution in FY 15 to implement the Reading Success Act.

- \*S 327 LOTTERY TUITION FUND ACT & SOLVENCY, *Sen. Sapien* adds new material to current law to create the Lottery Tuition Fund Act; amends provisions relating to the Lottery Tuition Fund and the Community College Act; repeals three sections of current law in Chapter 21, State and Private Education Institutions; provides a definition of terms such as "legacy student" and "two-year branch institution"; changes the amounts of the awards beginning in FY 15; requires the boards of regents or governing bodies of public postsecondary institutions to award lottery tuition scholarships to qualified students and legacy students; and requires reports by the Higher Education Department to the Legislative Finance Committee and the Department of Finance and Administration by November 1 of each year. Pinto* amends CS/S 330 provisions in the Public School Code relating to school bus routes to authorize school districts to enter into transportation boundary agreements with adjoining school districts for students whose geographical conditions may make it impractical to transport these students to a school within the district where they live, and for students residing on Native American reservations. ## S 347 LOTTERY TUITION SCHOLARSHIP FUND SOLVENCY (Passed S/Passed H),

- \*CS/S 347a Sen. M. Sanchez makes changes to the Legislative Lottery Scholarship Program to extend its financial solvency and changes the requirements for and the amount of awards; requires a \$2.0 million minimum balance in the Lottery Tuition Fund; and distributes 39 percent from the Liquor Excise Tax to the Lottery Tuition Fund.
  - \*S 379 LOTTERY TUITION FUND SOLVENCY, *Sen. Payne* adds new material to current law to create the Legislative Lottery Scholarship Act; amends provisions relating to the Lottery Tuition Fund; repeals three sections of current law in Chapter 21, State and Private Education Institutions; defines a "qualified student"; distinguishes among various postsecondary institutions; and requires a board of regents or governing body of a public postsecondary institution to determine the quantity of legislative lottery scholarships to award and the award amounts for qualified students who meet eligibility requirements according to institutional needs, missions, and goals. information to the interim Legislative Health and Human Services Committee by November 2014.

- SJM 4a STUDY STATE BUILDING BROADBAND INFRASTRUCTURE (Passed S/ Passed H), Sen. Candelaria/Rep. Rodella — requests that a task force be convened to study appropriate ways for the state to participate in building broadband network infrastructure; that membership include representatives from the University of New Mexico, New Mexico State University, the New Mexico Institute of Mining and Technology, and New Mexico Highlands University; and that the Legislative Finance Committee, the Science, Technology and Telecommunications Committee, and the New Finance Authority Oversight Committee hear testimony and receive recommendations. - SJM 7 RETURN BLM LANDS TO LAND GRANTS, *Sen. Martinez* requests that the New Mexico congressional delegation work closely with the US Bureau of Land Management (BLM) to return lands under the current control of the BLM to New Mexico's historic land grants; also requests that the New Mexico congressional delegation not support legislation that would transfer to the US Forest Service lands currently under BLM control that were once part of land grant common lands. (For the Land Grant Committee)
- SJM 10 ASSESS ROLE OF SCHOOL P.E. IN CHILD OBESITY, *Sen. Candelaria* requests that the LESC create a task force to assess the role of elementary school physical education in reducing obesity in children and that the task force develop a plan for increased weekly instruction to improve children's fitness and provide a report to the LESC by October 1, 2014. (For the LESC) [Related to \*S 122aa, S 178, S 307aa]
- SJM 11a VISION FOR HIGH-QUALITY EDUCATION IN NM (Passed S/Passed H), Sen. Candelaria — recognizes a shared commitment to the vision of a high-quality public education system in New Mexico and renews the Legislature's commitment to New Mexico students, families, educators, and communities to focus resources and craft policies in a manner that moves New Mexico toward the shared vision of high-quality public education for all.
- SJM 12a STUDY TRANSPORTING SCHOOL STUDENTS (Passed S/Passed H), Sen. Woods

   requests that the Public Education Department (PED) develop and implement a two-year pilot program to study the fiscal and programmatic effects of transporting students between and among school districts to support school choice; and requests that PED report to the LESC and the Legislative Finance Committee before the 2017 legislative session. (For the LESC) [Related to S 258, S 278, S 320, CS/S 330 and H 169, H 308]
- SJM 13 STUDY BRANCH COMMUNITY COLLEGE STATUTES, *Sen. Campos* requests that the Higher Education Department, in conjunction with the Public Education Department, appoint a "branch community college task force" to review the adequacy, appropriateness, and alignment of branch and community college statutes, with recommendations to be presented to the appropriate legislative committees by December 1, 2014 for consideration by the 2015 Legislature.
- SJM 15 COMBINE ALL STATE INVESTMENT FUNCTIONS (**Passed S**), Sen. Beffort requests that the New Mexico Legislative Council authorize a contract for professional

services to study the feasibility and potential benefits of combining all state investment management and investment functions.

- SJM 17 BID & RFP TRAINING FOR STATE CONTRACTS, *Sen. Neville* requests that the Secretary of General Services develop guidance and secure qualified training for state and local public body employees on bids and requests proposals that will enable fair competition by New Mexico resident businesses and contractors. (May affect public schools)
- SJM 18 STANDARDIZED TEST FUNDS REPORT, *Sen. Candelaria/Rep. McCamley* requests that the Public Education Department report to the LESC by November 1, 2014 on funds spent on contracts for standardized tests; including documentation of the procurement process.
- SJM 25 STUDY UNM BRIDGE TO SUCCESS ELIGIBILITY, *Sen. Padilla* requests that the Higher Education Department (HED) study the eligibility requirements and effects of proposed changes to those requirements for the University of New Mexico's Bridge to Success Scholarship Program and for similar programs in other higher educational institutions; and requests that HED prepare a report of its recommendations to the LESC by November 1, 2014.

- SJR 2a BOARD & SUPERINTENDENT OF EDUCATION, CA, *Sen. Padilla* proposes an amendment to the Constitution of New Mexico to create a 13-member State Board of Education, with 10 elected and three appointed members, to make education policy and to appoint a Superintendent of Public Instruction to manage the Public Education Department. [Related to HJR 4]
- SJR 3 REQUIRE MESSAGES ON ALL VETOES, CA, *Sen. Candelaria* proposes an amendment to the Constitution of New Mexico to provide that all bills passed by the Legislature and not acted on by the Governor become law and to require veto messages on all bills vetoed by the Governor.
- SJR 4a LAND GRANT FUND CARE & INVESTMENTS, CA (**Passed S/Failed H**), Sen. Keller/ Rep. Larrañaga — proposes to amend the Constitution of New Mexico to preserve the Land Grant Permanent Fund by increasing the duty of care and removing the restrictions on the type of investment that may be made. (For the Investments and Pensions Oversight Committee)
- SJR 8a PUBLIC EDUCATION COMMISSION, CA, *Sen. Keller/Rep. MH García* proposes an amendment to the Constitution of New Mexico to establish duties and functions of the Public Education Commission, including sole authority to render an agency decision regarding applications for the establishment or renewal of charters for state-chartered charter schools and regarding the affirmation or revocation of charters for locally chartered charter schools.
- SJR 9 STATE ETHICS COMMISSION, CA, *Sen. Keller/Rep. Cook* proposes an amendment to the Constitution of New Mexico to create an independent state ethics commission to

oversee the conduct of state officers and employees in the executive and legislative branches of government, government contractors, and lobbyists.

SJR 12 LAND GRANT FUND BALANCE & EDUCATION, CA, *Sen. M. Sanchez* — proposes an amendment to the Constitution of New Mexico to establish a minimum balance of the Land Grant Permanent Fund to be maintained before any additional distributions are permitted; to extend the current 0.5 percent additional annual distribution beyond FY 16; and to provide a 1.5 percent additional annual distribution from the Permanent School Fund, starting in FY 17, for nonsectarian early childhood education programs administered by the state for the benefit of children before they are eligible to attend kindergarten.

### SJR 13a ANNUALLY INCREASING MINIMUM WAGE, CA (Passed S/Failed H),

*Sen. Martinez* — proposes an amendment to the Constitution of New Mexico to establish that the minimum wage will increase annually at the rate of inflation but will not increase more than 4.0 percent in any one year. [Related to HJR 9]

- SJR 15a NO NEW SCHOOL ACTIVITY WITHOUT FUNDING, CA, Sen. Ivey-Soto/Rep. Roch — proposes an amendment to the Constitution of New Mexico to prohibit state rules or regulations that mandate new or increased activity or service by school districts or charter schools from having the force of law unless funding for those mandates is provided.
- SJR 17 TWO-THIRDS TO AMEND CONSTITUTION, CA, *Sen. Ryan* proposes to amend the Constitution of New Mexico to require the approval of two-thirds of the members of each house of the Legislature for passage of proposed amendments to the Constitution.
- SJR 21 LEGISLATIVE POWER TO COMPEL WITNESSES, CA, Sen. Cervantes/Rep. Egolf proposes an amendment to the Constitution of New Mexico to give the Legislature and its committees the power to compel witnesses to attend legislative hearings, to require sworn testimony, and to compel persons to produce documents, electronically stored information, or tangible items.
- SJR 23 SEC. OF EDUCATION REQUIREMENTS, CA, *Sen. McSorley* proposes to amend the Constitution of New Mexico to require the Secretary of Public Education be an educator licensed in New Mexico. [Identical to HJR 13]

- SM 65 STUDY STATE WORKER COMPENSATION, *Sen. - **SM 69 EDUCATION OF CHILDREN IN JUVENILE JUSTICE (Passed S)**, *Sen.
