MEMORANDUM

TO: New Mexico Legislators

RE: **Summary of Public Education-related Legislation Passed by the Forty-seventh Legislature, Second Session, 2006** (*after executive action*)

The enclosed materials represent an overview of the 2006 legislative action related to public school support and other public education-related legislation – ***after executive action***.

Since the initial memorandum was issued on March 10, two events have taken place: (1) the Department of Finance and Administration has decided that the credits used in the calculation of the State Equalization Guarantee (federal impact aid, forest reserve, and .5 mill levy) will not be "sanded"; therefore, program cost has been adjusted to reflect an increase of \$61,400; and (2) the Public Education Department has set the 2006-2007 initial value at \$3,444.35, an increase of \$246.34, or 7.7 percent, over the current school year.

The 2006 legislative session may very well have been the busiest 30-day session ever. From the time legislative leaders in both chambers gavelled the session to order until adjournment, the work never slowed. During this time, the Legislature addressed a number of education-related issues, including capital outlay funding for public schools and changes to the way in which charter schools are authorized. But as always, the main emphasis of the 2006 Legislature was to ensure that the schools will have adequate funding to "open the school doors." In addition, the Legislature focused on funding an employee compensation package that includes employee salary increases; the next phase of the three-tiered licensure minimum salaries; the FY 07 increase in the employer's contribution to the Educational Retirement Fund; and the employer contribution for insurance increases.

This year, the Legislature passed two appropriation acts: the *General Appropriation Act of 2006* (CS/HB 2, et al., as amended), which contains the funding for public school support and for the Public Education Department (PED); and CS/SB 415, as amended, *State Agency Expenditures* (also known as “HB 2 Junior”), which includes several public education-related appropriations. Table 1 provides a summary of public school support and related appropriations in the *General Appropriation Act of 2006*. For FY 07, the Legislature appropriated approximately \$2.3 billion in public school support and related recurring appropriations, an increase of approximately \$163.6 million, or 7.7 percent, over the FY 06 appropriations – a greater increase in new dollars designated for education than the previous high of \$149.0 million appropriated by the 2001 Legislature. Please note that the public school support and related recurring appropriations, including the 5.0 percent salary increase, have been “sanded” (which means an across-the-board reduction) by 0.105 percent. Not sanded, however, is almost \$38.3 million in special nonrecurring appropriations also included in the bill.

The FY 07 statewide program cost of approximately \$2.2 billion represents an increase of about \$147.7 million, or 7.3 percent, over the appropriation for the current school year. Among the initiatives included in the program cost are sufficient dollars to fund enrollment growth and increases for insurance and fixed costs, as well as:

- a mandatory average 5.0 percent salary increase for all school employees other than educational assistants, for whom a mandatory average 9.5 percent salary increase is included;
- the 0.75 percent increase in the employer’s contribution to the Educational Retirement Fund for FY 07 (an additional 0.75 percent to accelerate the employer’s contribution for FY 08 that was included as a related recurring appropriation was **vetoed** by the Governor);
- full funding for elementary fine arts programs at a 1.0 student FTE; and
- funding for the \$45,000 minimum salary for Level 3-A teachers to implement the fourth year of the five-year phase-in of the three-tiered licensure system. In addition, language is included in the *General Appropriation Act of 2006* to require school districts and charter schools to provide the salary increases for teachers before implementing the minimum salary.

Table 2 summarizes additional public education-related appropriations in “HB 2 Junior,” including \$799,000 to PED for a variety of programs, among them funds to PED to establish a Math and Science Bureau and \$1.5 million to other state agencies for various programs.

Table 3 provides a summary of direct capital outlay appropriations to PED and other agencies for public education-related projects. CS/HB 622, *Severance Tax Bond Projects* (with emergency clause), appropriates approximately \$140.2 million for public school capital outlay needs, including almost \$119.2 million in nonrecurring General Fund dollars and approximately \$21.0 million in Severance Tax Bonds. Of the \$140.2 million in direct appropriations, about \$40.0 million is for specific school district and charter school projects and \$100.2 million is for statewide projects.

Among the legislation endorsed by the Legislative Education Study Committee (LESC) and signed by the Governor is HB 42, as amended, *Extend Funding Formula Task Force*, which extends the term of the Funding Formula Task Force until December 15, 2007 and adds a new member from a statewide teacher organization appointed by the Legislative Council.

The *General Appropriation Act of 2006* includes a special appropriation of \$500,000 to the Legislative Council to pay costs associated with the task force and with the study, including contracting with an individual or individuals selected by the task force to conduct a formula study.

One other bill that was signed into law and is likely to have an impact on K-12 public education in New Mexico and on PED is FL/CS/SB 600, *Education Dept. Charter Schools Division*, which creates the Charter Schools Division in PED and allows dual chartering authorizers—the Public Education Commission and local school boards, thereby giving charter applicants a choice. The bill also amends the *Public School Finance Act* to require state-chartered schools to be their own boards of finance and to make charter school financial operations in general equivalent to school district operations. In addition, the bill contains numerous provisions affecting the application for and renewal of charters, as well as governance and facilities. Finally, the bill charges the Public School Capital Outlay Oversight Task Force to study the provisions in statute governing the funding of charter school capital outlay facilities, transportation costs, and other capital outlay issues concerning charter schools and to report to the LESC, the Legislative Finance Committee (LFC), and the Governor by November 1, 2006, well in advance of the bill's effective date of July 1, 2007.

The major capital outlay needs of school districts and charter schools are addressed in CS/SB 450, as amended, *Public School Capital Outlay Omnibus Bill* (with emergency clause), which was endorsed by the LESC and includes the recommendations of the Public School Capital Outlay Oversight Task Force. Among its many provisions, the bill:

- raises the statutory limits on the amount of cash balance that a school district or charter school may retain before the state takes credit for some or all of its remaining cash balance and allows the Secretary of Public Education to waive all or a portion of the cash balance credit if a school district's excess cash balance is needed to provide the local match required under the *Public School Capital Outlay Act* or to recoup an amount paid as the district's share for "qualified high priority projects";
- creates the New School Development Fund to provide for certain one-time costs associated with the first year of operation of a new school (no money was appropriated to the fund for FY 07);
- extends the lease payment assistance program through 2010 (current law specifies 2009) and increases funding for the program from \$4.0 million to \$7.5 million in order to fully fund the assistance amount of \$600 per MEM;
- creates a local share advance program designed to provide immediate financing for "qualified high priority projects" but requires the district to pay its share of funding under this program, including any direct appropriation offsets, prior to the allocation of future Public School Capital Outlay Council (PSCOC) project awards and to use its local resources to bring otherwise PSCOC-eligible projects up to the required adequacy standards until the district's share is paid (a separate appropriation of \$90.0 million is included in CS/HB 622); and
- appropriates funding for the statewide facility information management system and for the indoor air quality program in public schools.

Provisions in CS/SB 450, as amended, that the Governor **vetoed** include:

- the increase of the state guarantee in the *Public School Capital Improvements Act* (2.0 mill levy) from \$60 per unit per mill in current law to \$90 per unit per mill in FY 07;
- the School District Revenue Impact Study Group which would have examined the relationship and interaction between school districts and local government, with an emphasis on the financial impact of actions taken by local government on school districts;
- an appropriation of \$50,000 to fund the impact study; and
- language that would have allowed all districts to participate in the local share advance program for “qualified high priority projects.”

Finally, for public school libraries, in CS/SB 301, as amended, *2006 Capital Projects G.O. Bond Act* (with emergency clause), the Legislature appropriated \$3.0 million in General Obligation Bonds, which will require voter approval at the November 2006 general election. Language in the bill requires the Secretary of Public Education to provide a base amount of \$3,000 per eligible library and to distribute the remaining balance on a per-membership basis to support the acquisition of new, updated materials for public school libraries (including juvenile detention center libraries).

OTHER EDUCATION (Section 4, I)

The general fund appropriation to the public education department in the other category includes five hundred thousand dollars (\$500,000) for a charter school authority, contingent on the enactment of House Bill 630 or similar legislation of the second session of the forty-seventh legislature.

SEVERANCE TAX BONDS—AUTHORIZATIONS—APPROPRIATION OF PROCEEDS. (Section 1)

- A. The state board of finance may issue and sell severance tax bonds in compliance with the Severance Tax Bonding Act in an amount not to exceed the total of the amounts authorized for purposes specified in this act. The state board of finance shall schedule the issuance and sale of the bonds in the most expeditious and economical manner possible upon a finding by the board that the project has been developed sufficiently to justify the issuance and that the project can proceed to contract within a reasonable time. The state board of finance shall further take the appropriate steps necessary to comply with the Internal Revenue Code of 1986, as amended. Proceeds from the sale of the bonds are appropriated for the purposes specified in this act.
- B. The agencies named in this act shall certify to the state board of finance when the money from the proceeds of the severance tax bonds authorized in this section is needed for the purposes specified in the applicable section of this act. If an agency has not certified the need for the issuance of the bonds for a particular project, including projects that have been reauthorized, by the end of fiscal year 2008, the authorization for that project is void.
- C. Before an agency may certify for the issuance of severance tax bonds, the project must be developed sufficiently so that the agency reasonably expects to:
 - (1) incur within six months after the applicable bonds have been issued a substantial binding obligation to a third party to expend at least five percent of the bond proceeds for the project; and
 - (2) spend at least eighty-five percent of the bond proceeds within three years after the applicable bonds have been issued.
- D. Except as otherwise provided in this section or another section of this act, the unexpended balance from the proceeds of severance tax bonds issued for a project, including projects that have been reauthorized, shall revert to the severance tax bonding fund as follows:
 - (1) for projects for which severance tax bonds were issued to match federal grants, six months after completion of the project;
 - (2) for projects for which severance tax bonds were issued to purchase vehicles, emergency vehicles or other vehicles that require special equipment, heavy equipment, educational technology or other equipment or furniture that is not related to a more inclusive construction or renovation project, at the end of the fiscal year two years following the fiscal year in which the severance tax bonds were issued for the purchase; and
 - (3) for all other projects for which severance tax bonds were issued, within six months of completion of the project, but no later than the end of fiscal year 2010.
- E. Except for appropriations to the capital program fund, money from severance tax bond proceeds provided pursuant to this act shall not be used to pay indirect project costs.
- F. For the purpose of this section, “unexpended balance” means the remainder of an appropriation after reserving for unpaid costs and expenses covered by binding written obligations to third parties.

GENERAL FUND AND OTHER FUND APPROPRIATIONS—LIMITATIONS—REVERSIONS. (Section 2)

- A. Except as otherwise provided in this section or another section of this act, the unexpended balance of an appropriation made in this act from the general fund or other state fund, including changes to prior appropriations, shall revert to the originating fund as follows:
- (1) for projects for which appropriations were made to match federal grants, six months after completion of the project;
 - (2) for projects for which appropriations were made to purchase vehicles, emergency vehicles or other vehicles that require special equipment, heavy equipment, educational technology or equipment or furniture that is not related to a more inclusive construction or renovation project, at the end of the fiscal year two years following the fiscal year in which the appropriation was made for the purchase; and
 - (3) for all other projects for which appropriations were made, within six months of completion of the project, but no later than the end of fiscal year 2010.
- B. Upon certification by an agency that money from the general fund is needed for a purpose specified in this act, the secretary of finance and administration shall disburse such amount of the appropriation for that project as is necessary to meet that need.
- C. Except for appropriations to the capital program fund, money from appropriations made in this act shall not be used to pay indirect project costs.
- D. For the purpose of this section, “unexpended balance” means the remainder of an appropriation after reserving for unpaid costs and expenses covered by binding written obligations to third parties.

PROJECTS. (Section 10)

The proceeds from the sale of bonds issued under the provisions of the 2006 Capital Projects General Obligation Bond Act shall be distributed as follows for the purposes and in the amounts specified:

Any bonds issued under that act shall be issued within thirty months from the date of such election.

B. The ballots used at the 2006 general election shall contain substantially the following language:

- (3) “The 2006 Capital Projects General Obligation Bond Act authorizes the issuance and sale of public library acquisition bonds. Shall the state be authorized to issue general obligation bonds in an amount not to exceed nine million ninety thousand dollars (\$9,090,000) to make capital expenditures for public library acquisitions and provide for a general property tax imposition and levy for the payment of principal of, interest on and expenses incurred in connection with the issuance of the bonds and the collection of the tax as permitted by law?

CAPITAL PROJECT APPROPRIATIONS WITH A FISCAL YEAR 2006 REVERSION—EXTEND TIME. (Section 3)

The time of expenditure for any capital project appropriation otherwise scheduled for reversion at the end of fiscal year 2006 is extended through fiscal year 2007.

***CS/S 301a** the 2006 Capital Projects General Obligation Bond Act; authorizes the issuance and sale of capital projects general obligation bonds for several purposes, including \$3.0 million to acquire library books, equipment, and library resources for eligible public school and juvenile detention libraries; and requires the Secretary of Public Education to distribute funds by providing a base amount of \$3,000 per library and the remaining balance on a per-membership basis.
- S 344a** **CONTRIBUTIONS BY PROCUREMENT CONTRACTORS, SGND (Mar. 6) Ch. 81**, *Feldman* — adds a new section to the Procurement Code to prohibit certain campaign contributions from contractors and their family members to public officials, including appointees to the State Board of Finance, and to require disclosure of certain other contributions. FL/CS/S 600 its provisions, makes the PEC a chartering authority in addition to local school boards;
creates the Charter Schools Division in PED and prescribes its duties; amends the Public
School Finance Act to require state-chartered schools to be their own boards of finance and
to use the same program cost calculation for locally chartered and state-chartered schools;
amends transportation statutes to apply to charter schools; amends the Public School Capital
