June 2016 Quarterly Update

Ouarterly Status of Outstanding Capital Funds

- As of June 2016, approximately \$773.2 million from all funding sources for 2,386 projects remains outstanding including \$116.5 million of earmarked fund balances for water (\$60.7 million), colonias (\$30.3 million), and tribal (\$25.5 million) infrastructure projects; approximately \$374.2 million remains outstanding from supplemental severance tax bonds for public schools.
- The September quarterly report will include an update on 67 state projects funded or reauthorized in 2016 from STB and OSF totaling nearly \$117.2.
- Since the March 2016 quarterly report, 203 projects closed with approximately \$82 million expended or reverted.
- Percentage of outstanding funding sources: general fund (GF) 4.6 percent (\$22.5 million authorized to the state road fund), severance tax bonds (STB) 57.7 percent, general obligation bonds (GOB) 22.8 percent, and other state funds (OSF) 14.9 percent.

• Public Libraries (\$3 million) and Tribal Libraries (\$750 thousand) spent over 99 percent of their 2012 GOB allocation.

Highlights of Select Projects – No Activity

Miners' Colfax Medical Center

• \$5.5 million authorized from the Miners Trust Fund, and appropriated in 2013, 2014, and 2015 have not been updated for the last three quarters. Miner's Colfax Medical Center is on the State Auditor's "At-Risk" list for late reporting as of July 13, 2016.

New Mexico Environment Department

• \$3.7 million (STB) appropriated in 2014 for the Camino Real Regional Utility Authority (CRRUA) wastewater treatment system has not had activity since December 2015. The project is delayed, according to the US Environment Protection Agency (EPA) website, pending an EPA administrative order in response to violations, including, but not limited to, "poor operation and maintenance, inadequate staffing, no notice of new/changed discharge, failure to request a permit modification for additional outfall, and failure to apply for a permit." Additional, required funding from the EPA and the Border Economic Cooperation Commission totaling \$8 million is pending approval from EPA before the project can move forward.

Office of Military Base Planning and Support

• \$800,000 (STB) of \$5 million originally authorized in 2006 remains unexpended and time was extended in 2016 to allow Cannon Air Force Base time to apply for Department of Defense funds to purchase easements in Melrose.

Highlights of Select Projects – Slow or Little Progress

New Mexico Environment Department

• \$1 million (STB) appropriated in 2014 for the Maxwell water well improvements, stalled due to non-compliance with Executive Order 2013-006. Over the last quarter, Colfax County has agreed to serve as their fiscal agent. Once the agreement is finalized, the project will move forward.

Spaceport Authority

• \$3 million (STB) appropriated in 2013, and \$6.4 million (STB) appropriated in 2014, for the southern access road, design is complete. The Spaceport Authority (SA) is awaiting BLM and state agency approvals of environmental assessments. The acquisition of two parcels of land located in Dona Ana and Sierra Counties is underway. Construction is anticipated to commence November 2017. NMDOT must approve the plans in order for the state to accept the new road into their inventory. An MOU between SA, Dona Ana County (DAC), and Sierra County is in process and will memorialize the following: DAC will be responsible for designing the roads (at their expense) and overseeing construction; SA will be responsible for the environmental assessment, mitigation and construction; and both counties, after construction is complete, will provide road maintenance.

Local Government Division and the Administrative Office of the Courts

• \$2 million (STB) authorized in 2013 and 2014 for the Mora County Complex is ready to proceed with completion of the interior of the first floor pending the NM Finance Authority Board approval of a \$2.2 million loan from the public project revolving loan fund at its August meeting.

2014 Water Initiative Status (Attachment A)

- \$83.5 million was authorized for water projects statewide in the 2014 capital outlay bill.
- \$60.4 million, or 72 percent, remains unexpended.
- \$33 million for 87 projects have no expenditures.
- Of the 191 water projects funded, only 37 have been completed.
- Seven projects closed in the last quarter of FY 2016, including a water plant improvement project in Tularosa and water system upgrades for the El Dorado Area Water Sanitation District.

<u>Authorized but Unissued Status</u> (Attachment B)

- Following the July 19, 2016, bond sale, 115 projects authorized for nearly \$21.9 million remain unissued.
- Of the amounts authorized in previous years, 17 projects totaling nearly \$4.6 million were not certified within two years, and the funds reverted; including \$3 million for the Drug and Substance Abuse Treatment Facility in Los Lunas.
- Due to noncompliance with Executive Order 2013-006, 22 entities in 12 counties are "ineligible" for bond issuance resulting in 26 projects totaling nearly \$1.6 million being stalled. The majority of projects are for water systems (8) and acequias (9).



2014 Water Initiative Status Update Fourth Quarter, Fiscal Year 2016

Over \$60 million of 2014 capital outlay appropriations for water storage, delivery, and treatment projects remains unspent. State agencies and local governments received \$83.5 for 191 projects, an additional \$2.3 million was appropriated for two fund transfers and bonds have not been sold for seven projects totaling \$426 thousand. Nearly \$33 million is dedicated to 87 inactive projects on which not a single penny has been expended. While 37, or 19 percent, of the 191 projects are complete, these represent just 7 percent of the total appropriations. Seven projects were closed out in the fourth quarter of FY16, including a \$120 thousand water plant improvement in Tularosa and \$282 thousand in system upgrades to the Eldorado Area Water Sanitation District.

The Energy, Minerals and Natural Resources Department (EMNRD) received \$6.2 million for forest thinning and watershed restoration and has made significant progress in spending the funds by taking a proactive approach and setting up grant agreements and working with other partners before the funds were received. To date, the agency has spent over \$4.3 million, nearly 70 percent, of the appropriation, including over \$370 thousand in the fourth quarter of FY16.

Nearly three-quarters of the projects are overseen by the New Mexico Environment Department (NMED). At the July 2016 Legislative Finance Committee meeting in Ruidoso, NMED officials stated much of the slow progress was due to the fact that many of the projects did not have complete plans or designs when the funds were appropriated. Only 20 percent of the NMED overseen projects are complete and almost half, totaling \$25.3 million, are still inactive.

A \$1.4 million drinking water system improvement in Rio Rancho is the sole appropriation greater than \$1 million to close. Of the \$58.2 million appropriated to 22 large projects, six have yet to begin expending funds, including two projects for the Camino Real Regional Utility Authority totaling \$5.45 million. This does not include slow progress on the \$8 million appropriated for the Chama wastewater treatment plant and \$10 million appropriated for Bradner Dam, both of which spent less than \$1 million in the two years since bonds were sold to fund the projects. The project to expand Bradner Dam has been abandoned and Las Vegas now plans to use the funds to repair the dam. In the two years since the appropriation, \$806 thousand was spent on now abandoned planning. Reauthorization or repurposing will likely be necessary because the 2014 appropriation will expire on June 30, 2018.

In addition to capital outlay appropriations, the Water Trust Board (WTB) awarded \$33 million to 22 projects in 2014 and nearly \$17 million remains unspent. Of the \$96.8 million WTB awarded from 2012 -2014, \$31.5 million, or 33 percent, is unspent. Awards to the Eastern New Mexico Water Utility Authority (ENMWUA) for the Ute pipeline during that period total \$11 million and make up 8.2 percent of the outstanding balance. The next three phases of the project are estimated to cost \$90 million and 90 percent of this is unsecured. ENMWUA received an additional \$3.2 million from WTB in 2015-2016 and hopes to hold existing awards and compile additional grants and loans, state and federal, to fund project construction in phases that take advantage of economies of scale.
