**Local Projects Update, May 2022** 



# Over \$1 billion was appropriated to local projects from 2018 to 2021

Consecutive years of strong state revenues have provided a significant boost for local capital projects, which are funded by various sources depending on annual capacity and are sponsored by individual legislators and the governor. Approximately 66 percent of the \$1 billion appropriated to local projects from 2018 to 2021 remained unspent as of March 2022. Clearing this backlog must be a priority for state and local governments in order to allow communities to take advantage of additional state and federal dollars that will be available in coming years to meet critical infrastructure needs.

### **Highlights:**

- As of March 2022, there were 2,634 outstanding local projects authorized between 2018 and 2021. Outstanding balances totaled \$706.3 million.
- The number of outstanding local projects represents a 35 percent increase over the previous year. Outstanding balances rose by 30 percent.
- An estimated \$418 million was appropriated to roughly 1,200 additional local projects in the 2022 session. When those projects come online after the June 2022 bond sale, the total number outstanding will approach 4,000.
- 2018-2021 local capital appropriations fell into several major categories:
  - Water, wastewater, solid waste, and utility projects received the greatest number of appropriations and share of funding, with \$201.3 million appropriated to 684 projects.
  - o Community facilities received \$173.9 million to 387 projects.
  - Highways, roads, and bridges received \$159.1 million to 362 projects.
  - Law enforcement and public safety received \$103.9 million to 223 projects.
  - o Parks and recreation received \$91.4 million to 302 projects.



#### **Attachment A. Outstanding Local Appropriations by County**

Attachment A is a summary by county for all 2,634 outstanding local capital outlay appropriations. Outstanding balances total \$706.3 million, or 79 percent of the funds appropriated to these projects. Counties highlighted in red have a high percentage of unspent funds.

- Of outstanding funds authorized in 2018, six counties had at least 75 percent unspent: Catron, Colfax, Lea, McKinley, San Juan, and Taos. Appropriations to projects in multiple counties also had at least 75 percent unspent.
- Of outstanding funds authorized in 2019, seven counties had at least 75 percent unspent: Cibola, Lea, Los Alamos, McKinley, Quay, San Miguel, and Socorro.
- Of outstanding funds authorized in 2020, nine counties had at least 90 percent unspent: Cibola, Dona Ana, Grant, Harding, Lincoln, Los Alamos, San Miguel, Santa Fe, and Sierra.
- Of outstanding funds authorized in 2021, 29 counties had at least 95 percent unspent. The only four counties with active local appropriations with more than 5 percent spent were Colfax, Guadalupe, Quay, and Socorro.

## Attachment B. Outstanding Local Appropriations, \$250,000 - \$999,999

Attachment B lists the 590 projects LFC tracked as of March 2022 funded for at least \$250 thousand but less than \$1 million. A total of \$283 million was appropriated to these projects, of which \$208.8 million (74 percent) remains unspent.

Sixty-two of these projects coded blue were fully expended or reverted, and the appropriations are considered complete. Another 221 projects are coded green and considered on schedule, 181 projects are coded yellow, indicating they are behind schedule or progressing slowly, and 156 projects are coded red due to minimal activity, funds being reauthorized, significant obstacles to completion, or no reporting. Blue and red projects are summarized at the end of this memo.

#### **Key Issues Going Forward**

- The state financing landscape remains fragmented, uncoordinated and difficult to navigate. It also lacks a cohesive strategy.
- Local governments, state agencies, and the private sector have limited capacity to take on additional projects or to prepare new projects for construction.
- Newly authorized capital outlay projects may therefore take more time than usual to reach completion.
- Providing partial funding to more projects will further strain the system's capacity and delay the delivery of public benefits.
- Projects that take longer to progress are more vulnerable to cost overruns.
- Federal infrastructure funds present New Mexico with a historic opportunity but communities face barriers to access, including:
  - O A significant gap in understanding about how to access the funds or how to choose among many funding opportunities
  - O Lack of clarity on eligibility and requirements
  - Limited staff at the state-level dedicated to coordinating funding opportunities and providing support to local governments, and a lack of pre-existing statewide infrastructure planning
  - Limited matching funds
  - O Limited administrative and technical capacity at the local and regional levels, exacerbated by staff turnover

This interim, LFC staff will provide members of the capital outlay subcommittee with additional analysis on these issues as well as a menu of potential remedies. Those could include opportunities for the state to provide centralized coordination and navigation of funding streams; opportunities to right-size support for local projects within state agencies; opportunities to increase support capacity within councils of government; revisions to the capital outlay request form to provide members with additional information on project status prior to funding; providing matching assistance for federal grants based on need; set-asides for cost overruns or for particular priority project types.

Many of the issues that make it challenging for New Mexico to effectively capitalize on the increased funding available for infrastructure are not new. LFC briefs and reports dating back at least 20 years have highlighted the need to better prioritize and coordinate the allocation of capital funds, to fully fund new projects, and to ensure projects the state has already invested in are completed and put into service for the public. While some progress has been made, these fundamental issues remain in need of solutions.

# Attachment C. LFC Vetting Guidelines for Local Capital Outlay Requests and DFA Grant Updates.

Attachment C is a resource guide, including a recommended vetting checklist for local requests and updates on new grant programs. The questions on the vetting checklist are intended to provide insight into how ready projects are to proceed to construction, how realistic requested amounts are for completing projects, the significance of the need the project would address, the local entity's commitment to the project, and the nature of the entity's need for grant assistance. While projects may not check all the boxes on this list, the more boxes they check, the higher they should rise on a funding priority list.

Attachment C also includes the current status and eligibilities for several new grant programs administered by the Department of Finance and Administration. These include grants to fund capital projects related to outdoor recreation and food insecurity, and grants to support local governments in applying for federal infrastructure grants.
