Capital Outlay

Local Projects Update, September 2022



Highlights:

- Approximately \$1.4 billion was appropriated to 4,700 local capital projects from 2018 to 2022, with 72 percent (\$1 billion) unspent as of June 2022. These totals include an estimated 250 reauthorized projects.
- As of June 2022, there were 3,649 outstanding local projects, about 67 percent of which (2,453) were funded for less than \$250 thousand; specific updates on these projects may be accessed through the Capital Project Monitoring System. Projects authorized for between \$250 thousand and \$999 thousand are tracked in **Attachment B**, which now includes 2022 projects sold in the June bond sale. Local projects funded for more than \$1 million were tracked in LFC's August quarterly report.
- The number of outstanding local projects increased an estimated 27 percent over last year and balances increased an estimated 29 percent.
- The Board of Finance split the severance tax bond sale for new projects into two issuances due to market conditions; 2022 projects that did not sell in June will be added to **Attachment B** in the next report.
- Local capital appropriations from 2018 to 2022 fell into several major categories:
 - Water, wastewater, dams, acequias, solid waste, and utility projects received the greatest number of appropriations and share of funding, with \$292.6 million (21 percent) appropriated to 1,017 projects.
 - Community facilities received \$202.9 (14 percent) million to 457 projects.
 - Highways, roads, and bridges received \$200.4 million (14 percent) to 463 projects.
 - Law enforcement and public safety received \$137.2 (10 percent) million to 302 projects.
 - Parks and recreation received \$125 million (9 percent) to 417 projects.

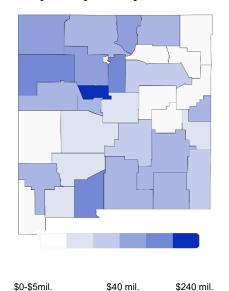
"Local" capital projects are funded by various sources depending on annual capacity and are sponsored by individual legislators and the governor.

Attachment A. Outstanding Local Appropriations by County

Attachment A is a summary by county for all 3,649 outstanding local capital outlay appropriations. Outstanding balances total \$1.04 billion or 84 percent of the funds appropriated to these projects. Counties highlighted in red have a high percentage of unspent funds.

- Of outstanding funds authorized in 2018, seven counties had at least 75 percent unspent: Catron, Cibola, Colfax, McKinley, San Juan, Santa Fe, and Taos. Appropriations to projects in multiple counties also had at least 75 percent unspent.
- Of outstanding funds authorized in 2019, six counties had at least 75
 percent unspent: Cibola, Lea, Los Alamos, McKinley, Quay, and
 Socorro.
- Of outstanding funds authorized in 2020, six counties had at least 90 percent unspent: Doña Ana, Grant, Harding, Lincoln, Los Alamos, and San Miguel.
- Of outstanding funds authorized in 2021, 17 counties had at least 95 percent unspent. The only six counties had spent more than 10 percent of their active appropriations: Chaves, Colfax, Guadalupe, Luna, Quay, and Socorro.

Attachment B. Outstanding Local Appropriations, \$250,000 - \$999,999

Attachment B lists the 653 projects LFC staff tracked as of June 2022 funded for at least \$250 thousand but less than \$1 million. A total of \$300.3 million was appropriated to these projects, of which \$237.5 million (79 percent) remains unspent.

- Fourteen projects totaling \$5.8 million are coded blue and were fully expended or reverted, and the appropriations are considered complete. Blue projects are summarized in **Table 2** on page 3;
- 298 projects are coded green and considered on schedule;
- 212 projects are coded yellow, indicating they are behind schedule or progressing slowly;
- 129 projects totaling \$61.7 million with \$51.7 million in unexpended balances are coded red due to minimal activity, funds being reauthorized, significant obstacles to completion, or no reporting. Red projects are summarized in **Table 3** on page 4;
- Red projects include \$963 thousand for courthouse renovations in Lea County; \$936,300 for water system improvements in Abiquiu MDWCA & MSWA; \$853 thousand for supportive housing in Santa Fe; \$800 thousand for stabilization of Southern Sandoval County Arroyo Flood Control Authority; \$862 thousand for road improvements on Navajo Nation; and \$690 thousand to construct a wastewater reuse facility in Albuquerque Bernalillo County Water Utility Authority.
