

NEW MEXICO LEGISLATIVE INTERNSHIP PROGRAM — 2009

The New Mexico Legislature invites applicants for two internship positions. Interns will be assigned to the Legislative Council Service, the Legislative Education Study Committee or the Legislative Finance Committee.

The purpose of the New Mexico Legislative Internship Program is to educate interested students about the state legislature and to provide practical experience in the day-to-day staff work for New Mexico's citizen-legislature. Interns will provide staff support to interim legislative committees that study various public policies. Work performed by interns may include legal and policy research, issues analyses, speechwriting, budget analysis and committee organization.

Each intern will receive a stipend of \$9,000, to be paid biweekly, and will be reimbursed for expenses incurred while traveling with interim legislative committees. The internships are full time and will last from July 1 through December 31, 2009. An intern's work day will generally commence at 8:00 a.m. and end at 5:00 p.m.

All applicants must be full-time, degree-seeking undergraduate or graduate students at one of New Mexico's four-year post-secondary educational institutions: Eastern New Mexico University, New Mexico Highlands University, New Mexico Institute of Mining and Technology, New Mexico State University, University of New Mexico or Western New Mexico University. Students receiving degrees in 2009 are eligible for the program. It is anticipated that each institution will develop a cooperative education written agreement with an intern and will decide whether academic credit will be awarded for successful completion of the New Mexico Legislative Internship Program.

Applicants must submit a cover letter, or an accompanying essay of no more than 500 words, explaining why the applicant is seeking the internship; a résumé; and a transcript (an unofficial copy will suffice) of college courses. Failure to provide the requested documents will result in disqualification of an applicant.
