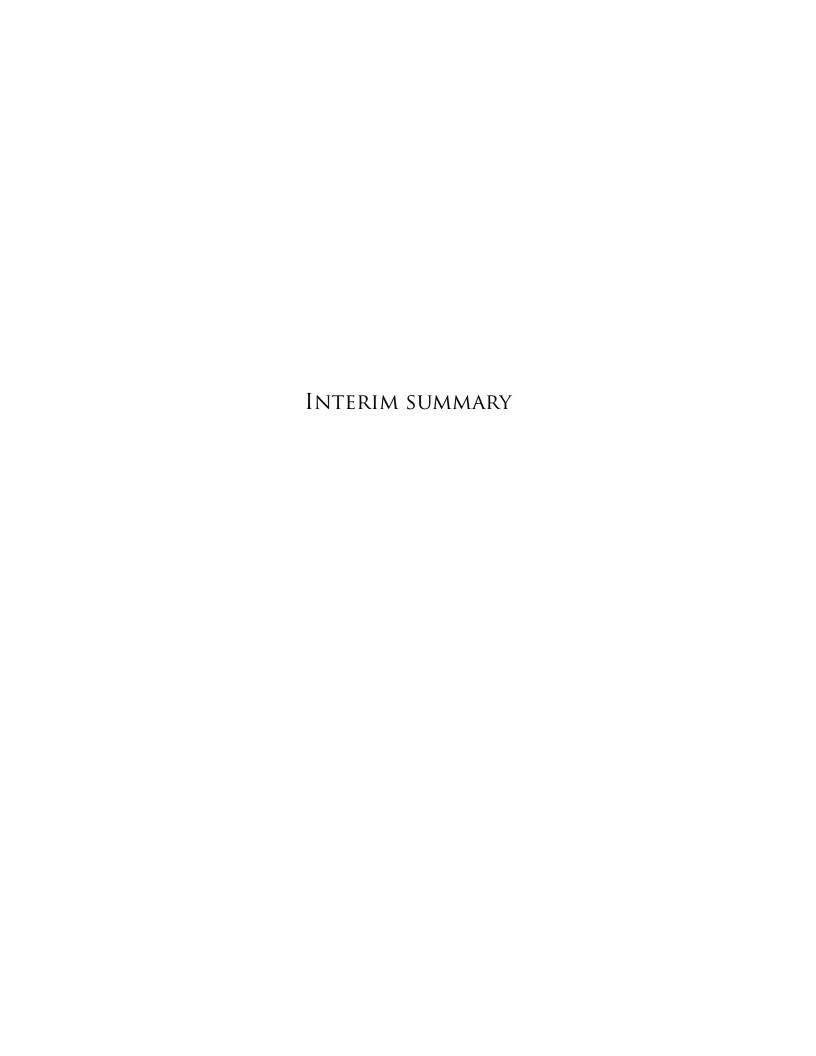

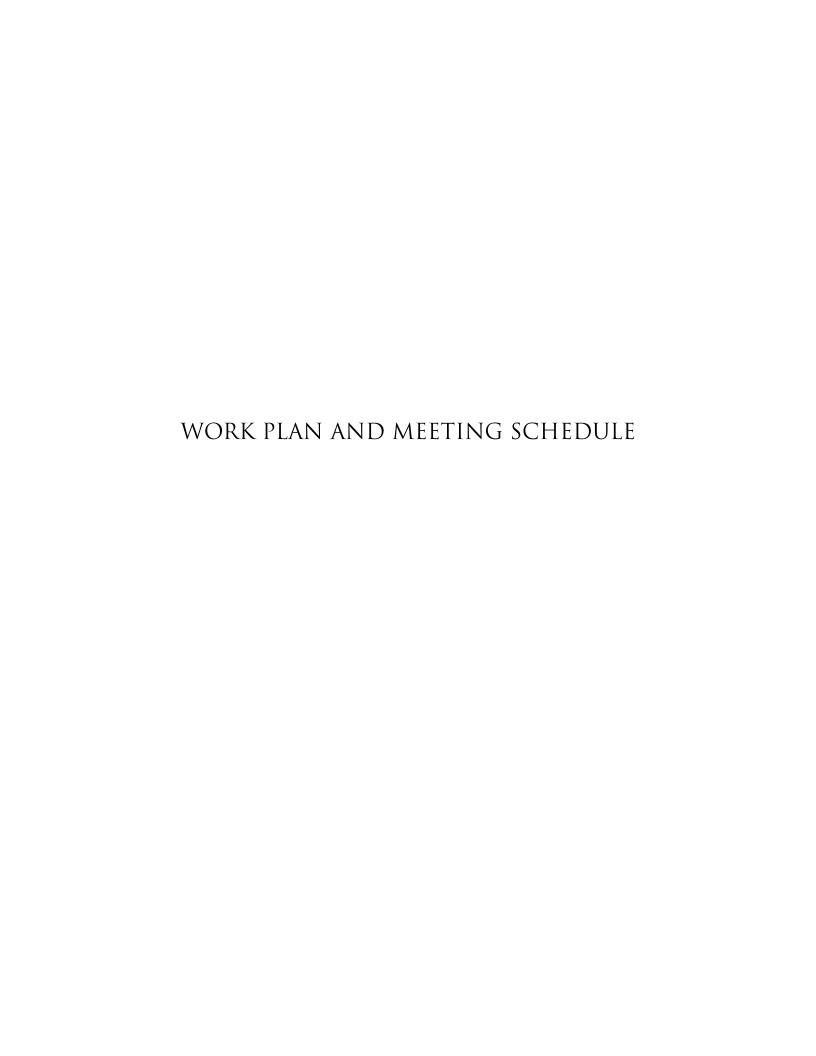


Economic and Rural Development and Policy Committee 2025 Interim Summary

The Economic and Rural Development and Policy Committee was created by the New Mexico Legislative Council on April 28, 2025 for the 2025 interim. The committee met five times, twice at the State Capitol and thrice in communities around the state. The committee traveled to Mescalero and Corona, Los Lunas and Farmington. The committee planned to meet in Gallup, but that meeting was canceled because it conflicted with the first special session of the fifty-seventh legislature.

During the 2025 interim, the committee heard presentations on issues facing rural communities in New Mexico. Topics included economic pathways through forest restoration and water management; the development of energy economies, such as wind and geothermal energy; housing affordability; and agriculture and food systems economies. The committee also heard reports on local economic development initiatives and challenges from the host cities and surrounding communities.

Other presentation topics explored by the committee included workforce education and development; international trade initiatives; security system use by businesses; outdoor recreation; creative and cultural industries; economic support for survivors of gender-based violence; trade ports in McKinley and Bernalillo counties; and libraries' role in rural New Mexico.

Work Plan

The Economic and Rural Development and Policy Committee (ERDPC) was created by the New Mexico Legislative Council on April 28, 2025. During the 2025 interim, and as time permits, the ERDPC will explore and discuss major areas and specific issues affecting rural economic development and policy as follows:

- 7. the New Mexico Finance Authority;
- 8. the New Mexico Mortgage Finance Authority;
- 9. the General Services Department;
- 10. the Department of Environment;

- 13. the Early Childhood Education and Care Department; and
- 14. the Cultural Affairs Department;
- B. reports on sector-based economic drivers, including:
 - 1. energy and climate economies:
 - a. clean technologies and energy economies;

 - c. site readiness and meeting the energy needs of New Mexico companies;
 - d. regional transmission organizations;
- e. taxation of projects on New Mexico Renewable Energy Transmission Authority property; and

 - a. the border industries and tradeports; and
- b. economic impacts of federal and military installations and national laboratories;
 - C. updates on business development and capital access, including:
- 1. economic development initiatives and priorities in communities around New Mexico;
- 2. challenges and opportunities facing rural New Mexico industries and small businesses, including:
 - a. the gaming and tribal gaming industries;
 - b. the tourism and hospitality industry;
 - c. the restaurant, bar and food service industry;
 - d. the manufacturing industry;
 - e. the medical industry; and
 - f. the creative industries;
 - 3. cooperative and community ownership models in rural and tribal economies;

- 4. impacts of state policies, such as the use of eminent domain, prevailing wage requirements and the Environmental Improvement Board's policies on electric vehicles;
- 5. access to capital for small and minority-owned businesses, including through community development financial institutions, tribal lenders and credit unions;
- 6. opportunities for international investment opportunities in New Mexico, such as the NMexus Center; and
- 7. impacts of federal tariffs and opportunities for substituting foreign imports with New Mexico production;



Welcome and Updates on the Local Economies (9:17 a.m.)

Victoria Archuleta, senior economic developer, Economic Development Division, Village of Los Lunas, welcomed legislators and gave an overview of the rapid economic growth happening in Los Lunas, with the Meta data center being one of the driving forces. Ms. Archuleta outlined some of the major infrastructure projects, including the Interstate 25 interchange and Los Lunas boulevard project, to address traffic flow and congestion in the area. Martin Moore, city manager, City of Rio Communities, and Lawrence Gordon, mayor pro tem, City of Rio Communities, discussed opportunities being created to attract small businesses to the area as well as current capital investment projects and the ongoing challenges establishing water and sewage infrastructure. Workforce Training Collaboration (10:07 a.m.)

Steven Sauceda, vice president for workforce development, New Mexico Junior College, addressed the Government Results and Opportunity Program Fund and how it has removed many of the cost barriers for workforce training programs. Randy Krall, chief executive officer (CEO), Telemetry Insight, and Arjun Bhakta, internet of things director, Telemetry Insight, explained how the data analytics company serves oil and gas companies by providing a remote monitoring device for wells to collect data and analyses, contributing to higher production. Report from the Office of Broadband Access and Expansion (OBAE) (11:38 a.m.)

Jeff Lopez, director, OBAE, presented an update on broadband access and rural development across the state. Mr. Lopez reviewed federal programs and state funding, as well as the Statewide Education Network, which supports the installation and maintenance of critical education technology infrastructure. He noted that the United States Department of Commerce terminated the OBAE's legal grant agreement for \$8.7 million, which would have supported digital equity, digital literacy and digital opportunity, in May of 2025. Geothermal Energy in New Mexico (1:54 p.m.)

Tom Solomon, electrical engineer and facilitator, Geothermal Development Working Group, and co-coordinator, 350 New Mexico, presented an overview of geothermal energy, noting that New Mexico is rated sixth in the country for geothermal potential. Mr. Solomon outlined the legislative and funding goals of the working group in promoting long-term development of advanced geothermal electricity. Logan Stephens, vice president and head of

development, XGS Energy, gave a brief description of the advanced geothermal and technological work the company does, using oil and gas industry practices to access hot dry rock. Shari Kelley, Ph.D., senior geophysicist and field geologist, Bureau of Geology and Mineral Resources (NMBGMR), New Mexico Institute of Mining and Technology (NMIMT), addressed the June 2025 report on "The Future of Geothermal in New Mexico" published by Project InnerSpace, in collaboration with the NMIMT and the NMBGMR. The report outlines how New Mexico, given its abundant geothermal resources, has the potential to be at the forefront of the global geothermal transition to cleaner energy. Jackson Grimes, director of global engagement, Project Innerspace, discussed some of the initiatives being brought forth, including geomap tools, state reports and plans to leverage oil and gas technology and infrastructure. Surface and Ground Water Use (3:49 p.m.)

Linda Guenley, member, Valencia Water Watchers, discussed the fact that the Rio Grande has run dry again in Albuquerque and Belen, leaving farmers without irrigation water. The Valencia Water Watchers recommend that legislators fund regional water councils, as well as aquifer mapping and water data initiatives. Maurice Hall, Ph.D., P.E., senior advisor, Climate Resilient Water Systems, Environmental Defense Fund, addressed the importance of ground water for rural communities, given that it is the only source of water for communities outside the major river corridors. Dr. Hall emphasized the critical need for proactive approaches to ground water management since ground water resources across the state are being threatened by persistent drought and increasing temperatures. Dr. Hall also encouraged legislative recommendations to prepare for water resilience and long-term water security in the state. The presentation materials can be found here:

Zoning Policy and Housing Affordability (10:41 a.m.)

Alex Horowitz, project director, Housing Policy Initiative, The Pew Charitable Trusts, addressed New Mexico's housing shortage and how the state's rental costs have increased by 58% since 2017, outpacing the 29% national increase. Mr. Horowitz noted that the state's housing inventory is currently one-half of its 2018 level, resulting in an increase in the median costs of homes and contributing to unaffordable rental costs and increasing homelessness. Mr. Horowitz also noted that many states have passed legislation to remove regulatory barriers, including reforming building codes and zoning restrictions, which has resulted in an increase in

Senator Charley welcomed everyone to the meeting, and members of the committee introduced themselves.

Welcome and Updates on the Local Economies (9:45 a.m.)

Nate Duckett, mayor, City of Farmington, and Warren Unsicker, director, Economic Development, City of Farmington, highlighted the strategic priorities and needs of the City of Farmington. In addition, Mr. Duckett gave an overview of upcoming major construction projects and the major construction projects that have been completed thus far.

Andrew DiCamillo, director, Community Development, City of Aztec, spoke about the arterial project around the City of Aztec to help with the flow of traffic and bring economic growth. He noted that there are other projects in place to make efforts to incentivize public-private partnerships to attract businesses, specifically retail shops, to the City of Aztec.

Mike Stark, county manager, San Juan County, said that a five-year strategic plan was developed at a time when the San Juan Generating Station closed down and emphasized the economic hardships that the community has faced.

Cynthia Atencio, mayor, City of Bloomfield, mentioned new retail establishments coming to the City of Bloomfield and noted that the city has a chamber of commerce. She also stated that the city has been in communication with the San Juan Water Commission for the purchase of land for the purpose of a water reservoir.

Kara Wood, Town of Kirtland representative, Four Corners Economic Development, said that prior to 2015, the community was unincorporated and decided to incorporate, as infrastructure and funding were unavailable. Infrastructure continues to be a huge need, specifically for broadband. She stated that the largest employer of the Town of Kirtland is the Central Consolidated School District and that the closure of the San Juan Generating Station had a huge financial impact on the town. Jaqueline Montoya, project manager, Harvest Food Hub and Kitchen, San Juan College, said that the Harvest Food Hub and Kitchen's mission is to grow and sustain the capacity of food systems and have a positive impact on the economy. Welcome and Introductions (9:32 a.m.)

Senator Charley welcomed everyone to the meeting, and members of the committee introduced themselves.

New Mexico Grocers Association (9:37 a.m.)

Henry Sandoval, executive director, New Mexico Grocers Association, introduced Ryan Doyle, owner, Intrepid Wholesale, LLC, and Breck Stewart, member, Executive Board, New Mexico Grocers Association, and emphasized how crime has impacted grocers in New Mexico, particularly in rural communities. They said that with limited resources in food supply and an increase in retail theft, many grocers have been forced to hire private security, which further increases grocery prices for consumers. Trade Ports in New Mexico (10:33 a.m.)

Gonzales, M.B.A., executive development officer, Economic Development, Bernalillo County, said that the Interstate 40 TradePort Corridor anticipates

creating 60,000 new jobs in New Mexico and Arizona hubs. Anthony Dimas, county manager, McKinley County, said that the Gallup-McKinley TradePort is a collaborative public-private effort among the Greater Gallup Economic Development Corporation, the City of Gallup and McKinley County. Libraries' Role in Rural New Mexico (1:04 p.m.)

Shel Neymark, executive director, New Mexico Rural Library Initiative, introduced Aspen Coriz-Romero, fellow, New Mexico Rural Library Initiative, and said that rural libraries are often the only infrastructure in the towns that they are in and that aside from providing library services, they tend to provide early childhood education, after-school programs, adult education and economic development. New Mexico Food Banks (1:56 p.m.)

Jill Dixon, executive director, The Food Depot, introduced Katy Anderson, vice president, Strategy, Partnerships and Advocacy, Roadrunner Food Bank, and said that there are over 500 distribution sites and food access in all 33 counties in New Mexico. Ms. Anderson explained that the healthy corner store model is an approach in which convenience stores are supported in offering a wider range of nutritious food options and that the goal of this model is to expand healthy food access in neighborhoods where larger, traditional retail stores may struggle to operate or reach consistently. Rural Chambers of Commerce (2:25 p.m.)

Bill Lee, chief executive officer, Gallup-McKinley County Chamber of Commerce; Jessica Bollema, executive director, Artesia Chamber of Commerce; and Hayley Klein, city administrator, City of Artesia, spoke on challenges that the City of Artesia, the City of Gallup and McKinley County face, as well as the areas' strengths. Mr. Lee noted that the City of Gallup continues to rank high in crime statistics, with repeat offenders cycling in and out of the criminal justice system and repeatedly targeting the same businesses. He also highlighted threats to the medical field, including ongoing issues with medical malpractice statutes, which have contributed to a shortage of medical providers and have placed additional strain on rural communities in New Mexico. Ms. Bollema said that the City of Artesia prides itself on its high school football team and its geographical accessibility to other towns in the southeastern part of the state. Ms. Klein discussed staffing shortages and broader health care concerns that are prompting many residents to seek medical care in neighboring states.
