# Military and Veterans' Affairs Committee 2023 Interim Summary

The Military and Veterans' Affairs Committee (MVAC) was created by statute for the 2009 interim and then permanently reauthorized during the Forty-Ninth Legislature, Second Session. Pursuant to Section 2-20-2 NMSA 1978, the MVAC holds hearings in several geographically dispersed areas of the state related to military and veterans' issues. The MVAC is also tasked with making legislative recommendations to each session of the legislature and regulatory recommendations to the United States Congress, United States Department of Veterans Affairs and United States Department of Defense.

The MVAC held five meetings during the 2023 interim: two in Santa Fe and one each in Angel Fire, Albuquerque and Truth or Consequences. In June, the MVAC received an update from the Veterans' Services Department, and the MVAC members discussed the committee's work plan for the 2023 interim.

In July, in Angel Fire, the MVAC received presentations that included a brief overview of the budgeting process from the Legislative Finance Committee, an update on the Vietnam Veterans Memorial replica wall project and veteran educational programs at the University of New Mexico-Taos.

At the third meeting, in September, the MVAC met in Albuquerque. The committee received a presentation from the Defense-State Liaison Office of the United States Department of Defense. The presentation included an overview of the office's priorities for the 2024 legislative session, which included military child care and education, justice and safety and representation and access issues. The MVAC additionally received presentations from Kirtland Air Force Base, Navajo Code Talkers Museum Corporation and Elected Officials to Protect America.

The fourth meeting was held in Truth or Consequences in October. The secretary of health provided an overview of the challenges that the New Mexico State Veterans' Home has faced since the pandemic. However, during the 2022 legislative session, funding was secured for the construction of six buildings, and the MVAC received a tour of phase one of the construction. The MVAC also received a presentation from the Mesilla Valley Community of Hope and heard about the efforts to address veteran homelessness and the programming and advocacy behind the military and veterans programs at New Mexico State University.

At the final meeting of the interim, in Santa Fe, the MVAC received presentations on the federal Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act of 2022, the New Mexico Veterans Legacy Program undertaken by Santa Fe Community College in partnership with the United States Department of Veterans Affairs and the New Mexico National Guard Youth ChalleNGe Academy. The committee endorsed legislation that would make an appropriation to the Veterans' Services Department to contract with a veteran, police and first responder posttraumatic stress disorder therapy program.

#### Work Plan

The Military and Veterans' Affairs Committee was first created by statute for the 2009 interim. The committee was permanently reauthorized by statute during the 2010 regular legislative session. The committee has various statutory duties, including making an annual report; recommending any necessary legislation to the next session of the legislature; and requesting necessary action to the United States Congress, the United States Department of Veterans Affairs and the United States Department of Defense. The committee is required to conduct meetings in several geographically dispersed areas of the state and to conduct hearings relating to military issues and veterans' issues.

During the 2023 interim, as time permits, the Military and Veterans' Affairs Committee will:

A. receive updates from New Mexico's military installations;

B. study issues relating to female veterans;

C. receive updates regarding college credit for military service from the Higher Education Department and the Veterans' Services Department;

D. receive testimony regarding jobs and business opportunities for veterans;

E. study long-term care options for veterans;

F. study transportation to and from medical providers for veterans, particularly those living in rural areas of the state;

G. receive testimony pertaining to educational opportunities and outreach offered by state educational institutions and public community colleges to veteran students;

H. examine options for the prevention of homelessness and support for homeless veterans in areas throughout the state;

I. receive testimony regarding health care options both within the Veterans Administration system and outside of it, including behavioral health care, suicide prevention and treatment for posttraumatic stress disorder;

J. examine actions New Mexico can take to improve quality of life for military and veteran families;

K. study the creation of veterans' courts in various judicial districts in New Mexico;

L. examine issues relating to New Mexico's active duty, reserve and National Guard military personnel, veterans and military families;

M. examine various issues relating to veterans and taxes;

N. examine the issue of the inspection of public records for military records;

O. examine housing issues near New Mexico's military installations; and

P. receive testimony from the Veterans' Services Department to better define the needs of the department.

# Welcome/National Veterans Wellness and Healing Center (9:19 a.m.)

Representative Garcia welcomed everyone to the meeting. Members of the committee, staff and audience introduced themselves.

Chuck Howe, board president, National Veterans Wellness and Healing Center, told committee members that the center was founded in 2009. The center treats veterans with post-traumatic stress disorder and their partners. The center has treated roughly 900 individuals and works in collaboration with state behavioral staff.

# Vietnam Veterans Memorial Replica Wall Update (9:31 a.m.)

Edward Mendez, director, Benefits and Services, Veterans' Services Department, introduced Jake Lopez, president, Vietnam Veterans of America, Chapter 996, and gave a briefing on the project. # Water and Energy Security (10:17 a.m.)

Alex Cornell du Houx, president, Elected Officials to Protect America (EOPA), said that the EOPA is a network of current and former bipartisan elected officials who care about protecting the planet and democracy while working collaboratively to transition the country into a clean energy economy. Mr. Cornell du Houx said that the EOPA works to implement solutions that will help solve the climate crisis and ensure environmental justice.

# Veteran Heroes of the American Southwest Media Project (11:26 a.m.)

David C'de Baca introduced Avelino Calabaza and told committee members that the goal of the project is to honor the service and life journeys of veterans from the time of the Civil War to the Iraq and Afghanistan conflicts. In addition, the media project hopes to provide local schools with materials so that students learn about local veterans, including those from Indian nations, tribes and pueblos and other underserved communities to which heroes have contributed. # Monday, October 2

## Welcome and Introductions (9:44 a.m.)

Representative Garcia welcomed everyone to the meeting. Members of the committee, staff and audience introduced themselves.

# Welcome (9:53 a.m.)

Kenneth Shull, administrator, New Mexico State Veterans' Home, gave welcoming remarks and an overview of the facility's construction progress and highlighted key issues that the facility is facing.

# Veterans Administration Rollbacks (10:20 a.m.)

Kelly K. Fajardo, former state representative, District 7, introduced Lieutenant Colonel Lawrence Baker, Jr., human resources director, Sierra Vista Hospital and Clinics. Ms. Fajardo said that there has been a move by the United States Veterans Administration to roll back reimbursement rates for veterans transported via ambulance or other special modes of transportation. Veterans who use these services would have to pay much of the cost of such transportation out of pocket. Lieutenant Colonel Baker gave an overview of the facility and services of the Sierra Vista Hospital and Clinics. The presentation can be found here:

# Motion to Send a Letter (10:54 a.m.)

On a motion duly made and seconded, and without any objections, the committee voted to send a letter to United States Senators Ben Ray Luján and Martin Heinrich to request that the United States Department of Veterans Affairs rescind its proposed rule to change reimbursement rates in its travel reimbursement program.

# Mesilla Valley Community of Hope Veterans Programs (10:55 a.m.)

Katherine McClure, veteran services coordinator, Mesilla Valley Community of Hope, said that the Mesilla Valley Community of Hope's veterans programs offer housing assistance with the collaboration of the Mesilla Valley Public Housing Authority. Patrick Allen, secretary, Department of Health, gave welcoming remarks and said that the pandemic took a toll on the facility. He said challenges the facility faces include a shortage of staff and the cost of contract staff.

## Committee Tour — New Mexico State Veterans' Home (1:00 p.m.)

Committee members and staff took a tour of the new facility for the New Mexico State Veterans' Home.

## New Mexico State University (NMSU) Military and Veterans Programs (1:45 p.m.)

Hector Sanchez, director, Military and Veterans Programs, NMSU, said that in 2010, the NMSU Military and Veterans Programming Office was created. The main mission of the office is to provide guidance to veterans from admissions to graduation and employment. The office provides resources that include a computer lab and homework area, priority registration for all military and veteran students and commencement cords in honor of military service and academic accomplishments. The PACT Act is one of the largest benefits expansions in the history of the United States Department of Veterans Affairs.
