


#### Rural Economic Opportunities Task Force 2022 Interim Summary

The Rural Economic Opportunities Task Force held five meetings during the 2022 interim. In addition to the first and last meetings, held at the State Capitol in Santa Fe, the task force held meetings at the Bosque Redondo Memorial in Fort Sumner, Los Luceros Historic Site near Alcade and Fort Bayard Theater in Fort Bayard.

This year, the task force broadened its scope of inquiry beyond rural infrastructure needs and heard presentations regarding fire and disaster response, the confluence of the state's historic preservation and tourism efforts, rural health care needs and general economic development programs. The task force also received regular presentations from New Mexico State University's Agricultural Economics and Agricultural Business Department regarding how to assess the potential for developing or recruiting value-added agricultural businesses in rural New Mexico. Presenters included the Homeland Security and Emergency Management Department, the state forester, the Economic Development Department, the Cultural Affairs Department, the Tourism Department and several regional councils of governments.

A recurring challenge cited by many presenters was a lack of sufficient project planning staff, engineering services and market analyses for rural communities to develop proposals for federal and state infrastructure grant programs or to create successful economic development strategies.

The task force endorsed one bill that would change how taxes for services are administered. The 2021 legislature had designated that gross receipts taxes should be assessed at the location where goods or services are received. However, this proved to dramatically increase accounting costs for service companies that provide services across many jurisdictions. The endorsed bill, file number 202.223229.1, would change the assessment of services to the location from which a service business operates.

#### **Work Plan**

The Rural Economic Opportunities Task Force (REOTF) was created by the New Mexico Legislative Council on April 26, 2022. As time permits during the 2022 interim, the REOTF proposes to focus on identifying opportunities for rural development and economic growth, providing oversight of the capacity-building funds for rural infrastructure appropriated during the 2022 legislative session and developing legislative proposals for a systematized state approach to address rural infrastructure needs and promote business and job growth in rural communities. Within those overall goals, the task force proposes to:

A. examine efforts to improve federal, state and local fire risk mitigation, response and recovery efforts;

- B. learn about the issues affecting rural areas of the state to generate an informed rural relief legislative proposal and long-term plan to address rural needs, including needs for health care systems and infrastructure;
- C. hear about rural issues and needs from rural frontier, small town, unincorporated and Native American communities:
- D. receive reports from various state agencies, including the Economic Development Department's New Mexico Outdoor Recreation Division, the Tourism Department and the Cultural Affairs Department, regarding current programs to grow rural economies;

- E. hear reports from various stakeholders regarding rural infrastructure and economic challenges and opportunities, including existing programs or business models that are working;
- F. examine the issues identified in the Pivotal New Mexico 2021 Rural Infrastructure Needs Study and the various other state models the study highlighted as having the potential to address rural infrastructure needs in New Mexico, including presentations from various state agencies regarding:
  - which agency would best house a general state rural infrastructure program, or alternatively, which agencies would be best suited for service-specific infrastructure programs; and
  - agency recommendations for how to design and fund a general infrastructure program or service-specific infrastructure programs;
- G. hear status reports on the use of funds appropriated during the 2022 legislative session to increase project planning and management capacity within local governments and regional councils of governments;
  - H. receive reports from the Rural Equity Ombud; and
- I. examine the potential for duplicating the dairy industry's success in developing valueadded production in other agricultural product sectors, including:
  - receiving analyses from New Mexico State University's Center of Excellence in Sustainable Food and Agricultural Systems and the Economic Development Department about: the potential to grow agricultural business sectors that create baseline jobs within rural communities; the leveraging effects of even moderate increases in family farm incomes; and the efficacy of developing logistics microcenters for food processing, packaging and distribution as a means of generating wealth throughout a rural region; and
  - hearing about the New Mexico State University Arrowhead Center collaborative Building Bridges Program with the Cooperative Extension Service to foster entrpreneurial development within rural communities.



## Welcome and Bosque Redondo Memorial and Fort Sumner Historic Site Status (11:35 a.m.)

Michelle Gallagher Roberts, deputy secretary, Cultural Affairs Department (CAD), and Patrick Moore, executive director, New Mexico Historic Sites, CAD, welcomed the members of the task force and guests. Ms. Gallagher Roberts informed the members of the CAD's responsibilities, including education, preservation and research. Ms. Chancey noted that all COGs in New Mexico needed additional staff to meet increasing community needs. Ms. Batista reemphasized that COGs and their communities need staff and funding to apply for grants and meet community needs, including fire recovery and water supply maintenance. #### Friday, July 29

#### Reconvene and Welcome (9:03 a.m.)

Representative Sweetser reconvened the meeting, and Mary Ann Cortese, president, Friends of the Bosque Redondo Memorial, welcomed task force members. Members introduced themselves.

#### State Fire Response, Recovery Plans and Burn Scar Flood Prevention (9:10 a.m.)

Laura McCarthy, state forester and director, Forestry Division, Energy, Minerals and Natural Resources Department (EMNRD), and Collin Haffey, coordinator, Forest and Watershed Health Office, EMNRD, discussed the impacts of the forest fires across the state, particularly flooding and water contamination, and possible strategies for recovery. Ms. McCarthy noted that the scale of response is overwhelming and that many federal programs are limited by narrow jurisdictions. Mr. Haffey noted that individuals who appropriately protected their property from fire damage are now struggling with flood damage.

Kelly Hamilton, deputy secretary, Homeland Security and Emergency Management Department, responded to questions and discussed the need for federal assistance. The presentation can be found here:

## Federal Fire Response, Recovery Plans and Burn Scar Flood Prevention in New Mexico (10:40 a.m.)

Wendy Jo Haskins, director, Ecosystem Planning and Biophysical Resources, Southwestern Region, United States Department of Agriculture (USDA) Forest Service; Rigoberto Lopez, acting state director, Natural Resources Conservation Service (NRCS), USDA; Jonas Moya, state executive director, Farm Services Agency, USDA; Ray Melton, business programs director, Rural Development, USDA; and Samantha Martinez, housing program director, Rural Development, USDA, spoke on the federal aspects of post-fire recovery and response through the USDA.

Ms. Haskins discussed the USDA Forest Service's use of the Burned Area Emergency Response (BAER) Program. Ms. Haskins noted that the BAER Program is used to identify threats and take immediate action to manage unacceptable risks.

Mr. Lopez spoke on funding obtained through the NRCS's Emergency Watershed Protection Program and what conditions must be met for the NRCS to provide assistance. He emphasized that each agency under the USDA is controlled by different rules and regulations that restrict where each agency can offer assistance.

Mr. Moya provided an overview of disaster assistance programs provided through the Farm Services Agency, including the Livestock Indemnity Program, the Emergency Livestock Relief Program, the Emergency Forest Restoration Program and the Emergency Relief Program.

Mr. Melton reported that Rural Development is not a disaster relief organization but still works with other agencies to support rural communities in disaster recovery and offer disaster resources. These resources address needs such as transitional housing and home repair and rural business planning and recovery. Ms. Martinez discussed Rural Development's ability to provide subsidized home loans to those impacted by fires and what consequences might ensue if someone defaulted on the loan. She emphasized the importance of digital equity; strong partnerships, including community and tribal engagement; and the creation of a robust middle-mile framework upon which connectivity to rural New Mexico will depend. Jason Espinoza, co-owner, KW Consulting, spoke in favor of bill draft 202.223229.1, which would allow businesses to elect origin-based sourcing rules for reporting gross receipts and use of certain services. On a motion made by Representative Armstrong and seconded by Senator Diamond, the task force voted to endorse bill draft 202.223229.1. Senator Stefanics voted in opposition.

Adrian Avila, fiscal analyst, Senate Majority Office, reviewed Senator George K. Munoz's proposal to establish a prosperity and economic resiliency fund.



RELATING TO TAXATION; ALLOWING BUSINESSES TO ELECT ORIGIN-BASED SOURCING RULES FOR REPORTING GROSS RECEIPTS AND USE OF CERTAIN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 7-1-14 NMSA 1978 (being Laws 2020, Chapter 80, Section 1) is amended to read:

"7-1-14. [BUSINESS LOCATION INSTRUCTIONS FOR PURPOSES OF]

SOURCING RULES--REPORTING GROSS RECEIPTS AND USE--LOCATION-CODE

DATABASE AND LOCATION-RATE DATABASE.--

A. For purposes of the Gross Receipts and Compensating Tax Act, Interstate Telecommunications Gross Receipts Tax Act, Leased Vehicle Gross Receipts Tax Act and any act authorizing the imposition of a local option gross receipts or compensating tax, a person that has gross receipts and a .223229.1

person using property or services in New Mexico in a taxable manner shall report the gross receipts or use to the proper business location as provided in this section.

- The business location for gross receipts from the sale, lease or granting of a license to use real property located in New Mexico, and any related deductions, shall be the location of the property.
- The business location for gross receipts from the sale or license of tangible personal property, and any related deductions, shall be at the following locations:
- if the property is received by the (1) purchaser at the New Mexico [business] location of the seller, the location of the seller:
- if the property is not received by the purchaser at [a business] the location of the seller, the location indicated by instructions for delivery to the purchaser, or the purchaser's donee, when known to the seller;
- if Paragraphs (1) and (2) of this (3) subsection do not apply, the location indicated by an address for the purchaser available from the business records of the seller that are maintained in the ordinary course of business; provided that use of the address does not constitute bad faith;
- if Paragraphs (1) through (3) of this (4) subsection do not apply, the location for the purchaser obtained during consummation of the sale, including the address .223229.1

of a purchaser's payment instrument, if no other address is available; provided that use of this address does not constitute bad faith; or

- (5) if Paragraphs (1) through (4) of this subsection do not apply, including a circumstance in which the seller is without sufficient information to apply those standards, the location from which the property was shipped or transmitted.
- D. The business location for gross receipts from the lease of tangible personal property, including vehicles, other transportation equipment and other mobile tangible personal property, and any related deductions, shall be the location of primary use of the property, as indicated by the address for the property provided by the lessee that is available to the lessor from the lessor's records maintained in the ordinary course of business; provided that use of this address does not constitute bad faith. The <a href="location of primary">location of primary</a> [business location] use shall not be altered by intermittent use at different locations, such as use of business property that accompanies employees on business trips and service calls.
- E. The business location for gross receipts from the sale, lease or license of franchises, and any related deductions, shall be where the franchise is used.
- F. The business location for gross receipts from the performance or sale of the following services, and any .223229.1

related deductions, shall be at the following locations:

- (1) for professional services performed in New Mexico, other than construction-related services, or performed outside New Mexico when the product of the service is initially used in New Mexico, the location of the performer of the service or seller of the product of the service, as appropriate;
- (2) for construction services and construction-related services performed for a construction project in New Mexico, the location of the construction site;
- (3) for services with respect to the selling of real estate located in New Mexico, the location of the real estate;
- (4) for transportation of persons or property in, into or from New Mexico, the location where the person or property enters the vehicle; and
- Paragraphs (1) through (4) of this subsection, the location of the performer of the service or seller of the product of the service, as appropriate, unless the business elects to use the location where the product of the service is delivered. The business shall notify the department of the election, in writing, no later than the date on which the taxpayer files the return for the first taxable period to which the election applies. The election shall apply to that taxable period and .223229.1

to each taxable period thereafter until the taxpayer notifies the department, in writing, that the election is terminated; provided that an election shall not terminate until the method using the location of the performer of the service or seller of the product of the service has been used for at least thirtysix consecutive taxable periods.

- Except as provided in Subsection H of this section, the business location for uses of property or services subject to the compensating tax shall be [reported at] the [business] location at which gross receipts would have been required to be reported had the transaction been subject to the gross receipts tax.
- If a person subject to the compensating tax can demonstrate that the first use upon which compensating tax is imposed occurred at a time and place different from the time and place of the purchase, then the business location for the compensating tax shall be [reported at] the [business] location of the first use.
- [I. The secretary shall designate codes to identify the business locations for a person's gross receipts, or use for purchases subject to the compensating tax, and deductions related to those receipts or that use shall be reported.
- J.] I. The secretary shall develop a location-code database that provides the business location codes designated by the secretary for purposes of reporting pursuant to

[Subsection I of] this section. The secretary shall also develop and provide to taxpayers a location-rate database that sets out the tax rates applicable to business locations within the state, by address, and sellers who properly rely on this database shall not be liable for any additional tax due to the use of an incorrect rate.

#### [K.] J. As used in this section:

[(1) "business location" means the code

designated by the department to identify business locations and
required to be used to report the gross receipts, or use for
purchases subject to the compensating tax, and deductions
related to those receipts or that use;

(2)] (1) "gross receipts" means, as applicable, "gross receipts" as used in the Gross Receipts and Compensating Tax Act and the Leased Vehicle Gross Receipts Tax Act and "interstate telecommunications gross receipts" in the Interstate Telecommunications Gross Receipts Tax Act;

[(3)] (2) "in-person service" means a service physically provided in person by the service provider, where the customer or the customer's real or tangible personal property upon which the service is performed is in the same location as the service provider at the time the service is performed; and

 $\left[\frac{(4)}{(3)}\right]$  "professional service" means a service, other than an in-person service, that requires either .223229.1

an advanced degree from an accredited post-secondary educational institution or a license from the state to perform."

EFFECTIVE DATE. -- The effective date of the SECTION 2. provisions of this act is July 1, 2023.
