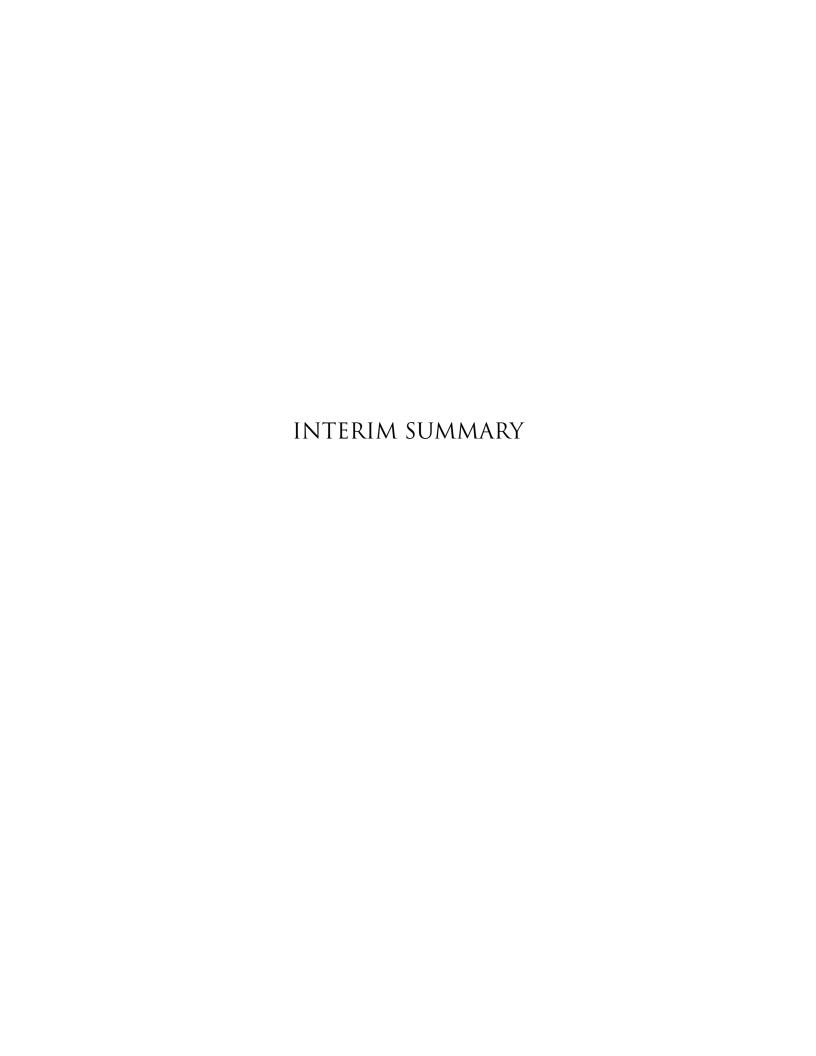

Radioactive and Hazardous Materials Committee 2023 Interim Summary

The Radioactive and Hazardous Materials Committee held five meetings during the 2023 interim.

At the first meeting in Santa Fe, the committee heard from the Office of Natural Resources Trustee (ONRT) on the office's role in restoring resources affected by the release of radioactive and hazardous materials. The Department of Environment (NMED) and the State Land Office presented on the regulation of radioactive and hazardous materials. The Energy, Minerals and Natural Resources Department (EMNRD) provided information on the working group for the Waste Isolation Pilot Plant (WIPP) Transportation Safety Program and highlighted achievements in the training of emergency responders, medical personnel and volunteers along the WIPP shipping corridor.

At the second meeting in Los Alamos, the United States Department of Energy, the NMED, the ONRT and Concerned Citizens for Nuclear Safety discussed the chromium plume cleanup and other environmental issues in the Los Alamos area. Advocate groups presented on the issues concerning people impacted by the Trinity nuclear test. The Defense Nuclear Facilities Safety Board presented a report on activities to fulfill the board's statutory mission of providing independent analysis, advice and recommendations to the United States secretary of energy for the purpose of providing adequate protection of public health and safety at defense nuclear facilities. Discussion was also held on the transportation of weapons-grade plutonium in the state. In addition, the committee heard about issues concerning Los Alamos National Laboratory, including legacy environmental cleanup and plutonium pit production.

The third meeting in Las Cruces included a report from the State Emergency Response Commission and discussions regarding policy issues in nuclear medicine by the NMED and Eden Radioisotopes. The ONRT, NMED and Dona Ana Soil and Water Conservation District presented on the progress of cleanup and restorative measures at the White Sands Test Facility.

The fourth meeting was held in Carlsbad and included discussions on per- and polyfluoroalkyl substances (PFAS) contamination, ongoing PFAS-related litigation and PFAS-related rulemaking. An update was provided by the EMNRD on the remediation of the Carlsbad Brine Well site. Separate panels were held regarding various policy issues on the storage of nuclear materials in the state, produced water use in the state and the reuse of water produced from oil and gas operations. Lastly, Kirtland Air Force Base (KAFB) and the NMED discussed the cleanup of the jet fuel spill at KAFB.

At the final interim meeting in Santa Fe, the committee heard about the use of PFAS in oil and gas operations. Panels were held to discuss issues relating to orphaned wells and financial assurance, uranium mine and mill site reclamation and abandoned contaminated sites, including dry cleaners. In addition, the NMED provided an update on the San Juan Generating Station cleanup, and the committee discussed a proposed constitutional amendment to provide the people of New Mexico with additional environmental rights.

- L. per- and polyfluoroalkyl substances contamination, rulemaking and litigation;

- M. produced water and water reuse;
- N. interim storage of nuclear materials;
- O. San Juan Generating Station cleanup;

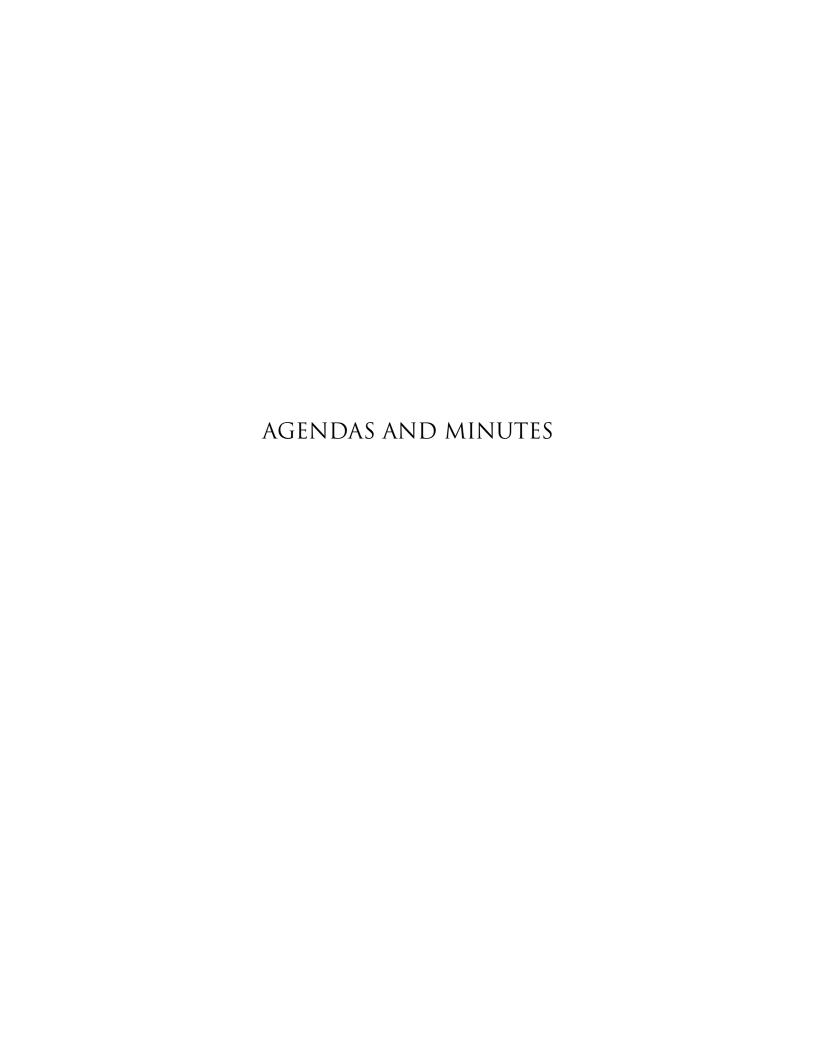

Thursday, June 15

Welcome and Introductions (9:43 a.m.)

Senator Steinborn welcomed the committee, and members of the committee, staff and audience introduced themselves.

Overview of the Office of Natural Resources Trustee's (ONRT's) Role in Restoring Resources Affected by the Release of Radioactive and Hazardous Materials (9:49 a.m.)

Maggie Hart Stebbins, natural resources trustee, ONRT, and Kate Girard, executive director, ONRT, presented an overview of the office's mission, its role in the restoration of injured natural resources and its shared responsibility with the Department of Environment (NMED) to stop contamination and to hold polluters accountable.

Ms. Hart Stebbins and Ms. Girard discussed three current cases and several potential new cases undergoing natural resource damage assessments. They also discussed some of the claim settlements that have been reached with polluters through the federal Superfund Act and other state and federal laws and the restoration projects created from and funded by those settlements. Discussion of the 2023 Work Plan and Meeting Schedule (10:44 a.m.)

Mr. Kricka presented the proposed 2023 interim work plan and meeting schedule, and committee members discussed the plan and gave input on additional topics of focus. On a motion duly made and seconded, and without objection, the committee voted to approve the work plan and meeting schedule.

Overview of the NMED's Regulation of Radioactive and Hazardous Materials (10:56 a.m.)

Rick Shean, director, Resource Protection Division, NMED, presented an overview of the NMED's regulation of radioactive and hazardous materials and what its authority is at high-profile facilities such as Los Alamos National Laboratory (LANL) and the Waste Isolation Pilot Plant (WIPP). He provided updates on permit renewal applications submitted by LANL and WIPP, legacy waste cleanup at LANL and the department's work with the United States Air Force to remediate the ground water and soil contamination at Kirtland Air Force Base.

Mr. Shean's presentation included information about emerging contaminants; concerns about self regulation of, collaboration on and the challenges of cleanup efforts; and the department's need for more funding and inspection staff.

Santiago Rodriguez, chief, Radiation Control Bureau, Environmental Protection Division, NMED, provided information on how the NMED regulates and monitors the naturally occurring radioactive materials in the waste streams of the oil and gas industry. The presentation can be found here:

WIPP Transportation Program (12:01 p.m.)

Jeremy Lewis, acting director, Energy Conservation and Management Division, Energy, Minerals and Natural Resources Department, presented information on the working group for the WIPP Transportation Safety Program, which coordinates with other state agencies, including the Department of Public Safety, the Department of Health and the NMED, and how those agencies contribute to the working group. He also highlighted achievements in the training of emergency responders, medical personnel and volunteers along the WIPP shipping corridor. The presentation can be found here:

Sunalei Stewart, deputy commissioner of operations, State Land Office, presented information about the office's legal and regulatory role in the management of radioactive and hazardous materials on state trust lands. He provided an update on Holtec International's proposed interim storage facility for spent nuclear waste and how the state's mineral interests at the site have not been properly considered. He also discussed the office's remediation and reclamation efforts and noted that the office would benefit from more staff and funding for enforcement of environmental compliance and other projects. Welcome and Introductions (9:10 a.m.)

Representative Ferrary asked members of the committee, staff and audience to introduce themselves, and Linda Matteson, deputy county manager, Los Alamos County, welcomed the committee to Los Alamos.

Approval of Minutes (9:26 a.m.)

On a motion made by Senator Pinto, seconded by Senator Rodriguez and without objection, the minutes of the June 15, 2023 meeting were approved.

Chromium Plume Cleanup and Other Environmental Management Issues (9:27 a.m.)

Michael Mikolanis, manager, Los Alamos Field Office, Office of Environmental Management, United States Department of Energy (DOE); Rick Shean, director, Resource Protection Division, Department of Environment (NMED); Maggie Hart Stebbins, natural resources trustee, Office of Natural Resources Trustee (ONRT); Kate Girard, executive director, ONRT; and Joni Arends, co-founder and executive director, Concerned Citizens for Nuclear Safety, discussed the chromium plume cleanup and other environmental issues in the Los Alamos area. Mr. Mikolanis discussed the DOE's top priorities, including accelerating progress on cleanup of the chromium plume, meeting the 2016 consent order milestones and continuing work on characterizing and repackaging above-ground transuranic waste. Mr. Shean focused on issues concerning the chromium plume, including the NMED's role in overseeing the DOE's extraction and cleanup of contaminated ground water pursuant to the Chromium Interim Measures and Characterization Work Plan and 2016 Compliance Order on Consent. Ms. Stebbins and Ms. Girard talked about the ONRT's plan for natural resource restoration and damage assessment of the chromium plume. Ms. Arends requested that the legislature take action on chromium plume cleanup by allocating more funding to the Office of the State Engineer and the NMED and reviewing rules and regulations for public participation in agency hearings regarding the permitting process. Approval of Motion to Send a Letter to the NMED and the DOE Regarding Chromium Plume Cleanup (11:26 a.m.)

On a motion made by Senator Steinborn, seconded by Senator Rodriguez and without objection, the committee approved sending a letter to the NMED and the DOE, copying New Mexico's congressional delegation, encouraging the NMED and the DOE to seek an independent third party to settle their technical disputes regarding cleanup of the chromium plume and to help the entities work toward an agreement on a final remedy.

Issues Concerning Downwinders (11:29 a.m.)

Tina Cordova, co-founder, Tularosa Basin Downwinders Consortium, and Barbara Webber, executive director, Health Action New Mexico, provided a presentation on the issues concerning people impacted by the Trinity nuclear test. Ms. Cordova provided updates on fallout disposition mapping, plutonium studies and amendments to the federal Radiation Exposure Compensation Act. Ms. Webber discussed the health impacts caused by the Trinity nuclear test. The presentation materials can be found here:

Approval of Motion to Send a Letter to Congress in Support of the Amendments to the Federal Radiation Exposure Compensation Act (12:04 p.m.)

On a motion made by Senator Pinto, seconded by Representative Lord and without objection, the committee approved sending a letter to Congress, copying New Mexico's congressional delegation, encouraging the conference committee to keep amendments to the federal Radiation Exposure Compensation Act in the National Defense Authorization Act for Fiscal Year 2024.

Weapons-Grade Plutonium Transport (12:09 p.m.)

Craig Tucker, state hazardous materials coordinator, Homeland Security and Emergency Management Department, and Cynthia Weehler, co-chair, 285 All, discussed the transportation of weapons-grade plutonium in the state. Mr. Tucker briefed the committee on the state's preparedness for and response to transportation incidents involving weapons-grade plutonium and requested that the legislature update the Hazardous Chemicals Information Act to incorporate the federal Emergency Planning and Community Right-to-Know Act of 1986 tier 2 reporting requirements and fee structure. Ms. Weehler discussed the expansion of the Waste Isolation Pilot Plant and the risks involved in the accompanying increase in shipments. The presentation materials can be found here:

Interim Storage of Nuclear Materials (11:40 a.m.)

Bruce Baizel, director, Compliance and Enforcement, Department of Environment (NMED); Mr. Grantham; John Heaton, energy development coordinator, Carlsbad Department of Development; and Camilla Feibelman, director, Rio Grande Chapter, Sierra Club, discussed various policy issues regarding the storage of nuclear materials in the state. Mr. Baizel talked about the NMED's role in regulating Holtec International's storage of spent nuclear fuel and high-level radioactive waste. Mr. Grantham discussed recent litigation and laws regarding the regulation of interim storage of nuclear materials. Mr. Heaton talked about some recent cases regarding the regulation of nuclear materials and the Waste Isolation Pilot Plant.
