INTERIM SUMMARY

Tobacco Settlement Revenue Oversight Committee 2023 Interim Summary

New Mexico receives approximately \$30 million to \$40 million annually in tobacco settlement revenue. Pursuant to Section 6-4-9 NMSA 1978, tobacco settlement revenue is distributed to the Tobacco Settlement Permanent Fund (TS Permanent Fund). A distribution of one-half of the annual revenue is made to the Tobacco Settlement Program Fund (TS Program Fund), and one-half remains in the TS Permanent Fund, which serves as a reserve fund. Annual settlement payments may be subject to challenge through arbitration by participating tobacco manufacturers.

Section 6-4-10 NMSA 1978 requires that money in the TS Program Fund be expended for health and education purposes. Pursuant to Section 2-19-1 NMSA 1978, the Tobacco Settlement Revenue Oversight Committee (TSROC) is required to monitor the use of tobacco settlement revenue, review evaluations of programs receiving funding from tobacco settlement revenue, prepare recommendations of program funding levels for the next fiscal year and make recommendations as necessary for changes in legislation regarding the use of the tobacco settlement revenue.

Throughout the 2023 interim, the committee heard from many recipients of money from the TS Program Fund, including the Department of Health, the Health Care Authority Department and the University of New Mexico Health Sciences Center. Representatives from these agencies shared how the funds they receive are used, the challenges they face and the opportunities for New Mexico to do better with tobacco prevention and cessation.

Another group that was a major focus of the committee this interim was New Mexico's youth. The committee heard from several youth-based and youth-oriented organizations that are working hard to prevent smoking, vaping and other tobacco use among youth throughout the state.

Additionally, the committee heard from both opponents and proponents of smoking bans in casinos and racinos, members of different tobacco enforcement agencies and community organizations focusing on tobacco prevention and cessation for specific demographics.

The committee did not consider any legislation for endorsement this interim.

Work Plan

The Tobacco Settlement Revenue Oversight Committee (TSROC) was established pursuant to Section 2-19-1 NMSA 1978. The TSROC is tasked with monitoring the use of tobacco settlement revenue, reviewing evaluations of programs receiving funding from tobacco settlement revenues and making recommendations for program funding and for changes in legislation regarding the use of the tobacco settlement revenue.

In addition to its statutory duties, and as time permits, during the 2023 interim, the TSROC will:

- A. review the status of the revenue for current and future fiscal years and reserves for the Tobacco Settlement Permanent Fund from the Office of the Attorney General;
- B. hear testimony regarding tobacco settlement-related litigation and legislation, including:
 - 1. the implementation of local government ordinances; and
 - 2. an overview of sister state regulations that restrict the marketing of flavored tobacco products to youth;
- C. hear testimony regarding tobacco settlement-related issues, including:
 - 1. tobacco use deterrents, such as increased taxation and point-of-sale restrictions on nicotine products;
 - 2. prevention and cessation initiatives targeted at youth and the efficacy of those initiatives;
 - 3. tobacco retailer compliance with licensing requirements of the Tobacco Products Act; and
 - 4. other topics within the scope of the committee's oversight duties;

- D. receive reports from state agencies regarding the use of all appropriations from the Tobacco Settlement Program Fund as recommended by the committee and funded by the legislature in prior years and cessation and prevention outcomes associated with those uses;
- E. prepare recommendations to the Legislative Finance Committee for program funding levels for fiscal year 2025 based on the committee's program evaluation process; and
- F. make findings and recommendations, including proposed legislation, available to the legislature as part of the TSROC's final report.
