If general fund balances, including all authorized revenues and transfers to the general fund and balances in the general fund operating reserve, but excluding balances in the tobacco settlement permanent reserve, are insufficient to meet the level of appropriations authorized from the general fund and, after all balances in the general fund operating reserve have been expended, then, upon specific authorization from the legislature, the amounts authorized by the legislature shall be transferred from the tobacco settlement permanent reserve to the general fund for the purpose of meeting those appropriations."".
