Money in the next generation trust fund shall 1 be invested by the state investment officer as land grant 2 permanent funds are invested pursuant to Chapter 6, Article 8 3 NMSA 1978 and shall not be expended for any purpose. Income 4 5 earned from investment of the next generation trust fund 6 shall be credited to the fund. Beginning in fiscal year 7 2003, there shall be an annual distribution from the next 8 generation trust fund to the youth development fund in an 9 amount equal to five percent of any amount appropriated to 10 the next generation trust fund in fiscal year 2002. 11 Thereafter, the annual distribution shall be four and seven-12 tenths percent of the average annual balance in the next 13 generation trust fund for the preceding two fiscal years. 14 Section 4. YOUTH DEVELOPMENT FUND CREATED .--

A. The "youth development fund" is created in the state treasury and shall be administered by the state department of public education. The fund shall consist of distributions from the next generation trust fund and money from any other public or private source appropriated to or deposited in the fund. Income earned on balances in the fund shall be credited to the fund. Balances in the fund at the end of any fiscal year shall be retained in the fund for expenditure as provided in this section and shall not revert to the general fund or to the next generation trust fund.

B. Money in the youth development fund shall be appropriated by the legislature for youth development grants. The state department of public education shall establish the
