[B.-] <u>C.</u> It is unlawful for [any] <u>a</u> person to intentionally cause or permit a child under eighteen years of age to engage in any prohibited sexual act or simulation of such an act if that person knows, has reason to know or intends that the act may be recorded in any visual or print medium or performed publicly. [Any] <u>A</u> person who violates <u>the</u> <u>provisions of</u> this subsection is guilty of a third degree felony, unless the child is under the age of thirteen, in which event the person is guilty of a second degree felony.

[C.] D. It is unlawful for [any] <u>a</u> person to intentionally manufacture any visual or print medium depicting any prohibited sexual act or simulation of such an act if one . 134079.1
