13. On page 9, strike lines 9 and 10.

14. On page 9, lines 11 and 12, strike the paragraph designation "(5)" and the money amount and insert in lieu thereof:

"B. three hundred seventy-five thousand dollars (\$375,000)".

15. On page 9, line 16, after the semicolon insert "and".

16. On page 9, line 17, strike the paragraph designation "(6)" and insert in lieu thereof "C."

17. On page 9, line 20, strike the semicolon and insert in lieu thereof a period.

18. On page 9, strike lines 21 through 25 and on page 10, strike lines 1 through 9.

19. On page 10, strike lines 16 through 20.

20. Reletter the succeeding subsections accordingly.

21. On page 10, line 21, after the end parenthesis insert "for expenditure in fiscal years 2001 and 2002".

22. On page 10, line 21, strike the money amount and insert in lieu thereof "two hundred fifty thousand dollars (\$250,000)".
