- 3. On page 2, line 15, strike "The driver's certified" and insert in lieu thereof "A" and strike "liability" and insert in lieu thereof "insurance".
- 4. On page 2, line 21, strike "certified", strike "liability" and insert in lieu of the latter word "insurance".
- 5. On page 2, line 22, after "policy" insert ", except for an automobile business exclusion, a furnished for regular use exclusion and a vehicle rented for business use exclusion if contained in the motor vehicle insurance policy and is otherwise enforceable".
- 6. On page 2, line 23, after "The" strike "certified" and after "vehicle" strike "liability" and insert in lieu thereof "insurance".
 - 7. On page 3, strike all of lines 7 through 14.
 - 8. Reletter the succeeding subsections accordingly.
- 9. On page 3, line 15, strike "certified", strike "liability" and insert in lieu of the latter word "insurance".
- 10. On page 3, strike all of line 18 after "(1)" and strike lines 19 through 21 and line 22 through the period.

- 11. On page 3, line 23, strike "such liability" and insert in lieu thereof "the liability of the insurance carrier with respect to the insurance required by the Mandatory Financial Responsibility Act".
- 12. On page 3, line 25, strike the period and insert in lieu thereof a semicolon, strike the remainder of the line and on page 4, strike all of line 1.
- 13. On page 4, strike lines 16 through 25 and on page 5, strike lines 1 through 12.
 - 14. Reletter the succeeding subsections accordingly.
- 15. On page 5, line 14, strike "certified", strike "liability" and insert in lieu of the latter word "insurance".
- 16. On page 5, line 16, strike "certified", strike "liability" and insert in lieu of the latter word "insurance".
