appointment, the legislative council shall designate the chairman and vice chairman of the committee.

Members shall be appointed from each house so as Β. to give the two major political parties in each house the same proportionate representation on the committee as prevails in each house; however, in no event shall either party have less 7 than one member from each house on the long-term care oversight 8 committee. At the request of the committee chairman, members 9 may be removed from the committee by the New Mexico legislative 10 council for nonattendance according to council policy. Vacancies on the committee, however caused, may be filled by the New Mexico legislative council, or the council may reduce the size of the committee by not making replacement appointments and in that case need not readjust party representation.

(1) examine how to fully implement the Longterm Care Services Act;

(2) review plans to reorganize government
agencies, if necessary, and to consolidate budgets, programs
and funding sources to implement the Long-term Care Services

B. The committee shall regularly receive testimony from the interagency committee on long-term care on issues arising from the implementation of the Long-term Care Services Act and proposed plans developed pursuant to Paragraph (2) of Subsection A of this section.

Section 4. SUBCOMMITTEES.--Subcommittees shall be created only by majority vote of all members appointed to the long-term care oversight committee and with the prior approval of the New Mexico legislative council. A subcommittee shall be composed of at least one member from the senate and one member from the house of representatives, and at least one member of the minority party shall be a member of the subcommittee. Any meeting or expenditure of a subcommittee shall be approved by the full committee in advance of that meeting or expenditure, and the approval shall be shown in the minutes of the . 136109.2

2 Section 5. **REPORTS.** -- The long-term care oversight 3 committee shall make reports of its findings and recommendations for the consideration of the second session of 4 5 the forty-fifth legislature. The reports and suggested 6 legislation shall be made available to the New Mexico 7 legislative council on or before December 15 preceding the 8 session.

Section 6. STAFF.--The staff for the long-term care oversight committee shall be provided primarily by the legislative council service, but the legislative council service may request the assistance of the legislative finance committee staff at the direction of the long-term care oversight committee.
