16	Section 1. Section 66-3-1 NMSA 1978 (being Laws 1978,
17	Chapter 35, Section 21, as amended) is amended to read:
18	"66-3-1. VEHICLES SUBJECT TO REGISTRATIONEXCEPTIONS
19	A. Every motor vehicle, trailer, semitrailer and
20	pole trailer when driven or moved upon a highway is subject to
21	the registration and certificate of title provisions of the
22	Motor Vehicle Code except:
23	(1) any such vehicle driven or moved upon a
24	highway in conformance with the provisions of the Motor
25	Vehicle Code relating to manufacturers, dealers, lien-holders

to market only the produce, animals or fowl produced by them or who transport back to their farms and ranches supplies for use thereon; or

(c) persons who transport animals to 4 and from fairs, rodeos or other places, except racetracks, 5 where the animals are exhibited or otherwise take part in 6 7 performances, in trailers drawn by a motor vehicle or truck of 8 less than ten thousand pounds gross vehicle weight rating 9 bearing a proper registration plate, but in no case shall the 10 owner of an unregistered trailer described in this paragraph perform such uses for hire; and 11

(8) any such vehicle driven or moved on a highway by a motor club towing service as defined in Section 59A-50-2 NMSA 1978.

B. No certificate of title need be obtained for any vehicle of a type subject to registration owned by the government of the United States.

C. Every manufactured home shall be subject to the registration and certificate of title provisions of the Motor Vehicle Code, and each manufactured home shall at all times bear a current registration plate."
